Peter reported that our crews have met to make preparations for the Tanglewood project. We've taken soil borings for Geotech analysis of the subsurface layers to help facilitate the new road design for the project. We meant with Kimberly Bullen last week to review the project and the upcoming grant proposal. Grant presentations are in Denver the end of February. They are encouraging us to go to Denver for the presentation as opposed to the live link in Grand Junction for a Tier II project. There are some concerns about paying for asphalt as proposed in the grant and we also proposed 36% of the total project as in-kind donation or \$162,000. The difference between the engineers estimate and ours is \$210,000 less.

Peter continued updating the council that Senergy Homes is having appraisals on the workforce housing project. Our part of the project terminates at the end of June 2018. The project is currently fully rented despite the vacancy rates in our community. When we started the project discussions in early 2011, the need was significant and frankly vacancy throughout the project has been minimal. Rents however never achieved their goals for project over 5 years with moderate escalators built in to the original contract due to the economic environment. The project continues to spin off some revenues for the community in property tax and town utility usage which totals about \$48,000 over the past five years. RBC Commissioners are holding a work session next week on Tuesday at 10AM in Rangely to talk about using

the courtroom for their commissioner meetings on this end of the county. They also want to talk about blinds and panic buttons for the court. Another topic of discussion that Commissioner Rector and I discussed today was the effort to combine the building departments on this end of the county and how that might look. This scenario has been implemented in Mesa County for Grand Junction and Fruita, and more recently in Moffatt County with Craig. The benefit could be in the potential cost savings, normalization of fees between the county and town and normalization of code adoption between town and county. If any of the council would like to participate in the discussion the meeting is next Tuesday at the annex at 10AM. Jeff Rector, RBC Commissioner reiterated that he felt the benefits for both Town's and Rio Blanco County following the same version of Building Codes and Sharing this employee position could be a real benefit to everyone.

Some progress on the wastewater grant activity with the foundation for the building completed and we are now awaiting the erection of the building on the north side of the water plant. We also ordered and received some of the collections system piping for the manhole rehab project. Jeff Lebleu and I are working to update the streets masterplan in ARCGIS to help with project and budget projections in 2019. Michael Dillon is working to update valve and distribution line attributes for both gas and water. Gas GIS mapping is the closest to complete with the water and wastewater utility following. A lot of information will go into the system over the next couple of years as we work to finalize the maps for all departments. Rangely Town Hall Renovation Grant when finalized will approach \$900K in total spend with an original project estimate of \$1,282K. The water treatment plant grant was a \$1.2 million projected project and will finish around \$1 million total. This is indicative of what we believe we can accomplish with the Tanglewood project in terms of in-house management of the projects and eliminating some of the overhead. I can tell you that executing on these projects is tenuous at times and we will have to be selective so as not to impact other areas of maintenance and service.

I plan to assemble a letter of support for Colowyo Mine's Collom Air permit with a prepared response. I'd hoped to have that together for tonight, but I need to do a little more homework on the letter and will have it for you at our next meeting.

Andy Shaffer asked about the reason we had not awarded a bid at WRV. Peter replied that the contractors felt uncomfortable that a wall scheduled to be demised could be load bearing and wanted an engineer or architect to sign off that it wasn't. Peter said there are two corridor walls that seem more likely to be bearing walls but we are having that looked at so the two contractors who have inspected the site can decide how they would like to proceed with their bids.

Andy Key had two questions. Andy Key asked if the engineers estimate that the Town received had given any time for completion estimates. Peter said that the Town feels the project will take two or three months but was not aware of an engineer's time estimate for the project. Andy asked if Peter could review the engineers estimate for the time allowed for the project. Peter will check on that for him. Andy Key also wanted to let Peter know that the AGNC grant cycle should be open and wanted to know if Peter had made any decisions if he would pursue a grant. Peter said he had not received any notification that the grant offering had opened and asked when was the deadline for the grant submission? Andy Key said he thought March or April but would find that information and forward to Peter.

Did you know that according to madd.org “Teen alcohol use kills 4,700 people each year? That’s more than all illegal drugs combined!” Years ago Rangely School District decided that we didn’t want to have any of our kids become one of those statistics. Students may also leave at any time, but once a student leaves the building, reentry is not permitted. Parents are also called at this time to let them know their child has left the premises. These procedures ensure a safe environment for all students, staff, and parents in attendance.

Rowdy Worm is organized by a pair of student Co-Chairs and one Sponsor from our school, and is not funded by the school district. The activities planned for the night of fun include those such as; interactive games, professional entertainment, athletic competitions, as well as music and peer interaction. Throughout the night, prizes are awarded to all attendees through competitions, auctions, and drawings. The prizes and entertainment provided, are incentives for the students to choose Rowdy Worm as their after Prom activity. However, since we, as the organizers, are subjected to generate our own funds, donations are much needed!

Rangely, Colorado is a small town of about 2,000 people in the North Western corner of Colorado. Our two closest towns to go shopping in are Grand Junction, 2 hours south, and Vernal, Utah, 1 hour west. On behalf of the Town of Rangely, our council and its constituents, we write to encourage you to grant Colowyo Mine the necessary air permit, 16MF1324F. The continued operations of the Collom Development project are critical not only for Northwest Colorado, but for electricity consumers throughout the region.


The Town of Rangely has been monitoring the activities of the Collom expansion for some time and it is clear that the environmental analysis and review of the Collom area development has been a very thorough and transparent process. In January 2017, the Office of Surface Mining Reclamation and Enforcement (OSMRE) approved the Colowyo Collom Development Mine Plan after an extensive Environmental Assessment (EA) under the National Environmental Policy Act (NEPA) and a robust interagency process.

We understand that the draft air permit recently released is the culmination of months of thorough analysis and modeling to study the potential emissions from the mining operations while setting strict limits and requirements to protect air quality. The Town of Rangely appreciates the hard work of CDPHE staff, and we support and encourage you to approve the permit as currently written.

The benefit of the Colowyo Coal Mine is significant and hugely impactful to the economies of our region. Many families and businesses in Rio Blanco County, Moffatt and Route County are adversely affected by disruptions that have occurred with our biggest and most successful primary employers in the recent past and these impacts create a ripple effect throughout every aspect of our society to include funding for schools, municipalities, healthcare facilities as well as social and philanthropic support for churches and charitable organizations. Approving this air permit will ensure that Colowyo Mine is able to continue with the development of the Collom area, providing badly needed economic activity well into the future while also protecting Colorado's air and helping to generate affordable, reliable electricity for rural consumers.

We encourage you to approve and grant the air permit in a timely manner. Thank you for your consideration.
