Anthony Mazzola also addressed the council about the rumor about taking over dispatch and that those are not their intentions. He also was present to congratulate Keely on her appointment.

- a. *Don Reed* – Don asked Emily to attend if Fluoride question needed to be answered. There has been a Pro's and Con's list with the assistance of Dr. Ken Myers. Don has been attending Round Table meetings. It is been brought to Don's attention that Rangely is not active enough with the future of our water rights and our water resources. Don stated that we need to re-affirm support for the Wolf Creek Dam. Don commented about concern about a drought. This year will be ok but need to address this issue sooner rather than later. At current state we would last 14 days with current storage. Still working on Utility Master Plan. Working on a tentative plan for the rake arm issue. Plan is to install in March and install cathodic protection. Completing the DOLA survey. Will present to DOLA on March 17th in Denver for the project on Hwy 139. At the wastewater plant, switching from UV to chlorine.

12. Reports from Officers – Town Manager Update – Lisa stated that Al Vandenbrink sent an email with a list of who we could speak with about Rangely water resources. Will probably have to fight the engineer on the Wolf Creek project. Ty Gates provided snowpack levels and are above normal. When the last snowstorm hit, we received many compliments on the snow removal. Public Works did a great job trying to keep up with the storm. We received help from some special district and the help was appreciated. Kelli has started annual safety training and hoping to be done in the 1st quarter. Jeannie has been visiting businesses and talking with the business owners to get to know them and hear what they would like to see in Rangely. She is also starting to work with the special districts. Working with the School District to possibly get a vaping ordinance. There is a House Bill that would raise the age to 21 to be able to purchase. CNCC received a grant in the amount of \$500,000 to start a Cyber Security Program.

Rangely Rural Fire Protection District

The Board of Directors of the Rangely Rural Fire Protection District would like to ask the citizens of Rangely for a small increase in the mill levy that the Fire Department receives. Currently we receive .874 mills and would like to increase it to 2 mills. The revenue from taxes to be received in 2020 from the .874 mills is \$250,176 per year. If the voters approve the increase to 2 mills it will be \$572,874 per year based on the current assessed value. This will allow the Rangely Rural Fire Protection District to continue to operate and help to cover the cost of replacing the equipment that is aging.

What this means to property owners:

In 2012-2013 we replaced two fire engines which cost \$936,909. We received donations and grants of \$366,391, \$315,000 from fund balance and financed \$255,518. We will continue to seek grants, but most require 50% matching funds. The operating cost of the fire department has increased over the years and we have been having to use our fund balance to operate. We anticipate without replacing ANY equipment, we will have used out fund balance by 2042. It is not realistic to think we can continue to operate without replacing any equipment between now and 2042. Because our Firefighters are valued members of this community, we want to send them out there with the equipment they need. We feel they deserve to be safe while they are keeping us and our property safe.

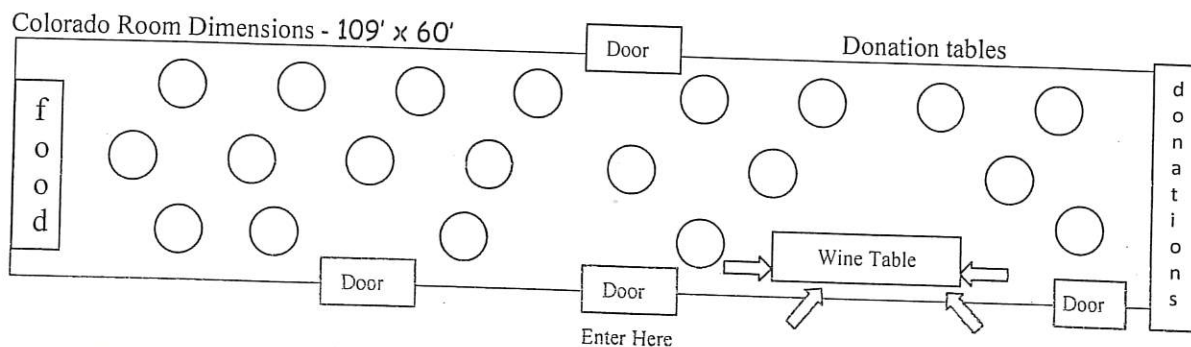

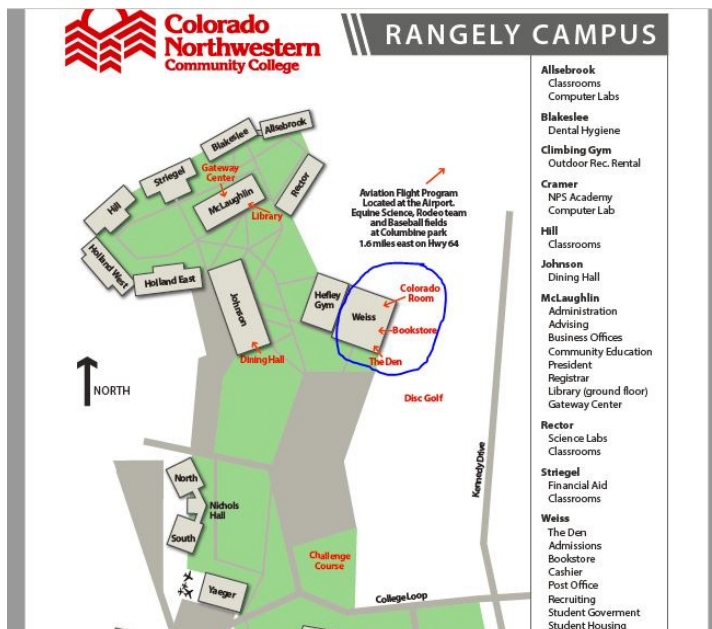

Pro's or "YES"

- Fluoride has an optimal delivery level for effectiveness of 0.70 ppm. Water is the major dietary source of fluoride which allows for widespread distribution at low to no cost to residents. Fluoride at the approved level has been delivered in Rangely's water system, since the 1970's

- According to the Centers for Disease Control in 2019, dental decay (cavities) is the most prevalent disease amongst 6-19 year olds in the United States. Evidence shows that water fluoridation prevents tooth decay by providing frequent and consistent contact with low levels of fluoride, ultimately reducing tooth decay in children and adults.
- Community water fluoridation reduces cavities among all individuals regardless of age, socioeconomic status and the ability to access care.
- Public Water System Fluoridation in controlled amounts, is considered one of the greatest successes in public health of the twentieth century and has helped millions of people to have stronger teeth.

Con's or "NO"

- Rangely has natural fluoride in the water supply averaging between a .10 and .30 ppm (parts per million). The CDPHE Fluoride Division recommended daily dosing for public water system treatment is .60 to .90 ppm. The recommended fluoride deliverable by the U.S. Dept of Health is .70 ppm.

- The occupational safe handling of fluoride for our Water Operator's is considered one of the most dangerous chemicals used in the water operations industry today.
- According to the Centers for Disease Control too much fluoride may have an adverse effect. Children are more likely to be affected by too much fluoride because their teeth are still developing. Adults that have full formed teeth but if overexposed can develop increased potential for bone fractures, pain and/or tenderness in the bone.

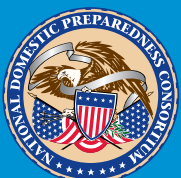
