1. **Call to Order** – Called to order at 7pm
2. **Roll Call** *Andy Shaffer, Andy Key, Matt Billgren, and Luke Geer present. Rich Garner, Trey Robie, and Tyson Hacking absent.*

10. **Reports From Council** – *Mayor Shaffer lead a meeting last night with the special districts and their directors and managers. We talked about how we can work together for long term goals for our community. Good conversations. There will be another meeting on June 3rd, but this was a great starting place.*
11. **Supervisor Reports – See Attached**
 - a. *Kelli Neiberger - We've completed 85/100 meter changes. May 6th we will be done. Records audit with CIRSAs went really well. We scored 109/100 on safety implementation and 97/100 in training and policies. That includes the changes from the audit this year. We also scored seven extra points for Action Points and five extra points for other activities, which is why we scored 109/100. April we used 16,718 BTUs (that is more than used in the past ten years in April) that is very high. Cathodic Protection has started, we survey 1/5 of town every year. Annual reports have been completed and submitted. Lock out and tag out and confined space trainings are approaching. Andy Key asked how many gas leaks the gas department handles per year. Kelli said that most of the calls the gas department get are when the odorant is changed (odorant bump) to make the smell more noticeable. Usually people smell a change and assume leak. When the gas department does find a*

leak inside, it is usually very small. Maybe 50 calls are received per year and very few leaks are ever found. Usually an increase in calls is caused by an odorant bump (the odor for gas is changed or added more and people notice the smell is different and assume leak). Historically, 3 leaks were found as a result of when the town ran fiber and a gas line was punctured. Maybe as many as 8 customers have a tiny leak found per year. Thankfully, customers are trained well on dialing 811 for safety.

- b. Jeff LeBleu – In April, Public Works painted offices, replaced the drainage by gasoline alley, file storage. So far, the department has repaired curb stops, cleaned yards, and hauled tree branches. The yard waste dump is permanently closed due to the public dumping items not belonging in the compost area such as televisions, computers, etc. Minor sink holes have been repaired, the Radino Senior center sign was repaired. Wes and Jeff attended the Gas Line Fusion class. We have been street sweeping, the animal shelter sprinkler system was turned on and repaired. New transmission in truck is needed due to a recall but it's under warranty. That truck will be out of commission for seven to ten days while it's repaired. TJ is prepping the signs and roads for the CNCC graduation. We aerated the East Entrance and yard work. I checked the price for a solar powered speed sign and they are running about \$1,500 per sign and that does not include the pole etc. Since we need on in each direction at each of the two crosswalks (one by post office and one by memorial park) that is eight total signs needed (\$12,000+). May 15th the new street sweeper should be delivered. The clean up day for Rangely is May 13-16. We are flushing the hydrant in early May in the Chevron field and will complete crack and chip sealing this summer for 2 miles of repairs. We really need to get to work on Safety and getting our signs up to code. The Mayor suggested a public safety meeting, and for the staff to map or drive the town to get the signs together and up to code.

12. Reports from Officers – Town Manager Update – Lisa made one day of the Energy Symposium. Air quality admitted that car emissions was far worse than oil and gas operations and that was interesting. Toured Summit Plant near Rifle and that was very interesting. Lisa's worked in oil and gas for years processing paperwork for operations; however, had never toured a plant before. Tomorrow, 4/24/19 we have a meeting to work with Elbert and the Hazard Mitigation plan. Currently the office is engaged in the annual financial audit with Colo CPA Services. The White River Village audit is approaching. Janet is doing great with her record keeping and should be ready for that. The guys are doing great with maintaining, and keeping up with White River Village's work orders and service requests. We hope to apply for CDOT Grants that may help with funding the speed signs and radar signs because we never replaced the stoplight. Ty will address Cross Walk etiquette after the Human Trafficking trailer is here, which should be Monday and Tuesday already.

GAS DEPARTMENT – SUBMITTED BY KELLI NEIBERGER

Project status/Current Issues:

- 90 of the approximately 100 Periodic Meter Changes have been completed. We are continuing to make appointments to complete these.

- Underground Line letter and mailing – each person who has a fuel line gets a letter reminding them about the line and how to take care of it.

- Cathodic Protection Testing – test at above ground valves, at Border Station piping, White River Bridge crossing, Gillam Draw and Douglas Creek

- Non-payment shut-offs (started with 5 and 4 customers were shut off)

- *Bryan Mackay backed into a set of USPS mail boxes in a Town Utility truck. There was no damage to the vehicle. Public Works was able to repair the mail boxes that same day.*

- *Safety Committee Meeting*
- *The Gas Department, along with the Police Department represented the Town at the Children's Health Fair*
- *Gas usage for April was down, but index price was at \$1.76 per MMBtu (last month it was \$3.51). We do not have any pre-purchased gas for April for all the gas we buy is at index price. This was very good news as the gas rate to our customers was only \$0.58 per CCF.*

Water/Wastewater – Submitted by Donald Reed

Project status/Current Issues:

Water Treatment Plant:

- Plant operations for April 2019 were good, the average flow is at 415K per day this will start to rise at a more rapid rate during May. Overall operations are changing more frequently due to run off from snow and rain in the lower elevations, operators must pay more attention on the day to day operations.
- We have completed the 2019 project list for the department, there are a considerable number of projects that we have forecasted for completion this year. We have completed some items on our list and working on others based on priorities.

- C. The finalization of the Wes-Tech warranty issue has been worked out with all parties at this time. It was deemed that this option was in the best interest for the Town. We would receive the sum of \$6000.00 from SGM for their part in this matter. Mueller Construction give us a discounted rate to install the new rake arm based on a daily rate. Estimated at 3-4 days to install new stainless rake arm cost per day is 1200.00. Wes-Tech will manufacture the stainless-steel rake arm with delivery included for the some on \$17,000.00 which is and upgrade to the system and about half the cost of repairing the old one. The only other cost would be for arbitration fees from the Town attorney. The total amount of the cost for the Town should be able to be accommodated this year's budget for the Water Treatment Plant.
 - D. Attended the Basin Round Table meeting in Craig and the Douglas Creek Round Table which were quite informative on current matters on water rights and usages thru out the western slope of Colorado. Views an opinions on water rights should be reviewed in a closed session with the Council so as to move in the best interest of the Town.
 - E. Utilities Master Plan – This Dept. is working in depth on upgrading this plan to include the Gas Dept. and Storm water systems. This project is a very time-consuming process and will be the most extensive plan ever completed for the town. In its completion it will show a very clear path by prioritizing and addressing all area's with cost assessments while aiding in grant applications.
 - F. Have completed about 90% of upgrades to the SOP program and is still a work in progress.
 - G. IGA Status with Chevron is still in the process there of.
 - H. The final report from Qual-Core on the corrosion control needed for the WTP was reviewed by the department. We will have to review the financial aspects and possibly have to table it for next years budget.
 - I. The Water Plant Sanitary Survey was conducted by State the overall debriefing was quite favorable with some aspects that will have to be worked out. The inspector noted discrepancies with some of the locations of the filter processing equipment. It was discussed with him and stated by me these item were addressed and we have correspondence from the State when we renovated the plant. Also recommended using different form the ground storage reservoir forms. We Completed and filed the annual report for the GRS facilities prior to the Survey.
- Monthly compliance reports were sent to state with no compliance violations for this reporting period. Was notified by State that they will be scheduling a Sanitary Survey for the Water Plant this year.
 - Backflow Cross Connection Program is currently behind for 2019, do to Michael's absence. Joe Brown will be added to the program to assist Mike so that we stay in compliance and meet the State's deadline in 2020.

Wastewater Plant:

- Have continued working with Desarado and filling their requirements for State, they are in the process of hiring a environmental engineer that will be filling the role of ORC status for both there water and wastewater, this individual has no current Colorado state licensing and we will be working with them to achieve this goal asap.
- The department is currently working on the basic design needed for a new headworks building as part of the wastewater engineering grant that is under way. The Department needs to narrow the scope to reduce those engineering cost. So, SGM has finished the engineering needed for the collections system repairs, and Jocelyn submitted for the CDOT permits pending approval.
- Reviewing all state correspondence and attending stakeholder meetings regarding the new wastewater nutrient standards that will be coming. Have scheduled tours of facilities that have incorporated new technologies to reduce nutrient levels to see if these applications can work for the Town facilities.
- Plant operations are good and functioning accordingly.
- State compliance reports were sent with no violations reported.

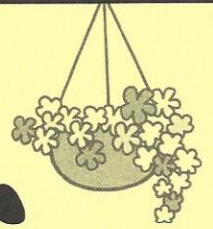

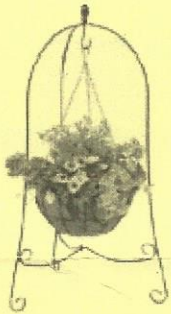

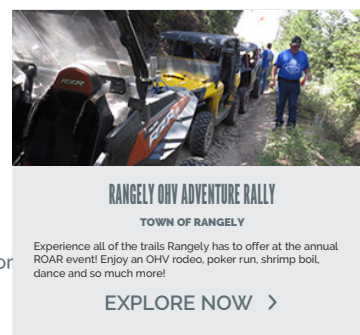

Read on to learn more about our favorite fresh-air adventures in Rangely.

1. OFF ROADING ON THE WAGON WHEEL TRAILS SYSTEM & ROCK CRAWLING AT THE RANGELY ROCK CRAWLING PARK

Hit the [Wagon Wheel Trails](http://www.rangelychamber.com/ohv?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/ohv?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) for off roading along 160 miles of interconnected roads and pathways through vast canyons and pinyon forests framed by mountain views and blue skies. Trails range from beginner to expert levels and maps are available at the Rangely Chamber of Commerce. Visiting during May? The [Rangely OHV Adventure Rally](http://www.rangelyohv.com/events/index?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelyohv.com/events/index?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) is a three-day event on the Wagon Wheel trails system — bringing together off-road enthusiasts from around the country for guided rides, a poker run, shrimp boil, rodeo and scavenger hunts.



As the only designated natural rock-crawling area in Colorado, the [Rangely Rock Crawling Park](http://www.rangelychamber.com/rock-crawling?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/rock-crawling?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) has more than 560 acres of natural terrain, including playfully named trails such as Chain Break, Poison Ivy and Willy's Way. And since many of the routes are yet to be discovered, you can channel your inner Lewis and Clark as you conquer uncharted territory in this delightfully free [4X4 spot](https://www.coloradodirectory.com/maps/atvdinosaur.html#mapinfo?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (https://www.coloradodirectory.com/maps/atvdinosaur.html#mapinfo?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent).

2. DISCOVERING HISTORY OUTDOORS: ROCK ART, RANGELY OUTDOOR MUSEUM & RANGELY AUTOMOTIVE MUSEUM

Petroglyphs and pictographs decorate the sheer sandstone walls of the [Canyon Pintado Historic District](http://www.rangelychamber.com/rock-art?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/rock-art?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent), which is listed in on the National Register of Historic Places. Prehistoric peoples began occupying the region as long as 11,000 years ago and the canyon contains the largest concentration of Fremont archaeology sites along the Dinosaur Diamond (a 512-mile scenic and historic byway in Colorado and Utah that showcases traces of prehistoric dinosaurs). Is that an elk? A human? What do the symbols mean? Find out at eight marked sites along Highway 139 as well as more sites on Highway 64 and Dragon Road.

After admiring the artwork, head to the [Rangely Outdoor Museum](http://www.rangelychamber.com/rangely-outdoor-museum?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/rangely-outdoor-museum?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent). Three historical buildings house exhibits about dinosaurs, Fremont cultures and pioneers, ranchers, oil field workers and other individuals who shaped the landscape. Then, drive over to the [Rangely Automotive Museum](http://www.rangelychamber.com/rangely-automotive-museum?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/rangely-automotive-museum?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) to see 35 classic cars owned by a local collector, including a McFarlan once owned by Warner Brothers Studios that has starred in multiple movies.

3. GOLFING AT CEDAR RIDGES GOLF COURSE

Swing for the tippy top of a mesa at [Cedar Ridges Golf Course](http://www.rangelychamber.com/cedar-ridges-golf-course?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/cedar-ridges-golf-course?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent), located 2 miles east of Rangely. This nine-hole course test golfers on uneven terrain like rolling swells, mounds and sand traps. The par-36 course is open annually mid-March through mid-November and offers a pro shop, snack bar, putting and chipping green as well as a driving range.

4. BIKING ALONG THE WESTERN WHITE RIVER TRAIL

The best way to survey the real Rangely is atop a [bicycle](http://www.rangelychamber.com/biking?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/biking?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent), be that a regular cruiser or a mountain bike. Routes around town are sparsely traveled so you can fall in love with the beauty of the mesas without the crowds and without feeling like you'll be run off the road. As an added bonus, pathways and trails are well-maintained. [Rent a bike](http://www.rangelychamber.com/outdoor-equipment-rentals?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) (http://www.rangelychamber.com/outdoor-equipment-rentals?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent).

[utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent](#)) and get out on the Western White River Trail network for chances to encounter wildlife, caves, the ghost towns like Dragon and more. [Check out the printable bike map >>](#) (https://chambermaster.blob.core.windows.net/userfiles/UserFiles/chambers/7788/CMS/Documents/Western-White-River-Trails2.pdf?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent)

5. BOATING ON KENNEY RESERVOIR & ALONG THE WHITE RIVER

With 4,000 acre-feet of water for canoers, kayakers, water skiers, fishers and floaters, the **Kenney Reservoir** (http://www.rangelychamber.com/kenney-reservoir?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) is a one-stop shop for all things water sports. Each spring the water is stocked with 5,000 rainbow trout that mingle (and are caught) with the crappie and catfish. Due to Rangely's unique location, the swimming areas and docks are seldom crowded and make for the perfect afternoon on the water. If you are feeling inspired to camp out like you did as a kid, pitch a tent or park your RV on the reservoir at one of the [16 campsites](#) (https://www.colorado.gov/pacific/rbwcd/camping-o?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent).

The reservoir sits on the **White River** (http://www.rangelychamber.com/white-river-boating?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent), just off Highway 64, which is home to a wetlands habitat where you can see bald eagles, waterfowl, mule deer, elk, river otters and beavers, plus so much more — so pack your binoculars. Once you're done appreciating the local wildlife, get your kayak, canoe or inner tube to float downstream with your family and friends, or hook a line to catch a smallmouth bass or catfish. Since river conditions can change rapidly, be sure to use the **White River Boating Guide** (https://chambermaster.blob.core.windows.net/userfiles/UserFiles/chambers/7788/CMS/Documents/WRG_2.PDF?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent).

6. EXPLORING DINOSAUR NATIONAL MONUMENT

Located 20 miles west of Rangely, **Dinosaur National Monument** (http://www.rangelychamber.com/dinosaur-national-monument?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) preserves one of the world's largest collections of Jurassic-age dinosaur fossils. Examine a Stegosaurus or Apatosaurus in the Quarry Exhibit Hall at the **Canyon Area Visitor Center** (https://www.nps.gov/dino/index.htm?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent), where you can touch real 149-million-year-old dinosaur fossils.

Finish up checking out those ancient bones at the center, and enjoy a **hike** (https://www.nps.gov/dino/planyourvisit/hikingtrails.htm?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) through the park. We suggest the Plug Hat Trail, an easy half-mile loop with panoramic views of surrounding canyons, or the Harper's Corner Trail, a moderate 3-mile round trip with shots of the Yampa River. If you are looking for a day hike, the Ruple Point Trail is a 9.5-mile round trip ending with a gorgeous view of the Green River winding through Split Mountain Canyon. At historic Echo Park just 60 miles from downtown Rangely, the majestic Steamboat Rock towers over the merging Yampa and Green rivers and is also a geological marvel to behold. The top of Harper's Corner Trail also has a great view of the area.

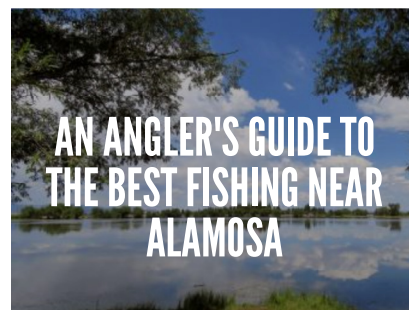
7. WILDLIFE SPOTTING

Some of **Colorado's most famous residents** (http://www.rangelychamber.com/wildlife?utm_source=colorado_com&utm_medium=referral&utm_campaign=sponsoredcontent) run wild in Rangely, such as deer, antelope, elk, bald and golden eagles, hawks, owls, coyotes, red foxes, bobcats and mountain lions — some of which you can spy on from the comfort of your car. But be sure to drive carefully and stay a safe distance away. In the summer, they migrate to higher elevations and spend winter congregating on ridges and exposed southern slopes.

River District confronting budget challenges

General Manager Andy Mueller and Chief Accountant Ian Philips led the Colorado River District Board of Directors in a robust discussion on the District's long-term financial sustainability during their April 2019 quarterly meeting.

Factors behind the budget discussions are a decline in property taxes from energy extraction and restrictions embedded in the Colorado Constitution.

While the District is currently in solid fiscal health, Mueller noted that "we do have a few issues creating a downward trend in our financial future."

Those issues include long-term financial threats attributed to revenue/spending limitations from the Taxpayer Bill of Rights (TABOR), shrinking residential assessment rates (RAR) attributed to the Gallagher Amendment in the Colorado Constitution, and a decline in energy-related activities on the West Slope.

"So members of the staff and I have taken this on in an attempt to look into the future to better understand how we meet our mission of protecting West Slope water while also being mindful of the potential burden on our constituents," Mueller said.

Residential Assessment Rate expected to hold steady

Mueller reported some good news that emerged from the State

Capitol related to the potential decline in the RAR. Colorado's Division of Property Taxation released its final residential assessment rate estimate in early April. According to the state, the final RAR estimate for property

tax years 2019-2020 is 7.15 percent, which replaces previous state estimates of 6.11 percent and 6.95 percent released in July and January respectively.

"This doesn't alleviate the long-term threat from Gallagher but does alleviate the magnitude and immediacy of the threat to the River District's property tax-based

revenues," said Mueller.

Property taxes account for some 97 percent of the District's revenues and a statewide drop in the RAR to 6.11 percent would have resulted in a 15 percent, or an estimated \$370,000, reduction in income.

TABOR Limitations on the Colorado River District:

The Colorado Constitution was amended to include the Taxpayer's Bill of Rights, or TABOR, in 1992. TABOR's stated purpose is to restrain the growth of government by limiting revenue, spending and debt incurred by local and state governments.

TABOR requires each local government, including special districts, to

What is the Gallagher Amendment?

In 1982, the electorate of Colorado approved a constitutional amendment, the so-called "Gallagher Amendment, that requires a bi-annual adjustment in the statewide residential real estate property tax assessment rate (RAR).

The reason is to maintain a consistent relationship, or ratio, between the total assessed value of statewide residential property compared to statewide non-residential property. Through RAR adjustments, the ratio is kept at approximately 45 percent for residential and 55 percent for non-residential.

So what's the big deal?

In theory, this amendment was designed to keep the burden of state taxes equitably spread between residential and non-residential properties.

However, since 1982 the growth in the value of residential properties has far outstripped that of non-residential properties.

Then, in 1992 the electorate enacted TABOR, which has been interpreted by the legislature to prevent it from raising (but not lowering) the RAR. What has resulted is a significant downward trend in the residential ratio.

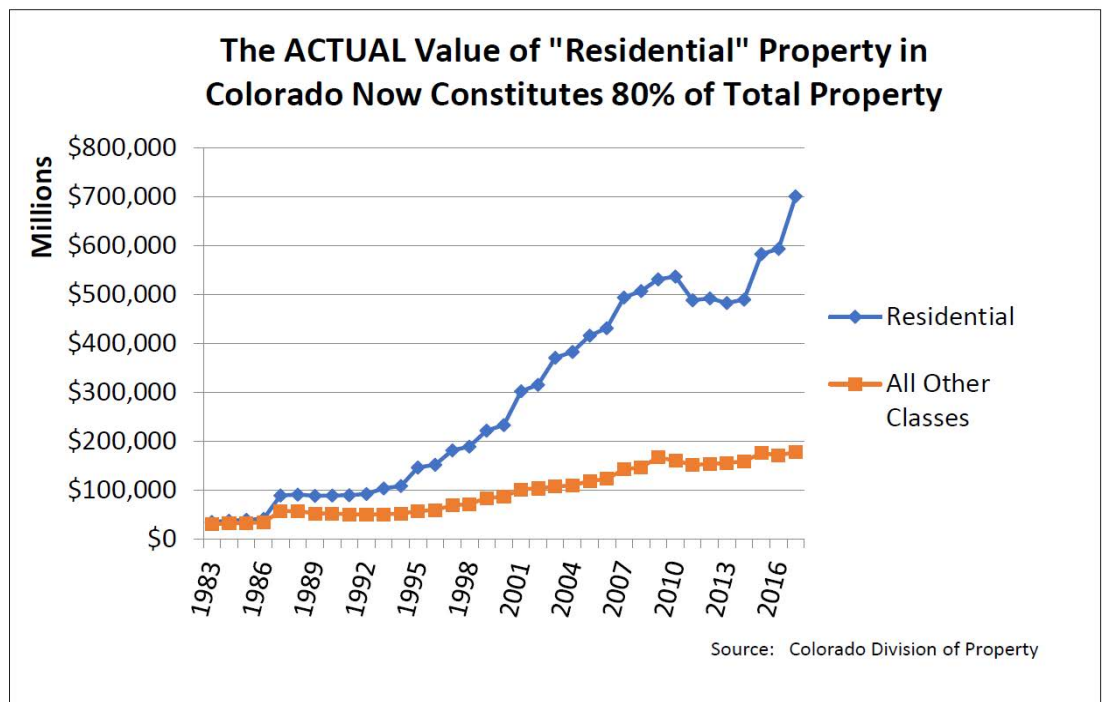
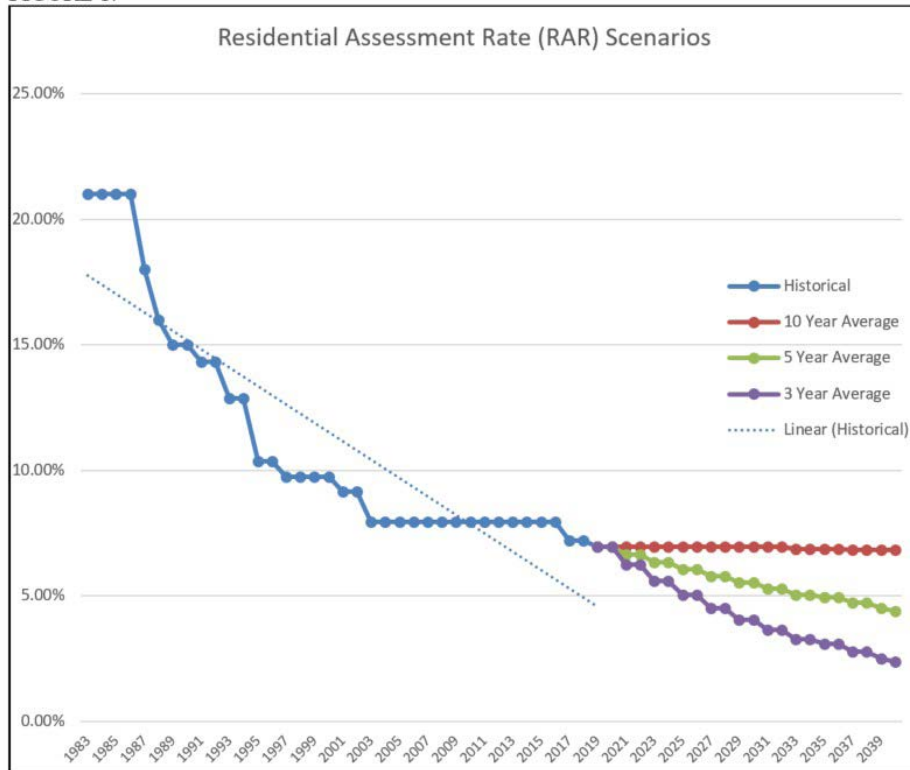
Take a look at the graph on the next page: In 1982, when the Gallagher amendment was enacted the RAR was set at 21 percent; today the RAR sits at 7.2 percent.

establish a revenue and spending base and then monitor any year-to-year growth in that base.

A district's "fiscal year spending" is only allowed to increase at the same rate as inflation plus new growth. Any additional increase in revenue, spending or debt beyond the established base by a local government requires approval of the voters.

TABOR prohibits an increase in any tax rate without voter approval, even if the tax base falls resulting in a decline in revenues.

At the Board's February 2019 Budget workshop, Mueller highlighted that much of the River District's best work in recent years has been performed by acting as a catalyst for constituents.

"We have been able to create an outsized impact for our water users through leveraging outside funding to assist our water users in everything from the Gunnison basin selenium and salt reduction effort, to acting as fiscal agents for state water plan funding grants for the Yampa, White and Green Basin Roundtable, to participating in a cloud seeding program," he said. "Our ability to continue to lead through these types of partnerships is tremendously impacted by the TABOR revenue cap."

Local governments throughout Colorado have adopted a variety of mechanisms to modify the negative impacts of TABOR. Some governments have asked voters for authority to

raise their mill levy and exempt their revenue from the limitations contained in TABOR.

Between 1992 and 2005 the District reduced its mill levy from 0.394 to 0.252 in order to avoid violating the TABOR revenue cap. By reducing its mill levy during these times, the River District's tax rate was permanently ratcheted down and may not rise above that rate without a vote of the electorate.

"The net effect of the TABOR tax rate cap is that in times of moderate to high inflation and growth, the River District's revenues are prevented from growing with that inflation plus growth factor," said Mueller.

"The result of these caps has been and threatens to continue to be a diminishing of the District's ability to provide services to our growing population and to our ability to successfully achieve our mission of developing and protecting our constituents' and the District's water resources."

Energy-related revenues on the decline

More than 97 percent of the River District's revenue is derived from tax on real property, including the value of fossil fuel production as well as the value of coal-fired power plants.

Over the decades, this has meant that the District's revenues, like many others, have been subject to boom and bust cycles of the energy sector on the Western Slope. Over the last

10 years, the District has seen a significant downward trend in the assessed valuation of oil and gas and coal within our District.

"Energy-related revenues in the District represented about 24 percent in 2013 and in the intervening years that revenue has dropped to only 11 percent," said Mueller. "Whether that trend continues or not, from a budgetary perspective it's important to plan for the worst and hope that the worst may not actually come."

"In light of the significant challenges to the District's future tax and revenue picture created by Gallagher and TABOR the decline of a significant property tax sector, will likely compound existing revenue challenges at the District," said Mueller. "If we were a private enterprise, our fiscal advisers would tell us that we need to consider diversifying our income stream in order to weather likely future economic storms."

While the Board has not made any formal decisions, Directors have collectively recognized the need for "belt tightening" to prepare for future financial challenges and it fully supports District Management's effort to reduce expenditures over the last year.

The Board has also expressed some concern that without a voter approved fiscal fix, the District will face declining revenues which will result in a serious threat to the District's ability to successfully achieve its mission.



Waters of the U.S. rule: a CRD analysis

On February 14, 2019, the Army Corps of Engineers and the Environmental Protection Agency published the agencies' proposed new rule defining the Waters of the United States (aka WOTUS) in the Federal Register.

According to a Colorado River District legal analysis of the rule, the stated goal of the rule is to increase the Clean Water Act's (CWA) "program predictability and consistency by increasing clarity as to the scope of 'Waters of the United States.'"

The CWA's primary areas of regulatory focus are point-source discharge permit requirements under Section 402 (the National Pollution Discharge Elimination System (NPDES)), and "dredge and fill" permit requirements under Section 404. Federal jurisdiction to impose those permit requirements extends only to jurisdictional WOTUS.

By all accounts, the proposed rule asserts jurisdiction over a narrower scope of waters than does the previous/existing rule, according to the General Counsel's report to the Colorado River District Board of Directors. The District's report focused on the definition of "ditches" under the proposed rule, as that has been a past area of Board concern.

The proposed rule defines ditches as "an artificial channel used to convey water," and identifies three categories of ditches that are considered jurisdictional: (1) ditches which are traditionally navigable waters used in interstate or foreign commerce, (2) ditches constructed in a tributary, and (3) ditches constructed in an adjacent wetland. All other ditches are not considered WOTUS and are excluded from the rule.

The first category of jurisdictional ditches is relatively straightforward, any ditch that transports goods and services

River District submits WOTUS comments

The Colorado River District submitted comments on the draft 2019 rule defining "Waters of the United States" (WOTUS) that determines jurisdiction of the Clean Water Act.

These five words have been the subject of a handful of U.S. Supreme Court decisions and nearly as many administrative rule makings, none of which provided the clarity and certainty desired by the water-user community.

The River District's comments on the proposed WOTUS rule focused predominantly on the definition of ditches and canals. The District applauded the general exclusion of man-made water conveyances but noted several potential conflicts and inconsistencies and offered clarifying agricultural language.

in interstate or foreign commerce is jurisdictional. An example would be the Erie Canal.

The second category – ditches constructed in a tributary – is not quite as clear. The rule defines a tributary as a "river, stream, or similar naturally occurring surface water channel that contributes perennial or intermittent flow to a navigable water... in a typical year either directly or indirectly through other jurisdictional waters such as other tributaries."

The District report noted that the

proposed rule's treatment of tributaries is much narrower than the previous/existing rule, which asserts jurisdiction over ephemeral streams (surface water flowing only in direct response to precipitation) and waters that have a "significant nexus" to otherwise jurisdictional waters.

The proposed rule defines "perennial" as "surface water flowing continuously year-round during a typical year," and "intermittent" as "surface water flowing continuously during certain times of a typical year and more than in direct response to precipitation."

The third category of jurisdictional ditches are those built in adjacent wetlands.

Adjacent wetlands are defined in the proposed rule as "wetlands that abut or have a direct hydrologic surface connection to a [jurisdictional] water..." A ditch built through a wetland adjacent to another jurisdictional water would make the ditch a jurisdictional WOTUS for purposes of the rule.

The General Counsel's report identified that the proposed rule does not affect the statutory exemption provided for the construction and maintenance of irrigation ditches, including diversion structures, weirs, headgates and other related facilities that connect an irrigation ditch to a jurisdictional water.

However, the construction or maintenance of diversion structures for municipal (or other non-irrigation) ditches likely would not be exempted.

Additionally, artificial lakes and ponds constructed in uplands (including water storage reservoirs, farm and stock watering ponds) are not jurisdictional pursuant to the proposed rule.



Federal affairs: Drought Contingency Plan passed, signed by the president; and more

Noting a distinct shift from “efforts” to real “progress” in this quarter's federal affairs discussion, Chris Treese, External Affairs Manager, highlighted significant Congressional accomplishments so far for 2019.

Top on his list was the recent passage of Drought Contingency Planning (DCP) legislation for the Colorado River basin. Passage through both houses required less than one week (two days by some measures), and it was signed into law by the President on the first day of the River District board's quarterly meeting, April 16, 2019.

Treese also noted passage of the “public lands package bill.” This bill includes final passage of the Bolts Ditch Access and Use Act that the District had been advocating for four full Congresses on behalf of the town of Minturn. The bill allows Minturn to repair a small diversion structure located just inside official Wilderness.

Congress also permanently reauthorized the Upper Colorado and San Juan River Endangered Fish Recovery Programs. The package also includes permanent reauthorization – but not guaranteed funding – of the Land and Water Conservation Fund.

Treese also noted Senator Gardner's considerable assistance in amending protective language onto a Wild & Scenic Rivers designation for a segment of the Green River in Utah. Gardner's

language ensures the designation does not adversely impact or complicate the “extended reservoir operations” component of the DCP.

The U.S. Senate confirmed David Bernhardt of Rifle as the new Secretary of the Interior. His confirmation vote was 56-41. The River District has worked with Bernhardt numerous times over his long career in public service.

Treese also reviewed the recently introduced CORE Act by Senator Bennet and Congressman Neguese, noting that the River District had previously reviewed the individual elements of the composite CORE Act and is satisfied that there are no adverse water implications associated with the various federal land designations included in the proposed legislation.

Finally, Treese mentioned Senator Gardner's recently introduced bill to provide guaranteed, annual funding for the Land and Water Conservation Fund. S. 1081 would dedicate \$900 million every year, eliminating the annual legislative battle over appropriations for the fund.

These are River District federal affairs priorities for 2019. This report describes progress on at least six priorities:

- Secure funding for the Upper Colorado River and San Juan River

Endangered Species Act Recovery Programs (legislative authorization and appropriations);

- Colorado River Drought Contingency Plan authorization/implementation legislation;
- Support for Bolts Ditch “easement;”
- Good Samaritan legislation;
- Waters of the U.S. (rulemaking, legislation possible);
- Monitor and protect water rights in proposed Colorado Wilderness (legislative) and other special land designations (legislative and administrative);
- Support healthy forest initiatives and related programs that assist and fund forest and watershed health programs;
- Support the Water Rights Protection Act (Congressman Tipton);
- Water and Wastewater Infrastructure Funding, (annual revolving loan fund appropriations);
- Provide for legal irrigation through and with federal water infrastructure for hemp and marijuana;
- Support tax exemption for water conservation rebate programs; and
- Support reauthorization and full funding for the Land and Water Conservation Fund.

Barge segments headed for Wolford Mountain for planned work

The Colorado River District this spring will replace the main outlet gate at the Wolford Mountain Reservoir dam.

Work is expected to begin any day on assembling the barge spread, the on-water platform by which divers and other workers will effect the project.

At its January 16, 2019 Board meeting, Directors approved a \$444,000 contract with Marine Diving Solutions LLC of Centennial, Colo. to take out the old gate and install a new stainless

steel one purchased previously by the District and currently being fabricated in Massachusetts.

A large, floating work platform will be assembled to hold a crane, divers' decompression chamber, work trailer, diving equipment and the gates as they are removed and installed. The work platform will be assembled near the boat ramp from the 8 by 10 by 40 foot segments and towed to the outlet tower.

The main gate is in 120 feet of wa-

ter when the reservoir is full.

Once the existing 17,000-pound gate is removed the new gate will be installed and tested.

The project is expected to take three to four weeks once the work platform is assembled and be completed in May.

The boat ramp and the majority of the day-use parking lot will be available for public use. The dam crest is open for foot traffic during the project.

CWCB Director addresses Drought Contingency Planning actions

Colorado Water Conservation Board (CWCB) Director Becky Mitchell said the CWCB is beginning its investigation about how Demand Management might work in Colorado and how saved water could be stored in Lake Powell.

Her comments came during the Colorado River District's April 2019 quarterly Board of Directors meeting. Demand Management, in this case, means reducing uses of Colorado River water in Colorado and using the conserved water to improve reservoir levels at Lake Powell. This is the biggest piece in the Upper Basin States' Drought Contingency Plan (DCP).

The CWCB policy is to investigate voluntary, compensated and temporary (VCT) reductions in water use, a policy that was advocated and is now supported by the River District. The alternative to VCT is a mandatory curtailment where nobody gets paid, a result the River District is trying to avoid as it would devastate western Colorado agriculture with negative effects to the environment and recreation.

President Trump last week signed congressional legislation that empowers the U.S. Secretary of the Interior to implement DCP actions in the Colorado River basin.

In the Lower Basin States of California, Arizona and Nevada, that means

taking shortages of Colorado River supplies as Lake Mead plunges and storing the savings in Lake Mead. In the Upper Basin states of Colorado, New Mexico, Utah and Wyoming, the DCP calls for first moving water from Flaming Gorge, Navajo and Blue Mesa reservoirs to Powell and then employing Demand Management, if it is found feasible. Each Upper Basin state will create its own mechanism for Demand Management.

Currently, the CWCB is creating eight work groups of about 10 stakeholders each to begin the Demand Management investigation. The River District has asked to have a representative on each work group. Mitchell said the 2019 work plan is to establish the work groups, hold workshops,

evaluate and report.

River District General Manager Andy Mueller raised the question of whether a 500,000 acre-foot pool of saved water in Lake Powell can really protect Colorado from curtailment under the Colorado River Compact of 1922, given the cost and intensity of creating a Demand Management program. Currently, nobody knows what the money source would be to pay water users to save water.

"That is still to be determined and that is why we are willing to put the amount of effort and energy toward this," Mitchell said. "We want to look at whether the costs outweigh the benefit – and better define what the benefit is."

Will voters place bets for the Colorado Water Plan?

The Colorado River District's Communications Director, Zane Kessler, provided the Board of Directors a brief update on a last-minute effort at the Colorado State Capitol to help fund the Colorado Water Plan through the legalization of online sports betting.

HB19-1327 would send a question to the November 2019 ballot asking voters to allow online sports betting in the Centennial State.

If approved, the majority of revenues from an online sports betting program – potentially as much as \$10 million a year – would go toward funding implementation of the Colorado Water Plan and programs to ensure continued compliance with interstate agreements on water sharing.

Until recently, federal law prohibited states from establishing programs that allow betting on sporting events. But a 2018 U.S. Supreme Court opinion (Murphy v. NCAA) overturned that prohibition. Prior to that decision, only a handful of states were allowed to legalize sports betting, including Nevada. Since the decision nine states have legalized sports betting and over a dozen more are considering legislation to legalize it.

The Colorado Water Plan was developed in 2015 and is the roadmap to address Colorado's future water needs. "Unfortunately, the state does not have the funding to fully implement the water plan," said Kessler. "If approved by the voters, this will get us

a little bit closer."

Western Slope legislators on both sides of the aisle supported the bill. Rep. Marc Catlin (R) of Montrose, called it "a true win-win for Colorado" on the House floor before casting his vote of support. Senator Kerry Donovan (D) of Eagle is the lead sponsor of the measure in the Senate.

"The bill enjoys broad bipartisan support under the Gold Dome but the fate of online sports betting and the revenues that come with it ultimately lies with the voters," said Kessler.

On April 25, the River District Board held a special joint meeting to discuss the bill. After discussing it in more detail, the Board voted unanimously to support HB19-1327.

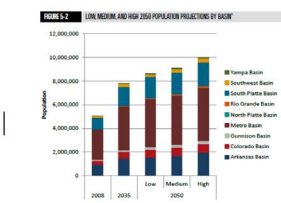

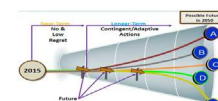

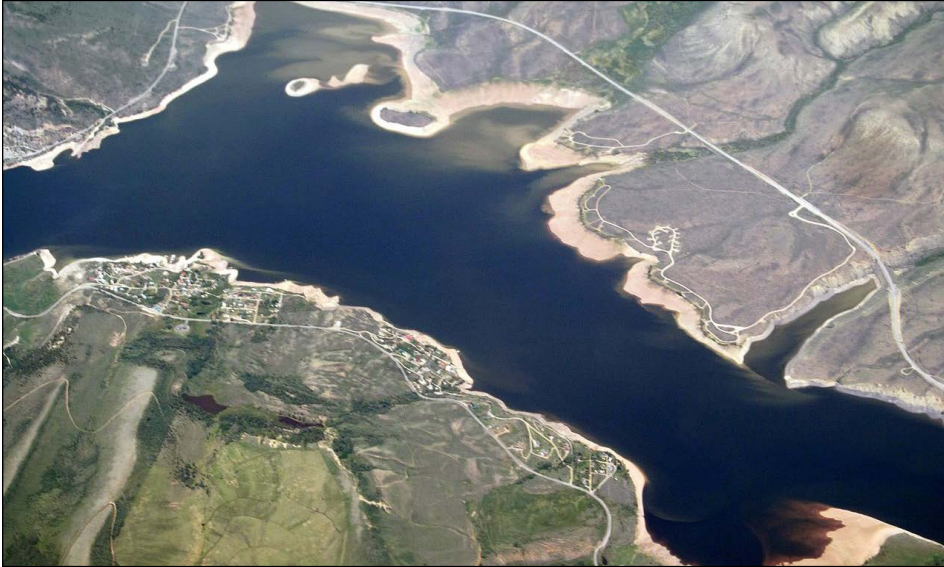

Green Mountain Reservoir in Summit County is a vital water supply reservoir for water users, endangered fish and recreationists along the main stem of the Colorado River.

Filling protocol at Green Mountain Reservoir scrutinized to protect West Slope interests

Green Mountain Reservoir, located in Summit County will always be a central focus of Colorado River District work to protect existing and future West Slope water uses in the main-stem Colorado River basin.

The latest issue, according to the Board's General Counsel Report, was the Bureau of Reclamation's accounting of inflow and bypasses at Green Mountain during the 2018 fill season.

According to the report, Reclamation's accounting favored the Colorado-Big Thompson Project's (C-BT) transmountain diversion interests against the interests of western Colorado and the Front Range cities of Denver and Colorado Springs.

The River District is working with the cities, the Grand Valley Water Users Association and the Orchard Mesa Irrigation District on a joint letter to

Reclamation to express its concern.

Green Mountain Reservoir, a component of the C-BT Project, has two primary pools – the 52,000 acre-foot Replacement Pool, which is used to replace diversions by the C-BT Project's transmountain diversion system, and the 100,000 acre-foot Power Pool, which is used for West Slope compensatory purposes and includes the 66,000 acre-foot Historic Users Pool (HUP) and the Contract Pool.

Senate Document 80, the operating principles for Green Mountain Reservoir, makes clear that the 52,000 acre-foot Replacement Pool must fill prior to the 100,000 acre-foot compensatory power pool. However, Senate Document 80 also makes clear that the 100,000 acre foot pool has a co-equal priority with the project's transmountain collection system.

The concern about last year's fill accounting is focused on the period of time when the C-BT Project was the "swing right," meaning it was partially in-priority and partially out-of-priority.

At that time, the 52,000 acre-foot Replacement Pool had already filled, and reservoir bypasses or releases were necessary to satisfy the downstream senior call from the Shoshone Hydro Plant in Glenwood Canyon.

The River District maintains that, in such conditions, Reclamation should pro-rate releases from the two pools in proportion to the respective out-of-priority depletions made by the C-BT Project and depletions made by West Slope HUP beneficiaries and contractors.

Instead, Reclamation treated all water released or bypassed from Green Mountain to satisfy the downstream call as coming entirely from the 100,000 acre-foot pool's storable inflow.

This manner of accounting reduced the volume of the 100,000 acre-foot pool. The end result is that water diverted or stored for transmountain diversion through the Adams Tunnel was effectively replaced from the 100,000 acre-foot pool instead of from the 52,000 acre-foot C-BT replacement pool as set forth in Senate Document 80 and the relevant decrees.

According to the Board report, "luckily," the 100,000 acre-foot pool filled last year anyway, so the cities were not injured by an increased substitution requirement and the West Slope benefited from a full compensatory power pool. The cities and the West Slope parties want to ensure that Reclamation properly accounts for depletions and inflow in future years.



Policies ratified on Endangered Species Act, Rec Water

To ensure its policies are timely and up-to-date, the Colorado River District Board reviews roughly one-third of its standing policies annually.

This annual review also provides an opportunity to add policy statements on important missing topics; none was identified this year.

The River District board reviewed and amended its **Water Quality, Endangered Species Act, Instream Flow and Recreational Water Uses** policies during its April 2019 quarterly meeting. The Board gave final approval to the amended **Endangered Species Act and Recreational Water Uses** policies.

Directors spent considerable time discussing the nuances of and potential for mixed messages inherent in its **Water Quality and Instream Flows policies**. Both were returned to staff for additional drafting and additional

consideration at the July quarterly meeting.

The District's **Water Quality** policy states that the primary policy objective is protection of water quality sufficient to ensure the safe and beneficial use of water by all water users.

Directors gave initial approval to new language supporting clarifying language regarding the scope and extent of the federal Clean Water Act through rulemaking or legislation defining "Waters of the United States."

The Board also endorsed adding that assured and adequate funding must accompany new water quality rules and regulations.

Regarding instream flows and the state's instream flow program, Directors unanimously supported a strong statement recognizing the River District's long-standing support for

flowing rivers and the state's instream flow program.

Directors discussed the need for balance in the protection of instream flows and the reality of consumptive water uses in the arid West.

Additionally, the Board noted that the state's instream flow program is not the only means for protecting water in the state's rivers and streams. The River District has been instrumental in developing a variety of mechanisms to assure and maintain stream flows that otherwise would or could have been diverted to the eastern side of the mountains.

River District working to protect stock-water use of irrigation rights

A rancher's ability to use a water right decreed for irrigation for stock-watering purposes has gotten tangled in a dispute with the State of Colorado regarding the priority of this historical practice against the state's Instream Flow water rights program.

The Colorado River District supports the historic use and is attempting to sort out the dispute with state officials, advocating that producers should not be required to go to water court to continue their historical stock-water practices.

The River District Board's General Counsel reporting at the April 2019 quarterly meeting said the River District is meeting with the State Engi-

neer's Office and Colorado Water Conservation Board (CWCB) staff regarding the state's treatment of historical uses that pre-date an instream flow right.

The issue arose in Water Division 6 in northwest Colorado, where the state shut off long-standing stock-watering diversions when the CWCB's junior instream rights were not satisfied.

The ranchers asserted that the practice stock-watering substantially pre-dates the state's instream flow water rights and are therefore protected from being called out. The state disagrees and maintains that the ranchers' stock-watering is not included within the scope of their irrigation decrees, and that the stock-water

diversions are therefore an undecreed use and not subject to protection under the state's instream flow law.

The River District's position has been that regardless of whether the irrigation decrees include an implied inclusion of stock-watering, the historical stock-water diversions are protected against a call from the instream flow rights because the instream flow statute expressly protects "present uses ... of water ... whether or not previously confirmed by court order or decree." The state acknowledges that instream flow rights are subject to pre-existing uses but argues that pre-existing uses must first be expressly recognized in a water court decree.

"You can either count beans or acre feet and I chose acre feet," Meyer said and he expects his next 20 years to be great. "I owe a lot to the District. It's a great place to work with good people. I never imagined I'd be here for 20 years."

When Don isn't in the office you can find him playing hockey, fishing or rafting but when he's in the office his passion and love for water fuels him.
