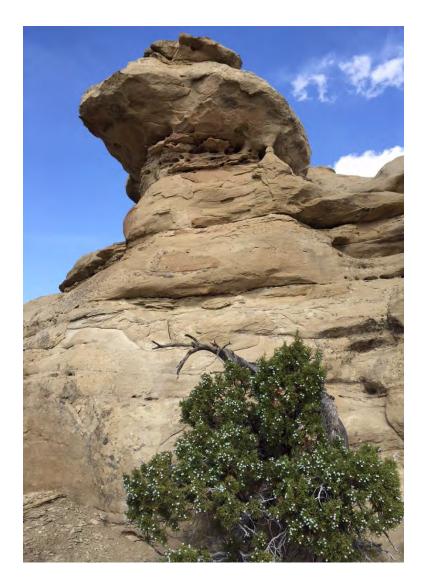

**10.** Reports From Council – Andy Key provided an AGNC update. It was an eventful meeting in Craig. Dinosaur Welcome Center was up 80% for April. The welcome center had stated they think this may be due to the Marijuana or higher fuel prices are bringing in people sooner before the cost goes up. Stewart Welding from Rangely donated a bike rack to the welcome center. Also discussed was the Comprehensive Economic Development Study which AGNC is working on to make a new region up here. In the next couple of meetings we will be asking for a letter of support from this council. Chemical Engineer Eric Eddings from the University of Utah talked to us about alternative uses for coal. There are a lot of rare earth metals that they are starting to research. U.S coal has 11 million metric tons of byproducts after everything is done. 5% of coal that is produced is needed to handle what they are making carbon fiber out of. They are looking at ways to expand that since the demand for power generation has declined. The University of Colorado Denver has a Master's Degree for School of Public Affair internship program which allows people to apply for any Bachelor's degree and then come back to their communities and work on an internship in Public Affairs and earn a \$40,000 salary while they are working for Public Affairs. This is a paid internship by DOLA. Another thing is that we will probably be bringing a letter of support forward for the BLM move to Grand Junction. There is a website called Welcome Home BLM and they are working on an ad campaign/information site to try and get the BLM to move to Grand Junction. This would provide over 100 high level jobs.

Matt Billgren provided a C.O.P meeting update and stated that Chief Wilczek and his department have done an

excellent job and it has given him a better perspective on what the officers do and the hazards that they face for our benefit. Matt expressed his gratitude for this.

Andy S. stated that everything is set for the 14<sup>th</sup> of June and that CIRSA will give a presentation and if there is time, we can discuss some issues that Meeker may be having and that we may also be having.

**12. Reports from Officers – Town Manager Update –** Peter stated that we have just started receiving information on the Enefit project and he has included information on the BLM's notice of the final EIS for the utility corridor statement and he assumes that by the next meeting we will have a support letter for that project. The Enefit project itself is located on private property. They need to build a utility corridor to get power, their oil that is produced from the project and natural gas to the site. The power line transmission line is 29 miles, the pipeline for oil is 10 miles, and the water supply line is 19 miles. There is a couple of years work for 80-100 people should they get signed off on the final impact statement. The other major aspect of this whole thing is what the possible benefit to the town of Rangely. The original prognostication of employees was about 2000 when the facility would be fully operational. During the pilot process, it probably wouldn't be guit that large. Andy S. thinks that we need to start creatively thinking about how to get those people in to Rangely. The project is near Evacuation Creek and there is a pretty straight line to get to Vernal and there are fairly good roads. We need to be creative on how to get them in here, whether it be getting with the commissioners to get a better road or incentives to get them here to live, whatever we need to do we need to think about it now. Rich stated that we are definitely closer to the project. Matt asked what the mileage is. Peter stated 45 miles to Vernal vs. 25. Matt asked if it is gravel road most of the way to Vernal. The group responded that it is a good paved highway. Rich stated that we have the Bonanza Rd. and that the Rio Blanco side is good. It is when you cross over in to Utah that it is in bad condition. Andy S. stated that the spot he thought they were going to do it was out closer to the Colorado line and asked if that is where it was going to be or closer to the paved road. Tyson thought it was at the paved road, Trey thought that it was in deeper. Matt asked if we could find out the exact location. Andy S. stated that yes it does make a difference because they are in Utah for a little way, but if we can get them up and around through Rabbit Mountain, it may be a slower road but we could talk to the commissioners about improving that road. Rich stated that it is right in the middle of a well path there and you will only be able to do so much with that. Rich stated that maybe we need to see what we can do as a council to try and encourage. Andy S. stated that he thinks that we do need to think of something creative to get them to stay here. Rich stated that we need to talk to them and find out what they need, and from there we will determine what we can give. Andy K. stated we should invite them and see what they need. Andy S. stated that Peter was talking about that. Matt asked if Peter had an idea of when this would actually kick off. Peter stated that it was originally closer to 2020. They just got renewal from BLM and Peter feels it will still be in 2020-2022 before they get it going. Matt asked if we would see activity in that time. Peter stated yes. Andy K. asked if they have an office in Vernal. Peter stated that they did but he does not know if they still do. Matt stated that it says they do have a field office in Vernal. Andy K. stated that if we could incentivize that office to be here somehow, that would encourage the people to be here. Rich feels it still boils down to an initial meet and greet to get an idea of where they are at, where they want to be, how fast they want to get there and what we can do to help facilitate that. Even if that is only letters of support to BLM. Peter stated that even if we have to go to Vernal or Salt Lake City to meet, that may be necessary to start this conversation. Andy K. stated that maybe that will be what makes them feel we are serious, if they see we are willing to travel that far. Matt asked if the delivery of what they are producing will be through pipe line and not trucking. Andy K. stated that there will be transportation from where they are mining it to the plant that they build, but that would be it. Peter stated that if they don't get approval for these easements then they would be trucking water and refined oil. In terms of trucking while they are setting up, we have some trucking companies that aren't all that busy and it would be nice if they could be utilized for moving equipment and trying to get materials in to the site. Matt and Rich stated that we have a lot of local resources that could help. Matt stated that hopefully they could utilize local workers. Matt suggested maybe we could get a roster of potential crafts and number of people that would be available. Peter provided handouts of the Colorado Confidence Report that just came out this week. This is produced once per year for the water treatment plant which has not had any violations in 2017. They have only had one violation in the past 3 years with a disinfection byproduct sample. We usually publish in the paper and Don has stated that the rules have changed and we no longer are required to publish in the newspaper.

This week Peter is going to attend the quarterly Northwest Transportation meeting in Steamboat. We have been able to get some good feed back to them based on how we feel about Douglas Pass and the pedestrian improvements over the past 8 months. David Eller who is the region 3 director has been responsive in terms of making sure that we are getting attention in those areas. We have been attending these quarterly meetings county road engineer a county commissioner and the Town Manager for Meeker if all attend. Peter has provided handouts on vaping that include ordinances and resolutions that have been passed in other communities regarding vaping and restrictions in public areas. Peter still has a file on that if it is something that the board would like to let Peter know. Peter stated that Meeker has picked this up and maybe we should revisit that item.

Tomorrow we will be meeting at the Trap Club to go through what remains to be taken care of before the June 1<sup>st</sup> COGA project. Rich will also be attending the meeting tomorrow and if Andy K. is free he will also attend. The manhole project is 100% complete and was part of the waste water improvements grant. We are at 90% on the Cleary building. The metal sheets that support the insulation have yet to be installed. The cement floor and driveways will be poured probably by the end of this week. By the middle of June we should be 100% complete and that will close out the grant. Peter talked to a commissioner today about the building inspector position. The county attorney is still working on the draft of that agreement. There have been some back and forth emails regarding the CDOT pedestrian project and the hydrology that is being planned and the engineering that is happening on Birch and Main. This is moving forward, but we aren't sure when we will see the final plans on that. Expect the project to be completed this year unless right-of-way issues cause a delay. Last night was the remote and virtual job fair. Better City produced a remote jobs brochure that has a lot of good information on Colorado companies that offer remote jobs. They also passed out USB drives with links to employers that are hiring. There were approx. 10 people that attended. Andy K. stated that if we do another one, we need to be more specific on what is taking place. Andy feels people were expecting more of a presentation. Matt feels we need to do more advertising to get more people to attend. Peter stated that we had it on the digital sign out front, Konnie sent out emails and we had it on Facebook, but we did not have enough notice to get it out in the utility billing. Matt feels there is a lot of opportunity but we somehow need to get the word out. Peter feels that we could do this again and stated it was handled like a trade show where you come in and interface with the subject matter experts looking at opportunities, but if a presentation is something you feel we should try, then we could also do that. Andy K. liked the format but feels that people misunderstood what was going to happen. Matt feels that this coincides with the co working space and that you could potentially get some of those people jobs in the co working space that we hope to see here in Rangely one day. You need to solicit the right people and it may take people from outside of Rangely to come in and invest money. We could pool our thought and see what we can do to advertise. The Tanglewood project is about 5% underway. We have ordered the materials, so from a dollars and cents perspective we are more about 15% underway. This week on the south side of Tanglewood, a number of gas services were installed and there up to six the last time Peter looked. We were awarded the grant for the Poole Memorial for \$6,000 from AGNC and that project will commence on Monday of next week. Locates have been called in this week. This will be a combined effort between the school dist. town and Elks Club.

- a. Discussion and action to approve the April 2018 Financial Summary Motion to approve the April 2018 Financial Summary made by Andy K., second by Luke Geer, motion passed.
- b. Discussion and Action to authorize Town Manager, Peter Brixius to execute Fact Sheet/Study Memo dated May 9, 2018 regarding the RBC Risk Map Supplemental Flood study. By executing the Memo, we are concurring with the general approach taken in the modeling process, but not implying that we will accept the future results of the process nor ownership for their development. (See attached Memo) – Jen Hill asked when the study will begin, Peter stated that they actually were here within the past couple of weeks. The LIDAR on the north side of town has been completed and we are waiting for them to finalize the results over the next year or two. They are stating that it will be 2020 before that happens. This is an additional segment to the flood concern that they have identified for the College Canyon and the infrastructure that we have

going under White Ave. and into Royden ditch. They will be looking at those structures to see if they will handle a 100 year event. Andy K. asked if it is a formality for us to do this, what happens if we don't. Peter stated that they would do the study anyway. Jen Hill asked if this was state or federally mandated. Peter stated that it is state, but a flow down from the feds. Matt asked if it is associated with FEMA. Peter and Trey stated that it is. Peter stated that the state engineer's office is the entity that we are responding to. Jen Hill asked what the consequences would be if the study were to say that we could not handle a flood. Andy K. states that they would designate it a flood zone. Andy K. states that they are looking in an area that doesn't even have water flow. Andy S. asked Peter if we need to authorize him to execute the fact/study memo. Peter stated yes. Matt asked if the maps are located online. Peter stated he was told they are. Andy K. asked if they are more worried about the channel that goes through town. Peter stated yes they are. Matt asked if a 100 year event here is related to snow and snow melt. Peter stated that it is generally rain fall and it takes something that will flow pretty quickly. We have cloud bursts that can achieve that, but they are rare. Matt asked if there are any numbers on inches per hour. Matt stated that where he is from they could see 12 in of rain in 6 hours. Peter sated it would not be anything like that Rangely's average moisture annually is 9-10 inches of moisture including snow melt is what we generally anticipate. Andy S. asked if they come in and say it is not sufficient, do we have to say that we accept that. Peter stated that we have no obligation to their study in terms of what their conclusions are, but we would certainly want to address it and if there are infrastructure changes that could improve the outcome for homeowners we may want to look at that. Matt asked what our course of action is. Peter stated to acknowledge the fact that they will conduct the study. Peter stated that he did also invite them to this meeting. Andy K. stated that part of him feels there is no purpose in making a motion acknowledging that they received a piece of paper, but if there are no implications either way then why do we need to do it. Matt asked what our benefit are for participating. Peter stated that they have a public obligation to show that they notified, just like when we conduct a public hearing. Andy K. stated that it is them saying that they are doing it and wanting us to acknowledge that yes we know they are doing it. Andy S. stated that if we do say that we are looking at it and are interested in it rather than just saying that whatever they do is their deal, this will show that we are concerned about what they are doing. Andy K. stated that if Peter wants to sign it than go ahead, he just doesn't understand why we are voting to acknowledge that we received a memo. Andy K. stated that it is under Peter's authority to sign it. Peter stated that it is addressed to community officials but they can authorize Peter to sign it. Peter feels it would be good to maintain a working relationship with them as well and he doesn't know what the outcome of this study may be. Matt asked if there is any cost associated with our involvement. Peter stated no. Motion to authorize Town Manager, Peter Brixius to execute Fact Sheet/Study Memo dated May 9, 2018 regarding the RBC Risk Map Supplemental Flood study made by Matt Billgren, second by Rich Garner, motion passed.

- c. Discussion and Action to submit the Application for Water Rights for the Town of Rangely in order to demonstrate a finding of reasonable diligence in the development of the remaining 1.1 cfs conditional right of the full 3.1 cfs at the Rangely Sewage Treatment Plant Discharge originally decreed in Case No. 80CW454. (Application attached) Peter stated that we have 3 diversion points and this diligence effort is for the sewage treatment plant diversion point that we use for irrigation. Every 6 years we have to defend any conditional rights. When we did this 6 years ago, they converted 2 of the 3.1 CFS to absolute rights, so we do not have to deal with that every 6 years. We are now defending the 1.1 CFS that is remaining. We are giving reasons why we are going to try incorporate that in to a plan using irrigation, recreation and piscatorial use of the 1.1 CFS. Our attorney and engineer feel like this is something the water court will find agreeable. We are hoping that they will convert this last 1.1CFS to absolute rights. We care not in the habit of giving up our water rights. Motion to approve the submittal of the application for Water Rights for the Town of Rangely in order to demonstrate a finding of reasonable diligence in the development of the remaining 1.1 cfs conditional right of the full 3.1 cfs at the Rangely Sewage Treatment Plant Discharge originally decreed in Case No. 80CW454 made by Andy K. second by Trey Robie, motion passed.
- d. Discussion and Action to support and agree to participate in an Amicus Curia Brief to be filed before the U.S. Court of Appeals for the Tenth Circuit Andy K. stated that AGNC has asked us to sign on to an Amicus brief. Amendment 71 is the raise the bar amendment that was challenged constitutionally and the challenge won originally, but it was appealed and it was said that it needed to be upheld by a higher court. They are asking

us to sign on as supporters of amendment 71. Andy K. states that this amendment makes it much harder for constitutional amendments to end up on the ballot. The ballot in November has 60-70% less constitutional amendments on it and there may be one this time around. It is effective for this one and it is working. Andy K. States that there is no cost to us and we are basically just saying that we are supporting the challenge of the appeal. **Motion to support and agree to participate in an Amicus Curia Brief to be filed before the U.S. Court of Appeals for the Tenth Circuit made by Andy K. second by Matt Billgren, motion passed.**

# Project status/Current Issues:

## Water Treatment Plant:

- Overall operations of WTP is good with production at 1 MGD+ (Million Gallons per Day) Staff is still working on getting the plant back in order and finishing up project work inside as time allows. West sed-basin was taken down for cleaning and inspection of coatings with no issues noted on finished coatings, Sika did extend the warranty and clarified that the Gel Coat would be as a finish coat, will keep you posted.
- Water Treatment Plant Grant will close out at the end of June.
- The only other problem as far as warranty issues is with the west plant sludge collector that shows signs of rusting Wes Tech who was the supplier will be working with us but they a dragging their feet. Wes Tech has asked me to contact vendors that could complete the work for them.
- The WTP plant has been experiencing some glitches with our SCADA systems which controls the automated side of the plant. Problems seem to be intermittent so hard to isolate the exact problems but we need to resolve this issue.
- The outlook for the Towns water supply is as follows. Current run off is at peak flows with snowpack remaining at 42% which is a little low for this time of the year. We are in moderate drought conditions predicted by the National Weather Service. Whether or not water restrictions will be imposed this year will depend on conditions later in the summer.
- Finished yearly maintenance program for 2018 at the WTP.

- Resolved issues with National Meter on new meters verses old meters and were able to get additional registers that were compatible with the new meter without having to purchase additional radio readers, which would have been a considerable additional expense.
- Backflow/Cross connection program for 2018 is now in progress which will consume a great deal of Mike's time and efforts over the next few months.
- Chevrons IGA agreement is still pending, they will be in touch once they complete their draft.
- Monthly compliance reports were sent to state with no violations for this reporting period
- Completed and dispatched the 2017 Consumer Confidence Report with no violations reported.

## Wastewater Plant:

- Cleary is at 90% completion, closed out old contract and had to open new one for the ceiling and insulation. Concrete floor and aprons were poured. Ducey has 80% of electrical completed but needs to wait for ceiling install to complete. Will start site grading and clean up in June
- The Wastewater Grant is on schedule for close out at the end of June.
- Currently we are still looking at the overall performance of the UV system. Rough draft is completed.
- Started working on the re-installation of the Pond A aerator's.
- In order to land apply sludge for Alan Ducey had to complete 3 samples for fecal coliform testing in which all test were below limitations. This makes it a go for land application.
- The WWTP 2018 Permit application and modification addendum has been submitted to State, will follow up on its progress. To date they will not allow the use of Sonar Genesis for duckweed control so we will have to see what else can be done to control the situation.
- Tanglewood project. As part of preparation for project, Department had to jet main sewer lines and camera main line to locate residential service lines.
- Jetted an additional 1000' of main sewer line in various locations that are random trouble spots.
- Overall operations at the Wastewater Plant are good.

Dear Mr. Torres:

The Town of Rangely enthusiastically supports the work accomplished in the Final Environmental Impact Statement for the EAO Utility Corridor Project. Rangely, as noted in the EIS, is positioned just 25 miles northeast of the utility project and we support the issuance of utility rights-of-way across BLMadministered lands and improvements to Dragon Road. The No Action alternative would deny Enefit's application for suitable utility rights-of-way and place a heavier burden on existing infrastructure to deliver these vital utility products to and from the site and would force Enefit to choose a less environmentally beneficial method of securing natural gas, electricity, water and product delivery via alternative means.

We not only find the request by Enefit to extend utilities to the site acceptable, but we believe that the economic benefit to a depressed area dealing with the downturn in the extractions industry to be a major benefit derived from the extension of these utilities. BLM projections site that 85-110 jobs could be created over several years in support of the Utility Corridor Project.

Enefit has proven itself to be a world-class operation and its engineers and scientists have shown the benefit of their oil shale retort process to be environmentally friendly using a marginal amount of water annually for the process of mining and refining. In fact, Enefit has stated their plan to design a "zero liquid discharge" facility. Total water usage projections equate to the amount of water utilized for irrigation of 2000 acres of alfalfa annually.

Enefit has fully responded to all requests by the BLM for information needed for the agency's analysis. Throughout the EIS process all third-party concerns were addressed and resolved to BLM's satisfaction providing clear evidence of the transparent nature of the process. In conclusion, it is evident that every aspect of the Utility Corridor Project has been researched, reviewed and analyzed. The company has shown itself to be extremely cooperative during the process and helpful in producing data necessary for the EIS determinations. Enefit has demonstrated its expertise in the development of Oil Shale Retort operations around the world and how they can function efficiently and environmentally safe and clean. This study has also demonstrated that the Proposed Action is the most cost effective and environmentally suitable alternative for the project.

The Utility Corridor Project is good for our economy, for Enefit, for the surrounding populations and for the environment. We find no reason to accept the No Action Alternative and we urge BLM to move forward with the Proposed Action.

#### A RESOLUTION SUPPORTING THE 2004 COLORADO WOLF MANAGEMENT WORKING GROUP RECOMMENDATIONS FOR MANAGING WOLVES AND OPPOSING THE REINTRODUCTION OF THE WOLF INTO COLORADO

**WHEREAS:** Wolf populations in the northern Rocky Mountains have achieved and exceeded the recovery goals set by the U.S. Fish and Wildlife Service in Montana, Idaho, and Wyoming and the Town of Rangely acknowledges wolves have been delisted in these states; and

**WHEREAS:** There have been numerous sightings of wolves in Colorado, documented by Colorado Parks and Wildlife (CPW); and

**WHEREAS:** The Colorado Parks and Wildlife Commission has adopted resolutions in January 1982, September 1989, and January 13, 2016 opposing wolf reintroductions in Colorado; and

**WHEREAS:** Big game hunting and agricultural livestock are significant economic drivers within the Rangely region; and

**WHEREAS:** Colorado has invested millions of dollars to manage numerous wildlife resources, including biggame populations in support of social and environmental goals; and

**WHEREAS:** Wolves have been determined to carry and distribute parasitic diseases to wildlife, household pets and humans; and

**WHEREAS:** The introduction of wolves into Colorado is in potential conflict with livestock production and big game management; and

**WHEREAS:** CPW has accepted 70 recommendations from the 2004 Wolf Management Working Group report describing how wolves will be managed and tolerated throughout the state, one management authority is returned to the state; and

**WHEREAS:** The Town of Rangely members generally support the funding recommendations provided in the Colorado Wolf Management Plan for Migrating Wolves;

#### NOW THERFORE, BE IT RESOLVED THAT THE TOWN OF RANGELY OPPOSES ANY EFFORT TO REINTRODUCE WOLVES INTO COLORADO AS WOLVES ARE ALREADY IN EXISTENCE IN THE REGION; AND

**THERFORE BE IT FURTHER RESOLVED** that the Town of Rangely supports the 2004 Colorado Wolf Management Working Group Recommendations for Managing Wolves that Migrate into Colorado; and

**THERFORE BE IT FURTHER RESOLVED** that the Town of Rangely supports delisting satellite wolf populations, such as those in Colorado, which will allow for state management of wolf populations; and

**THERFORE BE IT FURTHER RESOLVED** that AGNC encourages the State of Colorado to actively support the delisting of the Gray Wolf as well as active management of wolves to assure the protection of private property, livestock, and wildlife resources; and

**THERFORE BE IT FURTHER RESOLVED** that AGNC encourages specific implementation criteria be amended into the Colorado Wolf Management Working Group Recommendations for Migrating Wolves,

in addition to planning for resident wolves in Colorado. This planning process should include diverse stakeholders, including local governments. Issues that need to be addressed are: impacts to local economies, ungulate herds, threatened or endangered/rare species (i.e. sage grouse), livestock, hunting, recreation and disease management.

**THERFORE BE IT FURTHER RESOLVED** that the Town of Rangely encourages future management efforts be implemented that will protect local economies from losses due to the presence of the Gray Wolf. Financial compensation must be made available to address livestock, wildlife, and other impacts of wolf presence.

**THERFORE BE IT FINALLY RESOLVED** that the Town of Rangely encourages education opportunities be made available to the public regarding rules, regulations, and endangered species act implications related to wolf management. These opportunities should minimally include livestock and wildlife resource protection options.

Please review the document and if it meets with your approval, sign and date both copies and return to the address shown above. Upon our receipt of the signed documents and the fees discussed below, we can issue the renewal of right-of-way grant, absent any other unresolved issues.

You must pay a fee to the BLM for the costs we will incur in monitoring the operation of your authorized use. These fees are categorized according to the number of work hours necessary to monitor your grant and are not refundable. We anticipate your use will require a Monitoring Category  $\underline{2}$ , which involves a fee of  $\underline{\$440.00}$ . This fee must be paid prior to issuance of the grant.

Rent for use of public lands must be paid in advance of such use and prior to issuance of the ROW grant. Rent for a linear right-of-way is based on a schedule that is adjusted annually based on the Implicit Price Deflator (IPD), an inflation index. You have the option of paying the rent in 10-year periods or for the entire term of the ROW grant. If you do not pay the full term of the grant, future rental billings will be based on the rental schedules as published in the Federal Register. Rental for COC40655 has been paid through December 31, 2018. The next billing date will be January 1, 2019.

Please return **BOTH** signed copies of the grant, along with the monitoring fees and rent payment as discussed above within 30 days from receipt of this decision. If these requirements are not met, your application may be denied.

Please be aware that you may not conduct any activities related to your right-of-way on public land until you have received an authorized grant from this office. This grant, along with the authority to use the lands described in the document, becomes effective on the date it is signed by an authorized officer of the BLM. A copy of the signed renewal of right-of-way grant will be returned to you.

- b. The right-of-way or permit area granted herein is 20 feet wide, 3,444 feet long and contains 1.581 acres, more or less.
- c. This instrument shall terminate on December 31, 2048, ≤30 years from its effective date unless, prior thereto, it is relinquished, abandoned, terminated, or modified pursuant to the terms and conditions of this instrument or of any applicable Federal law or regulation.
- d. This instrument may be renewed. If renewed, the right-of-way or permit shall be subject to the regulations existing at the time of renewal and any

other terms and conditions that the authorized officer deems necessary to protect the public interest.

- e. Notwithstanding the expiration of this instrument or any renewal thereof, early relinquishment, abandonment, or termination, the provisions of this instrument, to the extent applicable, shall continue in effect and shall be binding on the holder, its successors, or assigns, until they have fully satisfied the obligations and/or liabilities accruing herein before or on account of the expiration, or prior termination, of the grant.
- 3. Rental:

For and in consideration of the rights granted, the holder agrees to pay the Bureau of Land Management fair market value rental as determined by the authorized officer unless specifically exempted from such payment by regulation. Provided, however, that the rental may be adjusted by the authorized officer, whenever necessary to reflect changes in the fair market rental value as determined by the application of sound business management principles, and so far as practicable and feasible, in accordance with comparable commercial practices.

- 4. Terms and Conditions:
  - a. This grant or permit is issued subject to the holder's compliance with all applicable regulations contained in Title 43 Code of Federal Regulations parts 2800 and 2880.
  - b. Upon grant termination by the authorized officer, all improvements shall be removed from the public lands within 90 days, or otherwise disposed of as provided in paragraph (4)(d) or as directed by the authorized officer.
  - c. Each grant issued pursuant to the authority of paragraph (1)(a) for a term of 20 years or more shall, at a minimum, be reviewed by the authorized officer at the end of the 20<sup>th</sup> year and at regular intervals thereafter not to exceed 10 years. Provided, however, that a right-of-way or permit granted herein may be reviewed at any time deemed necessary by the authorized officer.
  - d. The stipulations, plans, maps, or designs set forth in Exhibit A and B, attached hereto, are incorporated into and made a part of this grant instrument as fully and effectively as if they were set forth herein in their entirety.
  - e. Failure of the holder to comply with applicable law or any provision of this right-of-way grant or permit shall constitute grounds for suspension or termination thereof.

- f. The holder shall perform all operations in a good and workmanlike manner so as to ensure protection of the environment and the health and safety of the public.
- g. <u>The holder agrees to abide by all terms and conditions contained in right-of-</u> way grant COC40655, originally issued on September 29, 1986, to the Town of Rangely. No new construction is authorized.

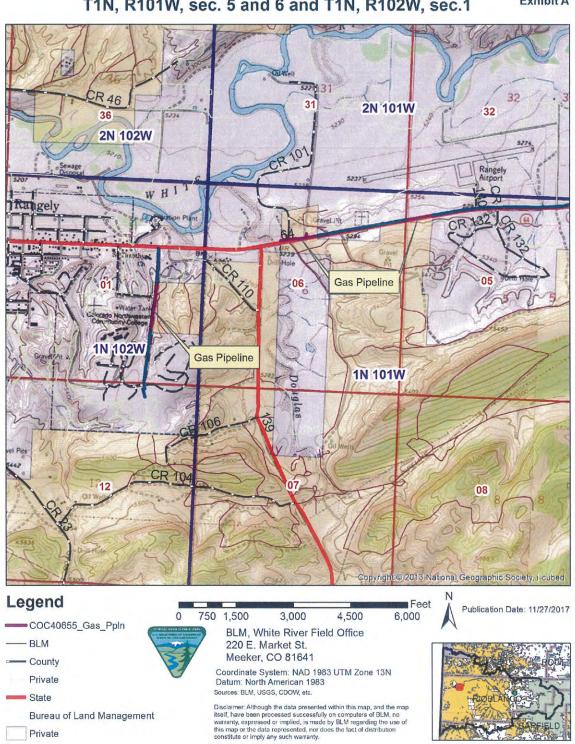

#### EXHIBIT B

1. The holder is responsible for informing all persons who are associated with the project that they will be subject to prosecution for knowingly disturbing archaeological sites or for collecting artifacts.

2. If any archaeological materials are discovered as a result of operations under this authorization, activity in the vicinity of the discovery will cease, and the BLM WRFO Archaeologist will be notified immediately. Work may not resume at that location until approved by the AO. The holder will make every effort to protect the site from further impacts including looting, erosion, or other human or natural damage until BLM determines a treatment approach, and the treatment is completed. Unless previously determined in treatment plans or agreements, BLM will evaluate the cultural resources and, in consultation with the State Historic Preservation Office (SHPO), select the appropriate mitigation option within 48 hours of the discovery. The holder, under guidance of the BLM, will implement the mitigation in a timely manner. The process will be fully documented in reports, site forms, maps, drawings, and photographs. The BLM will forward documentation to the SHPO for review and concurrence.

3. Pursuant to 43 CFR 10.4(g), the holder must notify the AO, by telephone and written confirmation, immediately upon the discovery of human remains, funerary items, sacred objects, or objects of cultural patrimony. Further, pursuant to 43 CFR 10.4(c) and (d), the holder must stop activities in the vicinity of the discovery and protect it for 30 days or until notified to proceed by the AO.

4. The holder is responsible for informing all persons who are associated with the project operations that they will be subject to prosecution for disturbing or collecting vertebrate or other scientifically-important fossils, collecting large amounts of petrified wood (over 25lbs./day, up to 250lbs./year), or collecting fossils for commercial purposes on public lands.

5. If any paleontological resources are discovered as a result of operations under this authorization, the holder or any of his agents must stop work immediately at that site, immediately contact the BLM Paleontology Coordinator, and make every effort to protect the site from further impacts, including looting, erosion, or other human or natural damage. Work may not resume at that location until approved by the AO. The BLM or designated paleontologist will evaluate the discovery and take action to protect or remove the resource within 10 working days. Within 10 days, the operator will be allowed to continue construction through the site, or will be given the choice of either (a) following the Paleontology Coordinator's instructions for stabilizing the fossil resource in place and avoiding further disturbance to the fossil resource, or (b) following the Paleontology Coordinator's instructions for mitigating impacts to the fossil resource prior to continuing construction through the project area.

6. All applicable terms, conditions, and stipulations contained in the original ROW grant and any amendments shall be carried forward and remain in full force and effect. No new construction is authorized. 7. At least 90 days prior to termination of the right-of-way, the holder shall contact the Authorized Officer to arrange a joint inspection of the right-of-way. The inspection will result in the development of an acceptable termination and rehabilitation plan submitted by the holder. This plan shall include, but is not limited to, removal of facilities, drainage structures, and surface material; recontouring; topsoiling; or seeding. The Authorized Officer must approve the plan in writing prior to the holder's commencement of any termination activities.

8. The holder shall conduct all activities associated with the operation and termination of the right-of-way within the authorized limits of the right-of-way.

9. Any proposal involving additional surface disturbance outside of the existing right-ofway disturbance requires an application to the BLM for analysis and authorization. New stipulations for construction would be applied to projects subject to the regulations and policies existing at the time of authorization.

10. The holder shall monitor all disturbed and reclaimed areas through final abandonment for the presence of invasive, non-native, and/or noxious plant species. The holder will be responsible for eradication of noxious weeds that occur on site using materials and methods approved in advance by the Authorized Officer.

11. The holder shall notify the authorized officer at least 60 days prior to non-emergency activities that would cause surface disturbance in the right-of-way. A "Notice to Proceed" shall be required prior to any non-emergency activities that would cause surface disturbance on the right-of-way. Any request for a "Notice to Proceed" must be made to the authorized officer, who will review the Proposed Action for consistency with resource management concerns such as wildlife, big game winter range, paleontology, special status species, and cultural resource protection. The authorized officer may require the completion of special status species surveys or other resource surveys. Additional measures may be required to protect special status species or other resources.

12. The holder shall comply with all federal, state and/or local laws, rules, and regulations addressing the emission of and/or the handling, use, and release of any substance that poses a risk of harm to human health or the environment.

13. When performing construction and maintenance (including emergency repairs) activities during the "closed" fire season (May 10 – October 20), as set by Colorado State Law, or during any other closed fire season prescribed by the BLM Colorado State Director, the Holder, including any persons such as contractors, etc. working on their behalf, shall equip at least one on-site vehicle with firefighting equipment, including, but not limited to, fire suppression hand tools (i.e., shovels, rakes, Pulaskis, etc.), a 16-20 pound fire extinguisher, and a sufficient supply of water for initial attack, with a mechanism to effectively spray the water (i.e., backpack pumps, water sprayer, etc.).

14. During conditions of extreme fire danger or when the State of Colorado and/or the BLM Colorado State Director issues a fire restriction order, operations shall be limited or suspended in specific areas, or additional mitigation measures may be required by the BLM Authorized Officer.

15. In accordance with 43 CFR 2805.12(d) (or subsequent revisions), the Holder shall do everything reasonable to prevent fires on or in the immediate vicinity of the ROW. The Holder will immediately report fires to the BLM Authorized Officer or local fire dispatch at (970)-826-5037 and take all necessary fire suppression actions, when safe to do so, with their personnel and equipment on any fires they cause to ignite.

16. The holder shall maintain the condition of the origin area of the fire from further damage to enable the Fire Investigator to properly assess the origin area and cause of the fire. The Holder shall report to the Fire Investigator or BLM Incident Commander and shall not enter into the origin area on fires unless given permission to do so.

17. The holder will cooperate with the BLM in its efforts to investigate, suppress and respond to all future fires. The duty to "cooperate" includes, but is not limited to, the following duties regardless of whether BLM is on the scene:

i. The duty to provide the BLM (Authorized Officer or local fire dispatch at (970)-826-5037 with reasonable and timely notice concerning all fires involving the Holder's facilities, or discovered during routine operations.

ii. The duty to share factual information with the BLM concerning fires, including but not limited to the names of Holder's employees and/or contractors with knowledge of the incident; and to allow employees and/or contractors to be interviewed by BLM's investigators regarding factual information relating to a fire.

iii. It is the duty of the holder to preserve the point of ignition, fire scene and reasonably account to the BLM for Holder's actions taken at the scene of a fire.

iv. The duty to minimize disturbance of potential evidence located at the scene; to not engage in any evidence collection or destructive testing without BLM and or its counsel's express written consent; to properly handle and preserve any evidence collected and to make all documents and evidence, including expert reports, available to the BLM in a rapid and timely manner upon request of BLM and/or its counsel.

v. The duty to not hamper the BLM investigation of origin and cause of the fire; and to reasonably assist BLM's investigation at the scene.

vi. The duty to provide information upon request of BLM and/or its counsel concerning the construction, monitoring, inspection, maintenance and/or repairs of any of holder's facilities located at or adjacent to a fire.

vii. The duty to provide information upon request of BLM and/or its counsel concerning the monitoring, inspection, and or alteration by holder of any condition on public land, including but not limited to, public land adjacent to any of the holder's facilities.

viii. The duty, during BLM fire suppression efforts: to defer to and follow the instructions of the BLM's Incident Commander regarding activities within the boundaries of the fire and checking in and out of the fire; and to recognize BLM's primary authority over the incident scene.

# **BLM HEADQUARTER'S GRAND JUNCTION**

Last month, after French President Emmanuel Macron addressed a joint meeting of Congress, U.S. Sen. Cory Gardner of Colorado quickly caught up to Interior Secretary Ryan Zinke on the House floor.

Gardner had Colorado business to discuss with his old friend, the former senator from Montana who now leads the U.S. Department of the Interior, which administers about a fifth of the nation's land.

The Republican senator from Yuma, as he's done since the Obama administration, pressed the case for Colorado becoming Washington's West Wing by moving the headquarters of the Interior Department's Bureau of Land Management closer to the 245 million acres it manages in the West.

"We're getting ready to move forward," Gardner remembers Zinke telling him.

Already, most of BLM's 8,900 permanent employees work outside of Washington, D.C., mostly in the West. Still, many western leaders see great significance in a westward HQ move.

And Gardner has his heart set on Grand Junction as the agency's new home.

Such a move could bring up to 400 jobs, economic activity and a national identity for the city of 62,000 near the Utah border, in the heart of the American West, away from the starched collars and leather briefcases of the nation's capital.

"He really wants to do this," Gardner told Colorado Politics about his conversation with Zinke about moving BLM's headquarters. "And he has a lot of support to do it in Colorado."

A number of possible destinations for BLM have been discussed.

Last August the environmental website E&E News reported that Zinke had told a private meeting that Denver "will probably" become the host of three major Interior divisions with moves being made in the 2019 fiscal year, which begins next Oct. 1.

The report cited BLM, the U.S. Fish and Wildlife Service and the U.S. Bureau of Reclamation. E&E News got hold of notes from a meeting in Denver last July with senior staff of the U.S. Geological Survey, another Interior agency.

In August, Interior's associate deputy secretary, James Cason, named BLM and the Fish and Wildlife Service as candidates for a move west.

Zinke last November mentioned Salt Lake City and Denver to The Salt Lake Tribune as possible BLM destinations.

But while there's been little or no public political inertia behind an agency move to Denver, Grand Junction is another story. There have been joint D.C.-Colorado meetings to address it. The Mesa County relocation has been chattered about in the statehouse, and it's of keen interest to the state's congressional delegation.

Sen. Michael Bennet, a Democrat from Denver, has been pushing the BLM deal with Gardner for almost a year. He, too, is convinced there's nowhere better than Grand Junction.

"The values of Coloradans on the Western Slope align with the core mission of the BLM," Bennet told Colorado Politics. "We must ensure this move is more than symbolic and provides the resources necessary to manage our public lands and improve agency decision-making."

#### Go West

Down south, they call such opportunities high cotton. And Colorado is chest-deep in positioning to land this deal.

Of its 245 million acres nationwide, BLM administers 8.3 million acres in Colorado. Nationally, there's another 181 million acres controlled by the U.S. Fish and Wildlife Service and National Park Service, also Interior agencies, and 193 million under the U.S. Forest Service, part of the U.S. Department of Agriculture.

The federal government collectively owns more than 50 percent of western states, but only about 4 percent of the federal lands are east of Colorado.

Zinke wasn't available to discuss it, but Department of Interior sp0keswoman Heather Swift said an official plan to move federal agencies hasn't yet been put on paper, and there's no official short list of locations.

"But generally speaking, I will say the secretary and deputy secretary both see incredible opportunities to push more resources closer to the land and people under (Interior's) management," she said.

The deputy secretary she speaks of is David Bernhardt, who's as Colorado as Red Rocks and craft beer.

Born and raised in Garfield County and a graduate of the University of Northern Colorado, Bernhardt got his start in Washington as chief of staff to Interior Secretary Gale Norton, a former Colorado attorney general. That was after he was an lawyer for Denver-based Brownstein Hyatt Farber Schreck.

"Both Zinke and Bernhardt are from Western towns and see value in having bureaus closer to the communities they manage," Swift said

### Local passion

Groups in Grand Junction have been holding meetings and at least one video conference call with Bernhardt, the Rifle-raised decision-maker at Zinke's right hand.

Christian Reece — executive director of Club 20, the Western Colorado coalition of government and business leaders — said Grand Junction could be a major hub for BLM, adding that she's sure the local economic folks will be ready to pony up incentives.

She said Gardner, Bennet and U.S. Rep Scott Tipton, R-Cortez, who represents Grand Junction in Congress, already are working with Club 20, the Grand Junction Chamber of Commerce and the Grand Junction Economic Partnership on the matter.

"The entire community has embraced the idea of hosting the BLM HQ, and if selected, I believe we would all work together to ensure that the BLM feels our warm and welcoming western hospitality," Reece said.

Reece thinks getting bureaucrats closer to their decisions can't help but improve those decisions.

"When rule makers are able to see the on-the-ground impacts of their decisions, greater thought and accountability will naturally follow and will hopefully result in a process that is not a one-size-fits-all bureaucratic process," she said.

#### What D.C. wants

Swift said that while the agency hasn't started naming specific cities, they have set some criteria for new homes for BLM: A reasonable cost of living, proximity to public lands, good quality of life and good schools and no more than two flights away from D.C. — say, like, Grand Junction Regional Airport to Denver International Airport and east to Washington.

In March, Tipton had Zinke sitting before him in a House Natural Resources Committee hearing. He used the opportunity to try to get the Interior boss on the record about the issue.

Zinke obliged.

"My concern is making sure we're going to a community that has a high quality of life, that's affordable to the GS-5 to GS-7 (employees), great communities where we can attract millennials who will want to live there," he told Tipton.

A GS-5 federal employee earns up to about \$38,000 a year. A GS-7 tops out at about \$46,000 annually.

"Colorado certainly fits that description," Zinke said.

#### Leg up on Denver

Grand Junction compares favorably to Denver in Sperling's Best Places assessments of cost of living, which is based on government and business data. While Grand Junction scores 100 on the Sperling's rating for housing costs, Denver scores a 185.

The average rent for a two-bedroom apartment in Grand Junction is \$797, says Sperling's. In Denver it's \$1,227, on top of the Front Range's traffic congestion, higher crime rates and periodic swells in bad air quality.

A person making \$39,000 a year in Grand Junction would need to make \$50,000 to maintain the same lifestyle in the Denver, Sperling's data suggested with the kind of information Washington decision-makers will likely give weight.

While Grand Junction indexed at 30 out of 100 on Sperling's crime index, Denver was 49.3. The national average is 31.3.

#### Leg up on the West

Gardner speculated on how Colorado stacks up against other Western locations.

Montana, Zinke's home state, is out of the way and could be viewed politically as home-cooking for the Interior secretary in an administration surely tiring of ethical questions by Cabinet members. Utah has a lot of Republican support, but most of the land the bureau would manage is far-flung from the Salt Lake City-Provo metro area, with few other competitive cities elsewhere in the state.

Nevada has Las Vegas, an urban area laden with a high cost of living and carnal distractions. Trump has had high-profile personal clashes with New Mexico Gov. Susana Martinez, a Republican he criticized by name on the campaign trail in 2016.

Gardner has had his own clashes with Trump, even calling him a "buffoon" in 2016 and challenging his attorney general, Jeff Sessions, on marijuana enforcement policy. The senator, however, is a rising star in Washington political ranks and is seen as a valuable ally on the Senate Energy and Natural Resources Committee, as well as in foreign-policy matters as member of the Foreign Relations Committee.

That leaves Colorado as an attractive and defensible option.

Already, the 623-acre Denver Federal Center campus in Lakewood houses offices for 28 federal agencies, including regional offices of several Interior divisions like BLM and the Geological Survey. And Interior is Colorado's largest non-military federal employer, with nearly 7,000 workers in the state, Colorado Public Radio reports.

But it just makes sense to move the BLM headquarters to Grand Junction, where the local communities and public lands co-exist, Gardner said.

Gardner and Tipton introduced legislation a year ago to authorize Interior to move the BLM's headquarters to an unspecified location in a western state.

But Zinke says a lot of groundwork has to happen before the idea is presented for congressional approval, however.

"There will be hearings on the Hill, briefings of committees," Zinke told the Washington Post in January. "We want the reorganization to be bipartisan. There will be a lot of my time spent on the Hill, talking to ranking members and chairmen."

If Republicans don't get on with things quickly, the November election could give Democrats a bigger say in the Trump administration's proposal when the next Congress convenes.

#### **Doubters in D.C.**

Not everyone thinks this grand reorganization is a great idea. Count President Barack Obama's interior secretary, Sally Jewell, among them. She thinks it an unrealistic boondoggle.

"I'm skeptical about the reorganization and its ability to serve the public more effectively," she said in an interview with the Washington Post. "Interior has a broad and diverse mission."

Jewell said it would be massively expensive to relocate federal agencies, which are located in Washington for a reason — to save cost on travel and to share real estate, leases and other economies of scale with other agencies.

"This would be from moving people, giving up leases before maturity, potential severance costs and substantial disruption to productivity," Jewell said of the expenses.

And that's before the first spade of dirt is turned on a new headquarters in Grand Junction or some other western city.

If Democrats take control of the Senate in November, New Mexico Sen. Tom Udall, the lead Democrat on the Senate Appropriations subcommittee that oversees funding for the Department of the Interior, could use his majority powers to settle some things with how Zinke runs Interior.

And that bleeds over onto Grand Junction.

In budget meeting on May 10, Udall chided Zinke for "continued attacks on America's public lands," and asked how he planned to pull off such a grand maneuver as reorganizing agencies and moving them to far-flung locations, while simultaneously seeking double-digit budget cuts for the agency. He cited an exodus of career agency leaders under Zinke.

"Mr. Secretary, you want our permission to reorganize the entire department, but it's not even clear whether you have the right policies in place to manage your most senior career staff members," he told Zinke. "The department has not provided sufficient detail on its actual plan for the reorganization, including how much it would cost, to Congress or the public."

The original pitch man, Gardner, doesn't think all Democrats feel that way. He thinks it wall pass Congress.

"It has bipartisan support," he said, with Bennet on the same side, for example. "It's not a controversial idea."

### Crews Respond to Dinosaur Headquarters Fire in Dinosaur National Monument

point of diversion was decreed in Case No. 89CW110 as a change from the original decreed point of diversion.

- C. <u>Source</u>: Municipal wastewater and urban runoff collected, treated and discharged at the Rangely Sewage Treatment Plant, tributary to the White River.
- D. <u>Amounts and Uses</u>: 3.1 c.f.s. By prior decrees 2.0 c.f.s. was made absolute for irrigation purposes, leaving 1.1 c.f.s. conditional for irrigation; 3.1 c.f.s. conditional for industrial, piscatorial and recreational purposes. In the last diligence Case No. 11CW12, originally decreed uses of domestic and municipal purposes were abandoned and cancelled.
- E. <u>Appropriation Date</u>: October 1, 1976
- 4. <u>Diligence Activities</u>: During the relevant Diligence Period (the past six years since entry of the 11CW12 Decree), the Town and its affiliated Water Users Group have invested considerable capital expenses into their raw water systems as well as the associated water and wastewater systems, both of which supply the subject conditional water right. In the six years preceding the filing of this Application, Applicant has performed the following activities that evidence reasonable diligence in the development of the Rangely Sewage Treatment Plant Discharge conditional water right.
  - A. The Town improved its wastewater treatment plant to include a new instream effluent diffuser in the White River and upgraded the disinfection treatment to ultraviolent system. Total design and construction costs were approximately \$784,000.
  - B. The Town's water treatment plant was overhauled and expanded from 2 million gallons per day (MGD) to 3.24 MGD peak capacity with a possible future expansion to 4.32 MGD peak capacity with additional equipment installation. Additional pumping capacity of the River Pump Station was increased from 2,000 gpm to 3,600 gpm. Total design and construction costs were approximately \$6,000,000.
  - C. In 2014, the Town dredged the pre-sedimentation ponds that feed the east raw water system at an approximate cost of \$100,000.
  - D. In 2017 the Town added a third pump to the River Pump Station to increase capacity both for peak demand at the water plant and to meet demand in the east raw water system. The cost of that project was \$50,477, consisting of the new pump and variable frequency drive, installation, and SCADA upgrades.
  - E. Since 2015 the Town has spent approximately \$942,600 to replace aging potable water mains.

- F. In 2016-17 the Town obtained a Colorado River Water Conservation District Grant for \$26,898 project to upgrade and improve isolation valves and meters for each user on the Raw Water System. The grant was \$8,379 with a match from the Town of \$18,519. That grant was completed and closed in October 2017.
- G. The Town completed an inspection of and repaired damages found to the 500,000 gallon raw water storage tank in 2017 for a total of \$11,648.
- H. The Town expended approximately \$204,000 in maintenance and operations of the integrated raw water system since 2012. The Town annually budgets \$5,000 to \$10,000 for its portion of capital improvements to the Raw Water System.
- I. The Town spent approximately \$35,000 in study and analysis of the integrated raw water system since 2012 including the 2014 Westwater Study.
- J. In 2018, the Utilities Superintendent plans to rebuild the raw water irrigation system at the WWTP and Town Park to include a flow meter for more accurate measurement of irrigation usage. That project is estimated to cost \$3,000.

5. <u>Integrated System</u>. As most recently recognized by the Decree in Case No. 11CW12, the subject conditional water right is a component of Applicant's integrated water supply system. Consequently, Applicant's substantial work identified above regarding its water right system inure to the benefit of diligence concerning the subject conditional water right. "When a project or integrated system is comprised of several features, work on one feature of the project or system shall be considered in finding that reasonable diligence has been shown in the development of water rights for all features of the entire project or system." C.R.S. § 37-92-301(4)(b)

6. <u>Land Ownership Information</u>. Applicant is the owner of the land upon which any new diversion or storage structure or modification to any existing diversion structure is or will be constructed.

WHEREFORE, Applicant respectfully requests this Court enter a decree granting a finding of reasonable diligence for the Rangely Sewage Treatment Plant Discharge, to continue this conditional water right in full force and effect for an additional six years, and for such other and further relief as the Court deems appropriate.

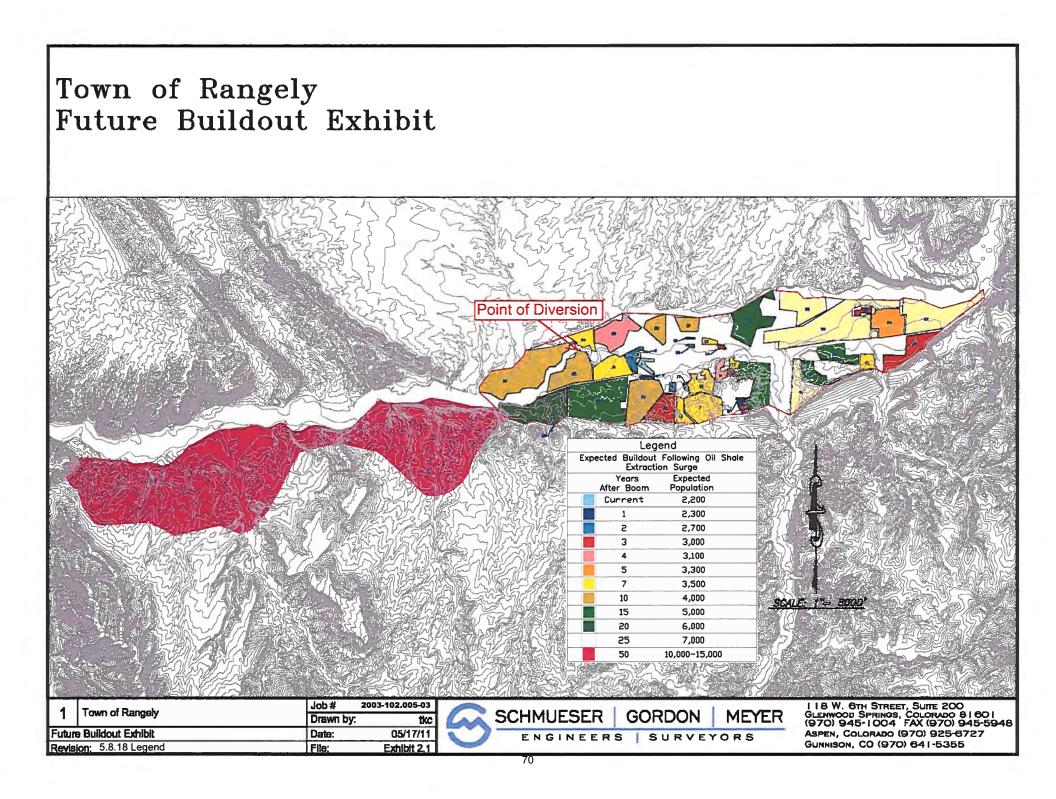

#### Subject: WR Algae Grant Process Update

Good Afternoon Algae TAG Members:

I hope you all had a <u>great Memorial Day Weekend and you stayed Safe</u>! My apologies for the long email below but it is necessary and I'm in need of your help to move us forward with the Algae process in the future study years.

Good news on the 2018 SOW and agreement. USGS has collected data from 8 of the 20 sites. The District was able to get USGS the names, contacts and permissions to access private land on most of the other 12 sites.

The WRCD signed the final USGS Agreement last night. Therefore, we will be sending invoices for your 2018 contributions in the next week or so if you have committed to contributing. (If you haven't committed, maybe we can send you one for double the top contributor. Just kidding...) Please let Tristan or I know if you need anything other than an invoice.

**2019 Grant Processes and Progress Update**: Unfortunately, we have gotten caught up in a timing issue with the YWG Basin Roundtable making changes to their grant process for the Water Supply Reserve Funding (WSRF). Therefore we did not present our first reading to them earlier in May as originally planned. It appears that they will grandfather us in and allow us to present the first reading in July and if accepted a second reading in Sept. which would, at best, have us presenting to the CWCB near the end of the year. If for some reason they don't grandfather us in, they will not hear it until Nov. which would put us in a challenging position so we will keep our fingers crossed.

I will also be submitting grant application to the Colorado State Conservation Board (CSCB) this month for 2019 that will be asking for matching dollar commitments. So as you can see this is something that most granting entities are going to require. **Could each of you visit with your respective Boards and or entities and see if you could provide a "pending letter" or something of that nature as to an amount they could request in this Fall's 2019 budget process?** The letter would need to have some kind of language such as the below example including an amount you would request during your budget process. The total for the proposed 2019 SOW is \$163,807. USGS will cover \$51,000 so we will be looking for around \$112,000. The grant request can be used for 2019 - 2021 so I'm hopeful that we can use about \$33,000 per year of the WSRF grant. That means we need to secure \$64,000 for 2019 providing we can get the CSCB grant as well.

I am writing you to express our continued support of the grant application, submitted by the St. Vrain and Left Hand Water Conservancy District, to the Colorado Watershed Restoration Program – Stream Management Plan Grant and the related application to South Platte Roundtable for basin funding for this same project. The City of Longmont and other watershed partners continue to complete a monumental flood recovery effort in this watershed. This continued comprehensive planning will allow us to take the next step in this recovery effort and is critical at this time.

In partnership with the St. Vrain and Left Hand Water Conservancy District and other basin partners, Longmont is planning on participating and partially funding this stream management planning effort. We are currently in the budgeting process for 2019 and will be putting this funding request before our City Council for approval in the normal budgeting process. Longmont staff will ask for \$17,500.00 as our proportionate participation level in this project.

This application is vital to our community and will result in a science based approach to working on many of the stream management issues that exist in our watershed.

I look forward to hearing if any of your entities would be able to provide this. Your help would be greatly appreciated. And of course, the sooner you can let me know if this is a possibility the better.
