

- **9. Committee/Board Meetings** The AGNC meeting offered some good info. Andy Garcia, Executive Director of DOLA presented a plan under the governor. There were some concerns with the \$12 mil Severance from oil and gas revenues to go to Renewable Energy. The BLM director was concerned about the issue with the time it took to approve the OHV trail system due to that most is on the County Roads. She discussed about the Lake and BLM offered a resolution. BLM was very helpful with Jocylyn's planning her Gravel Grinder.
- 10. Reports From Council The second meeting with the special districts was good. Most people want an economic marketing person in place to support all the special districts. Looking to combine many other services to streamline local service. For instance like an inhouse HVAC person to handle many business' needs. Not to replace Duceys or Praters but someone in-house for easy tasks. More questions surrounding the MILL levy and need to finalize what is needed by what date. July 1st is the next meeting for the community outreach. Lisa mentioned that they looked into a casino for the town. Seems the state would have to vote on approval on that, which is why, historically the town has gone through locals tribes for building one in our area. We can research further into the state side of things. Having good conversations and everyone is working well within a group.

12. Reports from Officers – Town Manager Update – Rangely was unsuccessful in their bid for the REDDI Grant; however, the USDA in Colorado has made plans to assist with programs and assistance in our economic development efforts. Lisa attended the CDOT meeting in Meeker this week. CDOT will be completing some major work to Douglas Pass, to fix and widen 139. CDOT has also included a CDOT poll regarding transportation plan. Andy Key suggested sharing letter on Town's facebook page. Lisa agreed. Ti has invited the community and council to participate in Narcan training. Group coming in from Steamboat Springs to teach participants how to use Narcan and identify when use is appropriate. Rangely Roundup is being sponsored by the Western Oil and Gas Commission and they are working our rock work starting June 21st. The Chevron Tree planting was a success and Matt said that Katherine (the organizer) was very happy with the participation turnout. 130 people from Rangely came to participate and it will be good to know that 500 shrubs were planted to reclaim this as a new public space. Matt/Chevron wanted to talk to town about contracting a watering plan for the newly planted shrubs. Lisa will talk to Janet and Jeff regarding watering. Keely at CNCC has invited the council to take a tour or a flight during the Aviation Road Show. Also wanted to ask council to consider sponsoring the day event as well as the council sponsor lunch estimated to be about \$2k. The Rountable will invite others but more should go to the benefit. It's a good opportunity for networking. Roundtable is looking for Weekend Warriors to find in-town competent welders, manufactures, machinists to keep work local. All the summer hires are working. Lots to do in Rangely with road work, town flowers upkeep, and mosquito abatement. Aerial spray happening tomorrow night and golf course Thursday morning. Mosquito questions ensued: the cost to spray is about \$3,600 per aerial fogging. Sprays by river and up and down town as well as our fogging trucks that will spray by the park and other neighborhoods that receive complaints on mosquitos. Also, be putting mosquito abatement bricks in standing water to control larvae. There are no issues with the runoff in the river. FAA approves this before we spray. We cannot aerial spray outside of city limits due to owner concerns despite council thinking it would be effective. Matt said Chevron might be looking into spraying as the bugs are very bad there.

Lisa Hatch approached Lisa with this idea to honor our aging population. Their drive and sacrifice to carve out a slice of life for us today and dedicate the month to the seniors as a way to partner with community. The TANK will have several events coming up for the seniors in the month, along with the Senior Picnic. The town also is advertising Rangely's WRV apartments with the Beacon Publication. We have White River Village for independent living, residents can then transfer to Eagle Crest for assisted care and finally move on to Swing Bed for long term care and hospice. Rare in such small towns to cater so fully to the aging population. **Motion made to approve Resolution 2019-04 proclaiming July 2019 to be Senior Month made by Andy Key, Second by Luke Geer, Motion passed.**

Discussion and action to approve partnering with the Colorado Parks & Wildlife and the Rio Blanco Conservancy District on the education and outreach to harvest smallmouth Bass and Northern Pike for fish management on the lower White River Drainage. –Colorado Parks and Wildlife as that Rangely be a partner to advertise the invasive fish species here exchanged for a cash payment to the angler. CPW has agreed to pay \$20 per Northern Pike and Small Mouth Bass. Great way for our resident anglers to get some cash while helping our environment. Motion to approve partnering with Colorado Parks and Wildlife and the Rio Blanco Conservancy District on the education and outreach of the invasive species in the White River made by Matt, Second by Andy Key. 




