	Rulemakings

BACKGROUND

Update to Board of County Commissioners (BOCC) regarding the Garfield County rulemaking team's status and efforts at ensuring beneficial, Piceance Basin/Rural appropriate, implementation of Senate Bill 19-181 (SB19-181).

Garfield County has been moving forward with tracking the development of regulations by the Colorado Oil & Gas Conservation Commission (COGCC) and the Colorado Air Quality Control Commission (AQCC) to implement SB19-181. We have assembled a team to advise and represent the County in such efforts, and to advocate for rules that better reflect the characteristics of the County and Piceance Basin/Rural geology and operations so as to be more cost-effective and not unduly burdensome or economically punitive to responsible gas development and production.

- I. The Garfield County Team:
 - a. The County has retained Davis Graham & Stubbs LLP (DGS) as outside legal counsel.
 - b. DGS has engaged Adamantine Energy (Matt Lepore and Anne Carto) as energy advisers to DGS and the County.
 - c. DGS has engaged an economist, Dr. Tim Considine, University of Wyoming and Natural Resource Economics Inc., to assist with cost-benefit and other economic analyses of proposed rules as they are developed by Staff to COGCC and the AQCC.
 - d. DGS has engaged an air quality expert, Jim Wilkinson, Terra Technologies, to assist with air quality benefit analysis for the various proposed emission control rules.
 - e. DGS is vetting potential flowline rulemaking consultants.

II. The Western Local Governments Coalition includes 15 members: Garfield County, Delta County, Jackson County, Mesa County, Moffat County, Montezuma County, Rio Blanco County, City of Craig, Town of Collbran, Town of Meeker, Town of New Castle, Town of Parachute, Town of Rangely, Town of Silt and City of Rifle. We continue to periodically engage the WLG membership as rulemakings proceed.


III. Rulemakings Update:

- *a.* Participating in COGCC Flowline stakeholder process, which began formally with a Notice of Rulemaking on October 8th and stakeholder meeting October 9th leading to rulemaking hearings in Greeley on November 20-21. This will be a fast-moving rulemaking process with tight deadlines. Will submit party status request in coming days on behalf of WLG coalition and initial comments to COGCC staff. *Matt Lepore will lead overview and discussion of flowline rulemaking key issues.*
- b. Adamantine Energy has been conducting research on the relevant stakeholders and groups we should optimally engage ahead of and during the rulemakings to ensure we understand where others stand on key issues and to ensure we effectively advocate for and build broad support for Garfield County and WLG coalition positions. Adamantine's Anne Carto will provide an overview of stakeholder engagement strategy development.
- c. Participating in AQCC's fall rulemaking focused on minimizing oil and gas emissions, which began September 10 in Grand Junction with a draft rules public presentation and public comment session, including comments provided by Chairman Martin. Rulemaking hearing is December 19 and 20, 2019 in Denver. *John Jacus will lead discussion of current thoughts and activities for AQCC rulemaking*.
- d. Continue advance planning for active participation in subsequent COGCC and AQCC rulemakings implementing SB 19-181, and are meeting periodically with Staff Directors (Jeff Robbins and Julie Murphy at COGCC, Garry Kaufman at the Air Pollution Control Division) and various other rulemaking parties and stakeholders to best ensure receptivity to WLG Coalition perspectives that equal protections and benefits may be achievable without "one-size-fits-all" regulations that may impose significant western Colorado economic consequences--while failing to provide intended and necessary air quality and other benefits.
- e. Continue identifying key issues and developing positions on those issues for each of the specific COGCC and CDPHE rulemakings. The working objective is to anticipate specific issues of interest or concern to the BOCC and WLG for specific rulemakings and to develop positions and robust stakeholder engagement processes on those issues well ahead of Rulemakings.

RECOMMENDED ACTIONS AND GUIDANCE REQUESTS

IV. Specific Actions recommended for BOCC Approval

- a. Flowline Rulemaking: While the team continues to assess the just-released and attached draft rules, key provisions include Rule 1105, Flowline Abandonment provisions, on pp 17-18. Specifically, 1105.c.(2) gives COGCC director discretion on the off-ramps to allow abandonment in place. Also 1105.e. outlines the six circumstances under which abandonment in place may be allowed.
- *Flowline Rulemaking*: Advocate for a complete carve-out for produced water lines from the requirement to excavate and remove rather than abandon in place.
- *Flowline Rulemaking*: Consider advocating for primacy of local governments over state on whether to require flowline removal or allow abandonment in place.
- *Flowline Rulemaking*: Advocate for a rural vs. urban distinction with respect to excavation and removal vs. abandon in place requirements.
- *Flowline Rulemaking*: Consider advocating for required excavation and removal of a sensible short section of flowlines rather than a default required removal of the full length of flowlines. This could provide the desired optimal safety assurances without undue cost and surface disturbance required to remove the entire flowlines.
- b. AQCC Rulemaking: APCD has requested comment on proposed rules changes for AQCC Regulation Nos. 3 and 7. These changes would apply the same requirements state-wide, and the County may be concerned they will be far more burdensome and less effective in the Piceance Basin than in the DJ Basin, for example. Right-sizing the applicability thresholds and monitoring frequencies in these proposed rules, among other changes, for Western Slope, drygas operations needs to be on the table from the outset. **Previously received approval to develop and submit comments along these lines and to submit party status request.**


