\*The applicant or a family member related by blood or marriage shall personally sign the application for an absentee ballot; or, in case of the applicant's inability to sign, another person shall witness the elector's mark.

**First Time Voters Who Registered By Mail**

If you are registered to vote for the first time in the state of Colorado and have registered by mail, **a copy of one of the following forms of identification information is required to be submitted with the Absentee Ballot:**

- A valid Colorado Driver's License; or
- A valid Colorado Department of Revenue identification card; or
- A Valid U.S. Passport; or
- A valid pilot's license with photograph issued by the Federal Aviation Administration; or
- A valid employee identification with a photograph issued by the US Government, Colorado State Government, or any county, municipality, board, authority or other political subdivision of the state; or
- A valid US Military identification card with photograph; or
- A copy of a current utility bill, bank statement, government check, paycheck, or other governmental document that shows the name and address of the elector; or
- At least the last four digits of the person's social security number.

The approved forms of identification must show your address as being in the State of Colorado.

**Do not include original documents with this application.**

COLORADO MUNICIPAL ELECTION LAW REQUIRES THAT IN ORDER FOR YOUR BALLOT TO BE COUNTED, IT MUST BE RECEIVED AT RANGELY'S TOWN HALL BEFORE 7:00 PM ON THE DAY OF THE ELECTION. MARK AND RETURN YOUR BALLOT AS SOON AS YOU RECEIVE IT.
