B.	Search, Retrieval, & Redaction of Criminal Justice Records (No audio/visual)	\$30.00 per hour
C.	Search, Retrieval, & Redaction of Criminal Justice Records (With audio/visual)	\$40.00 per hour
D.	Copies of records (standard printed copy)	\$0.25 per page
E.	Copies of records (flash drive) – no cost if supplied by requestor	\$5.00
F.	Copies of records (digital copies)	\$0.00

24-72-305.5 **Access to records-denial by custodian-use of records to obtain information solicitation**. Any person for the purpose of soliciting business for "pecuniary gain" shall not use record of official actions and criminal justice records and the names, addresses, telephone numbers, and other information in such records. The official custodian shall deny any person access to records of official actions and criminal justice records unless such person signs a statement which affirms that such records shall not be used for the direct solicitation of business for pecuniary gain.

24-72-309. **Violation-penalty**. Any person who willfully and knowingly violates the provisions of this part 3 is guilty of misdemeanor and, upon conviction thereof, shall be punished by a fine of not more than one hundred dollars, or any imprisonment in the county jail for not more than ninety days or both such fine and imprisonment.
