- 9. Public Hearings 7:10pm
 - a. CNCC Update President Lisa Jones and Vice President of Instruction Keith Peterson Dr. Jones from CNCC addressed concerns about the athletics at CNCC. Dr. Jones stated that CNCC is not cancelling the athletics but are looking at different regions due to budget and trying to save CNCC money. Travel is a substantial part of that cost. She is asking to move regions or to realign the region. She stated that the Presidents are meeting to help better schedule games to help reduce the travel. Dr. Jones also stated that they are in the process of updating their eligibility policy to make athletes more successful. Dr. Jones reported that the soccer team was moved to Rangely and that the Rodeo team moved to Craig. Rock 'n Bull will stay in Rangely. Keith Peterson with CNCC also reported to the council on the academic side of CNCC. Keith stated that the Aviation program has a new program director and a new coordinator. They will be attending an airshow to represent CNCC. Keith said that they are working on an EDA grant

and are still searching for a Maintenance Program Director. Keith also discussed the Dental Hygiene Program and how they will be offering CNCC's first bachelor's degree in 2023 for Dental Hygiene. They hope to grow the program by offering to be hybrid. Keith also stated that they will be offering new Sports Medicine classes and that the Cyber Security Program will be going fully hybrid in the Fall.

DOLA, the Town of Dinosaur, Kelli, and Lisa have met, and DOLA is very supportive. DOLA has granted an Admin grant to the Town of Dinosaur. The Gas Department would oversee the operation, but the Town of Dinosaur would own it. There would be no additional cost to the town. New meter reading equipment has finally been implemented today with it's first read and went well. Kelli stated that they continue to do meter changes, that they have 58 to get done this year and are about halfway done already. Kelli reported that they have completed their annual valve inspection. White River Villages has an apartment that is getting remodeled. Kelli also stated that they are working on the sprinkler system at the museum.

Water/Wastewater – Submitted by Donald Reed

Project status/Current Issues:

Water Treatment Plant:

- Water quality still isn't the best, but it is a lot better than we had last month. We are required to maintain a total organic carbon removal of 20% on a running annual average. Currently we're at 22.3%, which is a lot closer than we'd like. Soon, we may need to consider the addition of a pre-treatment before the water gets into the water plant.
- The last week of the month, snowpack was averaging between 89%-93%. Historical trends indicate that we should be okay for the year.
- Typically, around this time, USGS has data available for river flows at Boise Creek (Near Rangely), but so far, we
 haven't seen anything. The data we get from this measuring site is crucial for us to observe our river flows and is
 what we base potential water restrictions off. If we don't see anything soon, we'll be contacting USGS to figure
 out what's going on.
- Average water output from the plant in April was 347k gallons.
- Water loss for the month of April was at 13%.
- Monthly compliance reports were sent to state with no violations being noted.
- The water treatment plant's roof membrane was partially lifted during the windstorm on 4/5. Additional damage was sustained during another windstorm a couple of days later. We are working with Hurst roofing and CIRSA to get the roof repaired.
- High zone pump station also sustained some roof damage during the storms and will need to have the roofing repaired. We're communicating with local contractors to get bids for this work.
- CDPHE sent us a letter to inform us that our Lead and Copper sampling is now to be completed once every three years instead of annual, which will save thousands of dollars in the long run.

Wastewater Plant:

- Muller is continuing work on the new headworks facility. They're currently working on getting the influent and effluent wet wells completed.
- Plumbing was completely replaced inside the existing headworks. We used plastic PEX to avoid further complications with H2S.
- State Compliance Reports were sent out with no violations.

Utility Department Activities:

- Had 32 locates, meter reads and rereads, several work orders, high/Low usage report.
- Storm sewer cleaning cannot resume until we get our rodder pump fixed, which is scheduled for later this month.
- Attended meetings with PAC and the Conservancy meeting.
- Jetted several sewer lines as part of regular maintenance
- Irrigation is now up and running. We're currently waiting on parts to arrive so we can put our second irrigation pump into use.

WHAT >>

The heARTS of LYONS Program is an outdoor collection of art all over town. It includes sculptures and wall art from Colorado artists, specifically from the Front Range area.

- New artwork is cycled every two years.
- Each artist receives a stipend from the Lyons Arts and Humanities
 Commission (LAHC) of \$750.
- Local businesses can sponsor artwork, have their name on a plaque near it, can throw a celebration or ribbon cutting upon installation, and are able to get their name out beyond just their business.

Since its introduction in 2020, it has received 650 views!

HOW >>

The goal of the program and Main Street's involvement is to ensure that Lyons' public art ventures are playing a role in economic vitality and tourism. New art installations are often a collaboration between the Town, LAHC, Main Street Board, and the Historic Preservation Committee.

- Grants, sponsorships, and municipal government are potential funding sources.
- Lyons creates digital tours (both of the artwork and local history) via
 Clio and promotes them through their website and social media, on physical flyers, with QR codes in local businesses, and at the museum.
- Lyons sends out a call to artists when it is time for fresh pieces.

Rangely's new pocket part is located on Main Street between Town Hall and the Rangely Regional Library. Previously, the area had cracked old cement, no amenities, and some informational signage.

HOW >>

During the pandemic, with a huge push for outdoor dining, Rangely realized that there was not a great area on Main Street for residents to enjoy. From there, the idea for the pocket park was born. The Town's horticulturist (who does landscape design) and engineer, who serve on the Main Street Committee, worked with other committee members and the Public Works Department to design an area that would be beautiful and functional for residents.

While the park was funded by a CDOT Revitalizing Main Street grant, I feel that [Main Street] answered and assisted with the entire project, even down to deciding to install a bike repair station. If you have questions, they are always there to assist.

The Town of Granby is currently refreshing their design guidelines and developing its comprehensive plan. "We are excited," Lauren Huber, Executive Director of Destination Granby and the Main Street manager, says. "There's a lot of development coming into Granby, and we want to plan and not let the town lose its character." Creating these design guidelines, as well as doing some façade improvements with funds from the Main Street Open for Business (MSOB) grant, will help Granby by:

- Increase connectivity between destination areas and downtown
- Calm traffic through downtown, which sits along Highway 40
- Make the downtown area safer and more pedestrian friendly
- Ensure a cohesive design that maintains the aesthetic of the town
- Bring in visitors and residents alike with a warm and welcoming atmosphere

Colorado Main Street provided technical assistance as Granby developed a request for proposals to find a design consultant. Currently, the Town is in the discovery phase and public engagement process to learn more about what the community wants and how that can practically be achieved. But even while the new guidelines are still being developed, improvements are happening! Granby has 11 businesses benefitting from the MSOB grant, including Bowerbird's Den, Simple Coffee, and Drive by Pie (pictured). Façade improvements to existing businesses will ensure that they blend well with new developments to come.

"The local community are the ones living there, so ask them what is missing and what they'd like to see brought in." Lauren says.

- Host group walks with the community and look at a place that could be the home to something new. Ask people what they would like to see there.

- Host a meeting with different groups in the town and show them visuals of areas to improve and have a brainstorming session.

ABOUT Club 20

Club 20 is an organization of counties, communities, tribes, businesses, individuals and associations in Western Colorado. The group is organized for the purpose of speaking with a single unified voice on issues of mutual concern. Its activities include marketing and advertising, public education, promotion, meetings and events, and political action. Club 20 is the "Voice of the Western Slope".


Founded in 1953 by Western Slope business leaders, Club 20 was originally organized for the purpose of getting rural roads paved. At the time, the State of Colorado had been spending only 10 percent of its highway funds west of the Continental Divide, even though more than half the roads were there. With each community lobbying for its own roads, small towns were simply drowning each other out. It finally became clear that only by agreeing on a single priority list could all the counties be heard. And the process worked. Within a few years, the State was spending 37 percent of its highway funds west of the divide, and by the end of the 1950s finally had paved most of the major highways on the West Slope.

The organization continued to grow, incorporating in 1955, and began working on other issues of mutual concern to all the Western Slope communities. Its activities included water, agriculture and natural resources, energy issues - uranium in the '50s, oil shale in the '70s - and more recently economic development, public lands, air service, tourism, energy, trails, recreation and telecommunications.

A Board of Directors makes Club 20 policy, which includes voting membership for each of the 22 counties and Ute Indian tribes in western Colorado. Each has an equal voice, their delegations elected by the members in each county or Tribe. Management decisions are made by the Executive Committee, which is composed of the elected officers of the Board of Directors.

The engines that drive Club 20 are the standing committees. Most Western Slope policy on key issues originates within one of the several committees, each with broad geographic representation. These committees include Agriculture, Business Affairs, Energy, Health Care, Education, Natural Resources, Public Lands, Telecommunications, Tourism, Transportation and Water. Membership on these committees is open to all Club 20 members, and the groups recommend policy to the full Board of Directors. A vote of the full Board is required for Club 20 to take a position on any issue.

For more than five decades, this organization of all the communities of western Colorado has been providing a forum for the discussion of complex and controversial issues, and representing the interests of the western Slope at all levels of government. The group's membership is broader and more diverse than at any time in history, and still growing each year. The Club 20 leadership is convinced that, by working together to achieve a stronger voice, the Western Slope can help shape the destiny of Colorado and the West, and continue to serve as the "Voice of the Western Slope".

Committee Structure

Club 20 has ten standing committees: Agriculture, Business Affairs, Education & Workforce Development, Energy, Health Care, Public Lands & Natural Resources, Telecommunications, Tourism, Transportation and Water.

Any Club 20 member can participate in one or more committees. The committees meet twice a year before the spring and fall membership meetings. Participation includes being able to propose and vote on proposed policy resolutions. Any resolution approved at the committee level will be recommended to and reviewed by the Board of Directors at either the spring meeting in April or the fall meeting in September before becoming Club 20 policy.

Committees may meet more than twice per year, at the discretion of the Committee Chairman or the Chairman of the Board. Interim committees, subcommittees and task forces also are convened at the Committee or Board Chairmen's discretion when an issue merits further discussion. If the interim committee, subcommittee or task force develops proposed policies, the proposals will proceed through the usual committee and Board approval processes.
