

- **10.** Committee/Board Meetings Lisa attended the County Commissioners meeting to discuss the Northwest Colorado Resiliency ready grant. The County Commissioners would like to schedule a meeting with the special districts and council, on Tuesday August 17<sup>th</sup> at 1pm.
- **11. RBC Commissioner Reports** Ty Gates reported that they had a work session with IT, Trevor Nielson, regarding the broadband expansion. Looking at the engineering throughout the county but more specifically

- the Rangely end. Trying to get funding to expand the broadband blueprint to those areas. Approved a grant for FAA for improvements on the runway repair and maintenance for the Rangely Airport. Lisa provided Cogency materials to all the Commissioners. County Fair was last week and Rangely youth did very well.
- **12. Council Reports** Don Davidson reported that he continues to speak with Doug and still looking at funding and possibly start looking at asking companies such as Chevron.

- a. Janet Miller Janet reported to the council that this is her busy time of the year. Code enforcement was busy with 24 case, with 14 of those cases being closed and in compliance in July. Already in the month of August at least 16 citations have been sent out. White River Village handicap access along White Ave have been finished. Janet Miller wanted to commend Alicia Cushman for the hard work she puts in. Janet stated that there was one Special Event Permit done.
- 14. Reports from Officers Town Manager Update Lisa shared upcoming meetings/events to the council; Moonlake BBQ, Business over Breakfast with Matt Scoggins as the speaker, White River integrated initiative meeting is August 18<sup>th</sup>. Lisa reported that the Town had there Bid opening on Monday, August 9<sup>th</sup> and only one bidder was present. Jocelyn is reviewing it. Some of the bidders stated that they were waiting for supplies to other projects. The Rangely Police Department's microwave has been installed at Town Hall and Melon Hill and Motorola will be on site to get the new consoles in on the week of August 23<sup>rd</sup>. Looking into extra funding to finish out the Radio project. Don attended a zoom meeting concerning the compact. In 2026, some of the agreements will expire and the expect it to get ugly to see who feels they should get what. Colorado is ahead of the game with asking users to measure their usage, where other states have not. The Federal Government awarded CDOT about \$12 million to help reconstruct Glenwood Canyon. Submitted the grant for the hospital. Lisa stated that Jeannie reported 7 businesses that are going to apply for the Main Street Business grants.

#### To Whom it May Concern:

The Town of Rangely, Colorado (herein the Town), is pleased to provide this letter of support for Rio Blanco Water Conservancy District's grant application for the Wolf Creek Reservoir, White River Water Storage Project. This water storage project is crucial to the Town of Rangely, which has very little water storage for drought protection.

The Rio Blanco Water Conservancy District has secured a water right approved by the state for a 66,720-acre-foot reservoir. Upon completion, the Wolf Creek Reservoir will reliably provide critical water supply to this area. This water supply is critical to the Town of Rangely for providing sustainable drinking water currently and in the future. Benefits of this off-channel dam for Rangely specifically include water storage in anticipation of drought conditions, protection of endangered species, economic diversification opportunities, and protection for existing water rights holders, and water users.

Currently the Northwest Colorado White River Basin has three water storage facilities. The existing water storage facilities do not supply enough storage to meet the current water needs during drought conditions. Lake Avery and Rio Blanco Lake are not available for water supply. Kenney Reservoir is a run-of-the river hydropower project where over 75% of total volume has been lost to siltation and the current remaining expected life span is less than 10 years from today. These pending water crisis conditions leave Rangely and the entire White River Basin vulnerable.

This project aligns with the Colorado River District's mission "to lead in the protection, conservation, use, and development of the water resources of the Colorado River basin for the welfare of the District, and to safeguard for Colorado all waters of the Colorado River to which the state is entitled." The Wolf Creek Reservoir Water Storage Project meets and exceeds the mission of the November 3, 2020 ballot question 7A: fighting to keep water on the West Slope, protect adequate water supplies for West Slope farmers and ranchers, protect sustainable drinking water supplies for West Slope communities and protect fish, wildlife and recreation by maintaining river levels and water quality. As Rangely seeks to diversify its economy, recreation

will play a bigger role looking forward. The Wolf Creek Reservoir Water Storage Project will play a critical role in supporting our community and the entire Northwest Colorado region.

The Wolf Creek Reservoir has been in development since 2013. It is a result of a cooperating agreement between the Rio Blanco Conservancy District, (herein RBWCD), the Yellow Jacket Water Conservancy District, Rio Blanco County and the Town of Rangely, Colorado. The cooperating agencies completed a feasibility studies, which identified 23 potential sites, with the Wolf Creek Reservoir site being the preferred location.

The White River, which is situated below the proposed Wolf Creek Reservoir, is home to a variety of endangered fish species. The White River is under strict management by the U.S. Fish and Wildlife (USFW) and Colorado Parks and Wildlife (CPW) in cooperation with the Upper Colorado Endangered Fish Recovery Program. The species included in the Upper Colorado Endangered Fish Recovery Program include Colorado Pikeminnow, Bonytail Chub, Humpback Chub, and Razorback Sucker. These endangered fish populations will continue to decline without active management to maintain current water levels. With predicted drought conditions over the next decade, the Wolf Creek Reservoir White River Storage Project will have the capacity to provide a critical supplemental water release, which will protect and enhance the stability of these endangered species.

For many years Rangely has been fortunate to receive abundant tax dollars from the fossil-fuel industries. The second largest economy within Rio Blanco is agricultural production. Agricultural production is deeply affected by the ebbs and flows of drought conditions. When constructed, Wolf Creek Reservoir will have the capacity to help meet the needs of the agriculture producers down-river and allow producers up-river to use more of their water rights. The Wolf Creek Reservoir, without a doubt, will provide recreational opportunities and additional economic diversification for much of the surrounding area. Initially the construction of the reservoir will provide economic stimulus for job creation and tax revenues. In the long term, the proposed reservoir will be a multiple use recreation site, including fishing and water- based tourism. The additional traffic to the area for recreation will add another layer of economic diversity for the entire region of Northwest Colorado, Eastern Utah and Southern Wyoming. As well, the reservoir could open the region to potential new businesses that are related to water activities or service based.

The Town of Rangely appreciates the efforts of RBWCD to secure a viable, sustainable water storage solution for Northwest Colorado, Northeast Utah, Southern Wyoming and all of the White

River Basin. Their proactive approach and unwillingness to ignore the current water crisis is instrumental in enhancing water storage options, preserving endangered fish populations, and providing additional economic security and diversification to our region. Rangely is committed to actively participating in this project throughout this developmental process. Without hesitation that the Town of Rangely, Colorado provides this letter of support for Rio Blanco Water Conservancy District's application for Colorado River District Community Funding Partnership.

Dear Director Meyers:

A good transportation system promotes commercial activity and strong supply chains, while also providing convenient travel for visitors enjoying destination activities. The recent mudslides, which have forced the indefinite closure of I-70 through Glenwood Canyon, directly impacts Western Slope municipalities in numerous ways. The loss of this major transportation corridor creates immediate impacts on the economies and communities of the Western Slope.

During the period of time that I-70 is closed due to the damage caused by the mudslides, traffic from the Front Range to the west is forced to find alternate routes. This causes significant delays for most sectors in the Western Slope economy given that there are only a few viable routes, and some are not necessarily able to handle heavy traffic. The Western Slope economy is reliant on the regular movement of traffic from the Front Range. The combined effect of the I-70 closures and subsequent delays impact not just our supply chain of commercial goods but is also impairing Amtrak and freight lines, healthcare access and poses potential threats to broadband access. Tourism and hospitality industries are also major sectors negatively challenged by the closures. Considering that visitor spending accounts for 30 percent of the City of Grand Junction's sales tax receipts, the impact is significant.

The damage created by the Grizzly Creek Fire combined with the heavy rainfall during the monsoon season, will continue to pose a challenge for the section of highway running through Glenwood Canyon. The potential for additional closures, due to rock fall and debris, lingers due to the fire scar and rain which continues to destabilize the slopes. This stretch of highway, prior to the most recent devastation, has already been intermittently closed numerous times this summer. The potential for future closures is a major concern for our residents and Western Slope economic generators.

We respectfully request that OEDIT invest in resources for the Western Slope to mitigate the lasting impacts of these unfortunate transportation corridor closures. Investment in the Western Slope's economy to increase our economic self-reliance would mitigate the effect of current and future I-70 closures. Further, expansion of broadband infrastructure and access would help to ensure our businesses and residents remain connected. Finally, it is critical that OEDIT invest in and support our region to offset detrimental economic disruptions.







- Coordination with the Programmatic Biological Opinion (PBO) and White River Management Plan (water right includes Mitigation for T&E species)
- Development of a <u>one record of decision</u> permitting work plan; (positive conversations with State and Federal permitting agencies)
- Preliminary Recreation Plan; (essentially complete)
- Purpose & Need refinement & strengthening (water right has been attained & developing)
- Financing Plan (short & long term);
  - Short term = NEPA \$2M/year > Planning Cost \$10M (at least 3 years)
  - Long Term = \$130M \$135M (66,720 AF)
- Final Report.

2025 - 2026 Final dam design

2026 - 2028 Construction

2028 – Let's start filling the bucket
