ORDINANCE 694

AN ORDINANCE DESIGNATING THE LAND USE (ZONING) AND AMENDING THE TOWN OF RANGELY ZONING MAP AS IT PERTAINS TO 2828 SHALE DRIVE A CHANGE OF ZONING FROM INDUSTRIOUS TO COUNTRY ZONE

WHEREAS, on February 1, 2021, Oldcastle SW Group Inc., a Colorado corporation (hereinafter “Applicant”), submitted an application for Amendment to Rezone under procedures set forth in the Rangely Municipal Code. The proposed change is to rezone 2828 Shale Drive (a lot in the Clear Ridge Subdivision Poole & Pilcher Resub, Lot 4, Block 3, in Section 4, T1N, R101 W of the 6th P.M., Town of Rangely, Rio Blanco County, CO, Assessors’s Parcel No. 139504203004) from Industrious to Country Zone; and

WHEREAS, C.R.S. 13-12-115 (2) requires the Town to zone property that is annexed to the Town within ninety (90) days after the effective date of the annexation ordinance; and

WHEREAS, at a public hearing held on March 16th, 2021, before the Planning and Zoning Commission, after review of presented evidence, testimony, exhibits, review of the Town Master Plan, comments of public officials and referred agencies, comments from the public and recommendations from Town staff, the Town Planning Commission recommended to the Rangely Board of Trustees that the application for designation of zoning and amendment of the Town zoning map be approved subject to compliance with certain conditions; and

WHEREAS, at its public hearings with the 1st Reading to be held on April 13th, 2021 and 2nd Reading to be held on May 11th, 2021, after review of presented evidence, testimony, exhibits, review of the Town Master Plan, comments of public officials and referred agencies, comments from the public and recommendations from Town staff, the Board of Trustees RESOLVES AND FINDS as follows:

1. Proper publication and public notice were provided as required by law for hearings before the Planning Commission and Board of Trustees.
2. The proposed amendment is consistent with the purposes, goals, policies and Town zoning map and master plan. The subject property is currently annexed to the Town and zoned Industrious. The proposed amendment will rezone the subject property “Country” thereby creating consistency with the existing zoning map by creating this new designation.
3. The proposed amendment is compatible with existing and proposed uses surrounding the subject land. In addressing the unique location and characteristics of the property, the amendment is the appropriate zoning district for the land considering its consistency with the purpose and standards of the proposed zone district.

4. The proposed amendment is necessary because there will be a change in condition due to the fact that the property is being rezoned from Industrious to Country for Block 3, Lot 4 in Section 4, T1N, R101 W of the 6th P.M., Town of Rangely.
5. The proposed amendment, as conditioned will not result in significantly adverse impacts on the natural environment, including but not limited to water, air noise, storm-water management, wildlife habitat vegetation and wetlands.
6. The proposed amendment does address a demonstrated community need. The rezoning for the property will provide for the orderly and planned development of the property.
7. The proposed amendment will result in a logical and orderly development pattern. The proposed amendment will not result in spot zoning.
8. The resulting development, as conditioned, can logically be provided with necessary public facilities and services.
9. The proposed amendment, as conditioned, can logically be provided with necessary public facilities and services.
10. The proposed amendment, as conditioned, is changing to such a degree that it is in the public interest to encourage a new use or density in the area.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF RANGELY, COLORADO:

Section 1. The property described in Exhibit A attached is hereby classified under the zoning designation “Country” as set forth in Title 15, Article IV, Sections 106-120 of the Rangely Municipal Code.

Section 2. The zoning map of the Town of Rangely is hereby amended to show Lot 4 Block 3, [Name of Town subdivision? Or, name of County subdivision that created Lot 4. , Town of Rangely. properly rezoned as “Country”.

Section 3. Effective Date: This ordinance shall be effective ten days after publication following final passage.

Section 4. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper for the health, safety and welfare of the Town of Rangely and the inhabitants thereof.

INTRODUCED, READ BY TITLE, APPROVED ON THE FIRST READING, AND ORDERED PUBLISHED IN FULL THIS DAY OF APRIL 13TH, 2021, BY THE TOWN COUNCIL OF THE TOWN OF RANGELY, COLORADO.

Water/Wastewater – Submitted by Donald Reed

Project status/Current Issues:

Water Treatment Plant:

General note. The Department remains in full operations but is still adhering to Covid-19 policies and procedures.

- Operations has remained at a constant for the month. Were currently operating at about 420,000 gallons per day. Flows in the White River is at 560 cubic feet per second (CFS) which is normal for the time of the year. Water quality is good. The Water Conservancy Districts new mandated operations has had very little impact on our operations at this time. We should start to see spring runoff; this is when we will see the full impact of their new operations. We completed a full series of lab test to use as a base line for comparison reasons, our treatment process and operations will have to accommodate the changes needed. The initial impact is undetermined at this time but will aid in scouring the riverbed during run off. Long term effects will be more favorable in extending the life of Kenny Reservoir and water quality may improve over time. Most of our operations has switched over to spring operations which means a more heightened sense of awareness in watching for changes in our water source.
- The department took river station down and emptied the wet well for annual inspection and cleaning out river sediment with noting there was not a lot of accumulation that built up over the past year. Installed a new Low Limit float that was damaged from aquatic life chewing on the float cords. All other operations at the River station were good and reset system back online.
- Snowpack conditions in the Yampa-White Basin is currently at 64% which is way below the median average for this time of the year. At this point the outlook for this area is not good. We are in desperate need off additional precipitation over the next month. Will keep administration up to date as we move forward.

- The Water Conservancy District held their meeting on the 26th of April for the extension of the water distribution system along County Rd 102. The response was not as good as they hoped but they had enough feedback that they will continue moving forward and possibly see if they could reduce the initial cost for potential users. Additional meetings will be scheduled.
- Worked on excavating vegetation around the north preset pond. The total organic carbon footprint was too high and contributing to exceedance of TOC removal rates required level at State for meeting compliance.
- Still waiting on response from DOLA on proposed grant for the Pipeline replace project for Le Mesa. Have proceeded with required Engineering & SUV surveys that needed to be completed in the preliminary stages to acquire grant.
- Have completed 80% of the Utilities Master Plan. Is still a work in progress.
- Working on the Operator agreement for Chevron, preliminary write up has been completed. The final review is completed and will be forwarded to the Town attorney for legal review.
- Completed a full review of State new Ground Storage Comprehensive Program for 2021. Will need to schedule working on additional ground storage tank 250,000-gallon tank at Middle Zone.
- Monthly compliance reports were sent to state with no compliance violations for this reporting period.
- Completed State Eligibility Reports for State 2022
- Jetted various problem spots in Town.
- Working on scheduling of Raw water user as soon as possible.
- Worked on Raw water system repairs and maintenance problems with users on their systems.
- Completed full review of SCADA system. Plus completed contract agreement with Timberline on working on two of our Remote Telemetry Repeaters stations to upgrade them with new units, the old systems will be kept on site to have spare parts for other repeaters until we are able to schedule other units in the following years.

Wastewater Plant:

- Started working on ground maintenance at the WWTP and its facilities.
- Head Works building project. Continued having meetings with SGM and Jocelyn and finished final Q&A sessions on various items with the New Headworks building. Issued PO on major equipment items needed due to lead times on equipment from the manufacturers. Working on other pieces of equipment that needs ordering as soon as possible due to lead times.
- Working on the UV system off and on to keep it up and running as long as possible.
- Completed state reports and sent with no violations on compliance for this month.
- Worked on cleaning up of common areas at wastewater plant and patched in potholes in all roadways at the plant.

Utility Department Activities:

- Had 62 Locates, meter reads and rereads, 5 Work orders. High/Low usage report (full) review.
- In progress the Department started a (Water Audit Project) this will be an ongoing project. This project consists of breaking down and isolating the water users for the town in hopes of identifying

potential high water loss areas by zones. This is a new approach to an old problem. State does not currently have a reporting program for water loss, but it is being recommended down the pike.

- Department still working on a facility assessment and inventory program which also be part of the Utilities Mater Plan.
- Attended meetings with PAC and Douglas Creek Advisory Board and Water Conservancy.

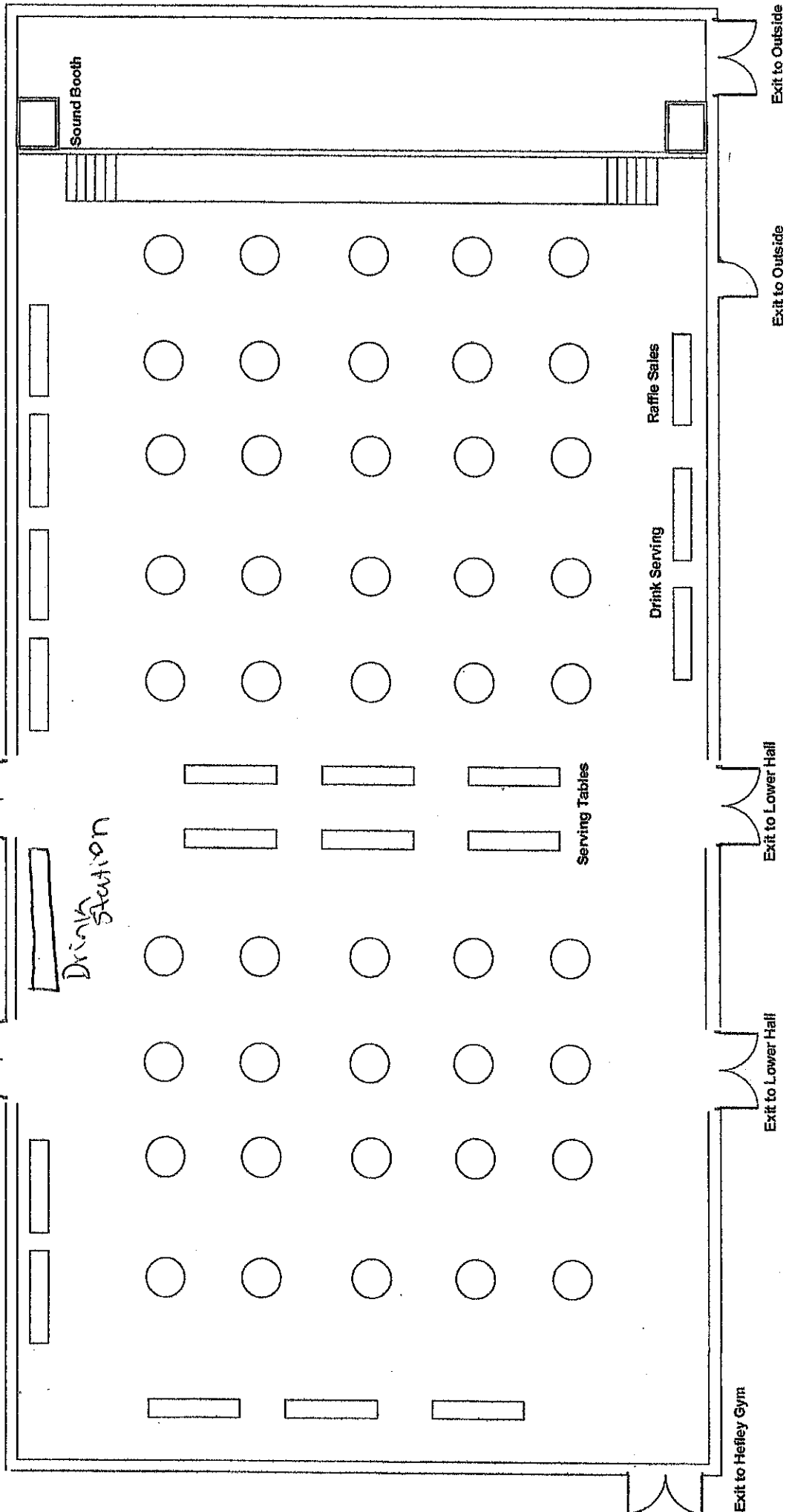

ORDINANCE 694

AN ORDINANCE DESIGNATING THE LAND USE (ZONING) AND AMENDING THE TOWN OF RANGELY ZONING MAP AS IT PERTAINS TO 2828 SHALE DRIVE A CHANGE OF ZONING FROM INDUSTRIOUS TO COUNTRY ZONE

WHEREAS, on February 1, 2021, Oldcastle SW Group Inc., a Colorado corporation (hereinafter “Applicant”), submitted an application for Amendment to Rezone under procedures set forth in the Rangely Municipal Code. The proposed change is to rezone 2828 Shale Drive (a lot in the Clear Ridge Subdivision Poole & Pilcher Resub, Lot 4, Block 3, in Section 4, T1N, R101 W of the 6th P.M., Town of Rangely, Rio Blanco County, CO, Assessors’s Parcel No. 139504203004) from Industrious to Country Zone; and

WHEREAS, C.R.S. 13-12-115 (2) requires the Town to zone property that is annexed to the Town within ninety (90) days after the effective date of the annexation ordinance; and

WHEREAS, at a public hearing held on March 16th, 2021, before the Planning and Zoning Commission, after review of presented evidence, testimony, exhibits, review of the Town Master Plan, comments of public officials and referred agencies, comments from the public and recommendations from Town staff, the Town Planning Commission recommended to the Rangely Board of Trustees that the application for designation of zoning and amendment of the Town zoning map be approved subject to compliance with certain conditions; and

WHEREAS, at its public hearings with the 1st Reading to be held on April 13th, 2021 and 2nd Reading to be held on May 11th, 2021, after review of presented evidence, testimony, exhibits, review of the Town Master Plan, comments of public officials and referred agencies, comments from the public and recommendations from Town staff, the Board of Trustees RESOLVES AND FINDS as follows:

1. Proper publication and public notice were provided as required by law for hearings before the Planning Commission and Board of Trustees.
2. The proposed amendment is consistent with the purposes, goals, policies and Town zoning map and master plan. The subject property is currently annexed to the Town and zoned Industrious. The proposed amendment will rezone the subject property “Country” thereby creating consistency with the existing zoning map by creating this new designation.
3. The proposed amendment is compatible with existing and proposed uses surrounding the subject land. In addressing the unique location and characteristics of the property, the amendment is the appropriate zoning district for the land considering its consistency with the purpose and standards of the proposed zone district.

4. The proposed amendment is necessary because there will be a change in condition due to the fact that the property is being rezoned from Industrious to Country for Block 3, Lot 4 in Section 4, T1N, R101 W of the 6th P.M., Town of Rangely.
5. The proposed amendment, as conditioned will not result in significantly adverse impacts on the natural environment, including but not limited to water, air noise, storm-water management, wildlife habitat vegetation and wetlands.
6. The proposed amendment does address a demonstrated community need. The rezoning for the property will provide for the orderly and planned development of the property.

Section 3. Effective Date: This ordinance shall be effective ten days after publication following final passage.

Section 4. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper for the health, safety and welfare of the Town of Rangely and the inhabitants thereof.

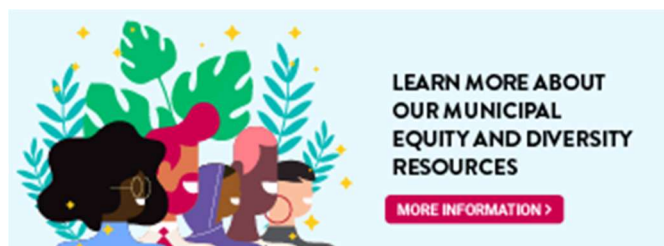

**RE: Involvement of Western Slope Local Governments in the Proposition 114
Gray Wolf Reintroduction Planning Process**

Dear Chair McDaniel:

As the Parks and Wildlife Commission (“Commission”) continues its work to implement the reintroduction of gray wolves to Colorado as required under Proposition 114, I wish to express my strong belief that greater public input—specifically from impacted Western Slope counties and regions—be included in the planning process.

As you know, Proposition 114 requires the Commission to begin reintroduction of the gray wolf by December 31, 2023. Colo. Rev. Stat. § 33-2-105.8(2)(d). Reintroduction is only permitted to occur on designated lands, defined as lands west of the Continental Divide and determined by the Commission to be consistent with the reintroduction plan. *Id.* at §§ (2)(d), (3)(a)(II), (5)(a). To put this in context, we are confronting the implementation of a statewide ballot measure that targets major impacts to a minority of Colorado counties in select regions of the State—notwithstanding that the same regions’ voters disapproved of this action at the ballot box. This uncomfortable situation calls for the greatest sensitivity to those Western Slope communities.

To ensure appropriate sensitivity, public input—particularly, public input from the region most impacted by Proposition 114—must be core to the reintroduction planning process. In approving Proposition 114, the voters expressed a clear desire that the public be included in the Commission’s planning process. *Id.* at § (2)(c). But not only does the language of Proposition 114 require the public’s involvement, but also requires the consideration of “scientific, economic, and social considerations” specific to reintroduction. *Id.* at § (2)(b). Those most knowledgeable on how reintroducing gray wolves will impact the scientific, economic, and social landscape in Western Slope counties are Western Slope local officials. These persons offer specialized input that represents Western Colorado citizens, lands, and interests. Such expertise cannot be obtained through any other stakeholder or interest group.

I understand that last month the Commission accepted applications for persons to participate on the Stakeholder Advisory Group for the planning process, and that this group


will consist of 12 to 16 members. Given the composition, it is likely that a mere one or two seats, at most, will be held by Western Slope local government representatives.¹ I am gravely concerned that this limited involvement is inadequate given not only the incredible diversity of Western Slope regions, ecosystems, and communities, but, in particular, the outsized impact Proposition 114 will have on Western Slope lands and residents.

To be successful, the planning process needs diverse and robust input from the communities directly affected by the reintroduction plan. It is of the utmost importance that Western Slope communities have a seat at the table. This will not only benefit those communities that are so directly impacted by the work of the Commission—but their voices will be of tremendous value to the Commission’s planning process. Western Colorado counties have tremendously diverse habitats, communities, economies, populations, and physical landscapes. And the local elected officials who represent those counties hold deep expertise in land use planning, community needs, economic priorities, and topographical and environmental considerations. Such expertise is of significant benefit to the reintroduction planning process.

I strongly urge the Commission to include a greater role for these voices in the reintroduction planning effort. We owe it to both the Western Slope—and the entire State—to not limit their participation to informal stakeholder discussions or through public comment sessions. We need their full involvement, opinions, and expertise at the table. To that end, the Commission would be well served to use its authority under § 33-1-105(1)(e), C.R.S. to enter into a cooperative agreement for the development of wildlife programs, using this authority to establish a Local Government Advisory Group specifically for local elected officials to participate in the process. This approach would provide a venue for input that is more comprehensive, reflecting *all* Western Colorado regions. The reintroduction plan, impacted communities, and the entire State are far better with this level of engagement to ensure a successful implementation of Proposition 114.

Time will demonstrate whether this experiment proves to be a success for Colorado. But for this experiment to have greatest chance of success, we must build the proper foundation and planning structure. That means that the gray wolf reintroduction process must consider implications of that action on local communities—and allow those communities a meaningful seat at the table where decisions are made.

This letter serves as a commitment of support by the Associated Governments of Northwest Colorado (AGNC) for the Unmanned Aircraft Systems (UAS) research project being conducted by the State of Colorado higher education institutions, Colorado Northwestern Community College (CNCC), and Metropolitan State University of Denver (MSU Denver). Having reviewed the scope and activities of the National Science Foundation (NSF) Advanced Technology in Education (ATE) grant, this research project is found to merit both engagement and participation in the project activities scheduled.

Research regarding the needs of commercial and governmental entities for use of UAS technologies will be conducted through surveys. The project is focused specifically on needs of those entities in Western Colorado. This research and grant funding will be instrumental in assisting with the retention, expansion, and creation of UAS companies/entities which may result in business growth in this market as well as job creation. CNCC and MSU will need this information to develop education programs supporting the UAS industry.

The NSF ATE grant funds the project activities aimed at assessing the education and training demands of CO Western Slope commercial organizations and governmental agencies having existing or planned UAS operations. Principal Investigators for MSU Denver, Drs. Jeffrey Forrest and TJ De Cino, will be contacting key commercial and governmental individuals for participation in survey and/or focus group activities. The projected results of the project activities should directly inform both higher educational institutions in developing custom UAS educational programs, as well as provide commercial organization and governmental agencies fundamental input and advisory opportunities in the knowledge, skills, and experience needed in training and educating their potential and future UAS operators.

AGNC strongly recommends AGNC members support and participate in the proposed project activities of the CNCC – MSU Denver grant and invest the time and effort to participate in the survey in a timely manner when it is received.

In this week's edition

- CML testified in support of **HB21-1117**, CML-initiated legislation that allows local governments to promote affordable housing in new developments. The bill passed the Senate today.
- CML testified in opposition to **SB21-197**, Changes to Workers' Compensation Doctor's Choice. The bill was amended but the amendments have not addressed CML's concerns. The bill passed the Senate Business, Labor, and Technology Committee on a party-line vote.
- CML lobbied in support of **HB21-1051**, Public Information Applicant for Public Employment. That bill passed Senate third reading with a vote of 28-7, and will make its way to the governors desk for signature.
- CML testified in support of **SB21-240**, Watershed Restoration Grant Program Stimulus. That bill passed with a vote of 3-1.
- CML lobbied in support of **HB21-1071**, Ranked Choice Voting In Nonpartisan Elections. That bill passed the House third reading with a vote of 40-23.
- CML lobbied in support of **SB21-166**, Colorado Fire Commission Recommendations. That bill passed 3rd reading in the Senate with a vote of 34-0.
- CML monitored **HB21-1168** as it went through second and third reading in the House to ensure that a CML-initiated strike below amendment stayed in the bill.
- CML collaborated with the Executive Branch on an amendment to **HB21-1027** that allows local governments to regulate communal dining areas. This amendment was successfully added to the bill.
- Cañon City Mayor Ashley Smith and Pueblo City Council President and CML Board member Larry Atencio testified in support of **HB21-1269** on Thursday, April 29. The bill passed out of the House Energy and Environment Committee on a party line vote.
- **HB21-1162** will be considered by House Appropriations on Tuesday, May 4, and then it will head to the House floor for debate. **Call your state representative and let them know you want to see local control over plastic products.**
- CML will testify in support of **HB21-1289** before the Transportation and Local Government Committee on Tuesday, May 4.

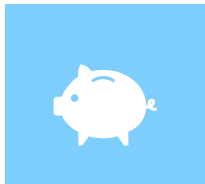

Now these lights, LED spotlights and washes that change to any color and produce almost no heat, are ready for the concerts, livestreams and other events of the 2021 season.

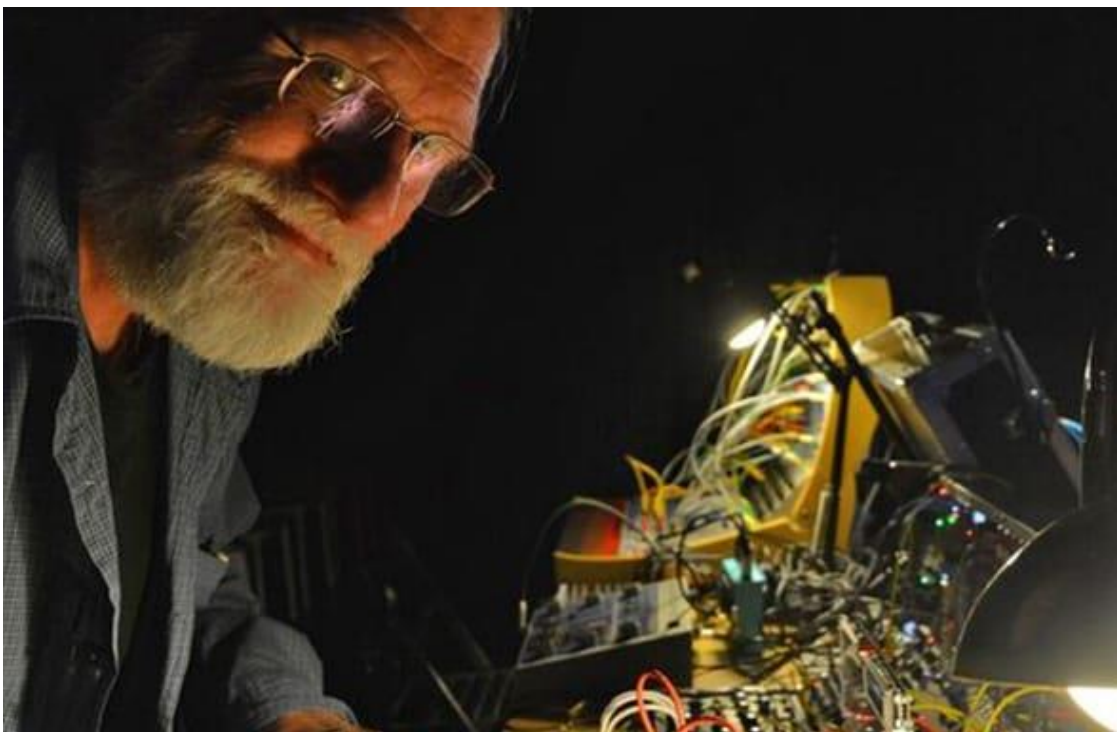


Coming this Summer 2021 Solstice Festival

*Boosters are NOT REQUIRED to be given at exactly 28 days. Boosters may be given after 28 days, but not before. You may choose to get your booster on following weeks at other community clinic offerings.

COVID-19 Testing Information

Please be advised that testing for COVID-19 is recommended for all symptomatic individuals (please see CDC website for list of symptoms), and all individuals who are exposed to a known case. If you have no symptoms, but have been exposed, it is advised to test 5-7 days after your last known exposure, or as soon as possible after you begin to develop symptoms. 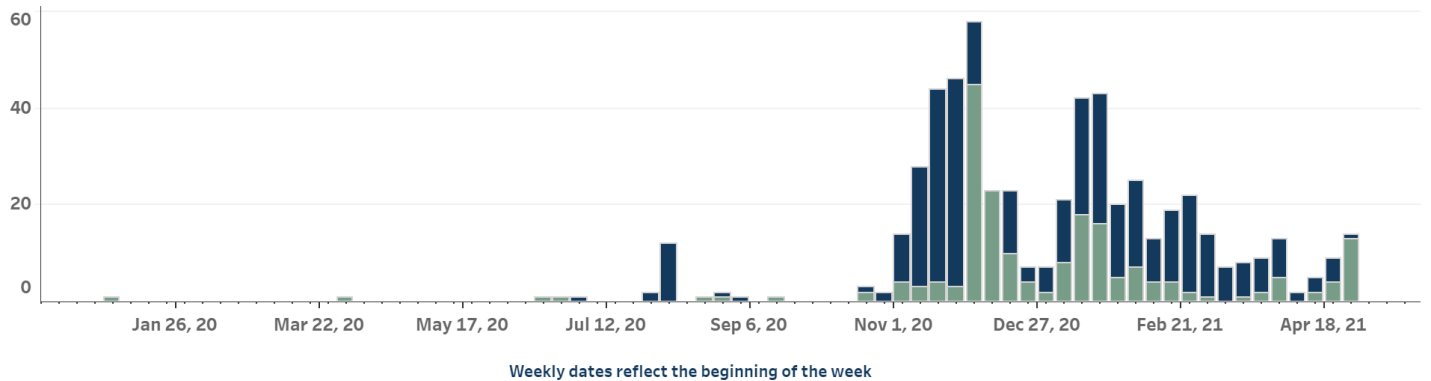

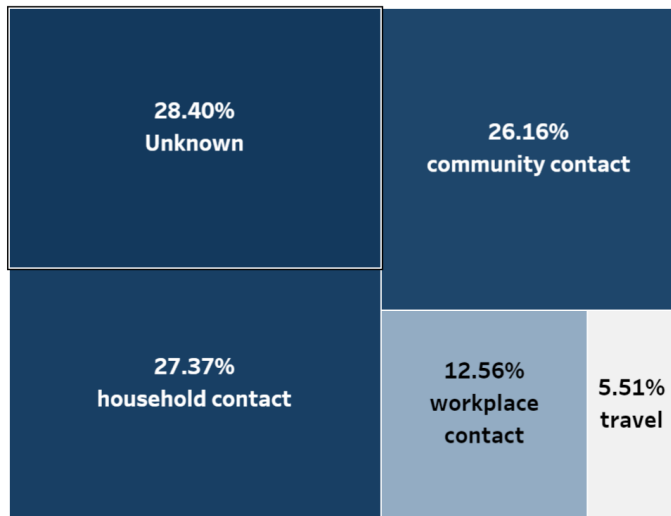

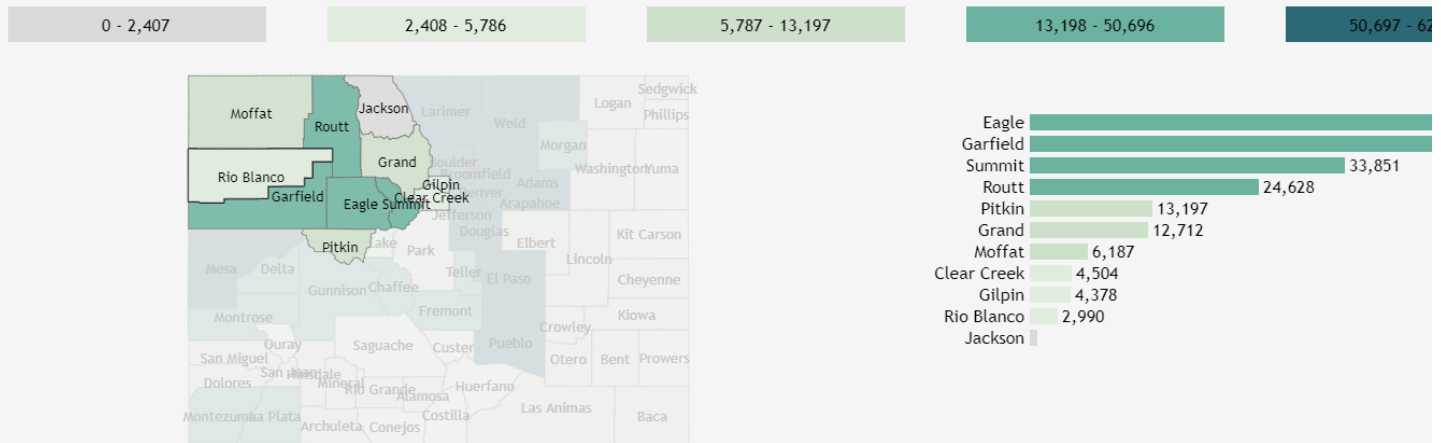

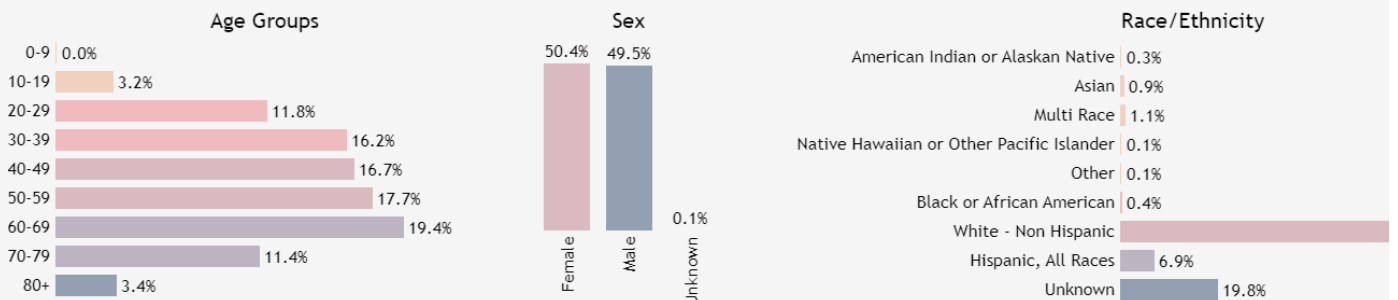

10-Year Water Quality Roadmap

Overview

Excess nutrients can degrade the quality of our drinking water, impair recreational boating and fishing experiences, and harm fish and aquatic species. Colorado has been directed by the EPA and the commission to adopt nutrient criteria to protect our streams and lakes. In October 2017, we established a water quality roadmap that outlines our strategy for developing nutrient criteria and other water quality priorities over 10 years from 2017 to 2027.

Focus areas

Criteria Development:

The Water Quality Control Commission plans to adopt water quality criteria for nutrients (nitrogen, phosphorus, and chlorophyll *a*), cadmium, temperature, arsenic, ammonia, and selenium during rulemaking hearings through 2027

Evidence Development:

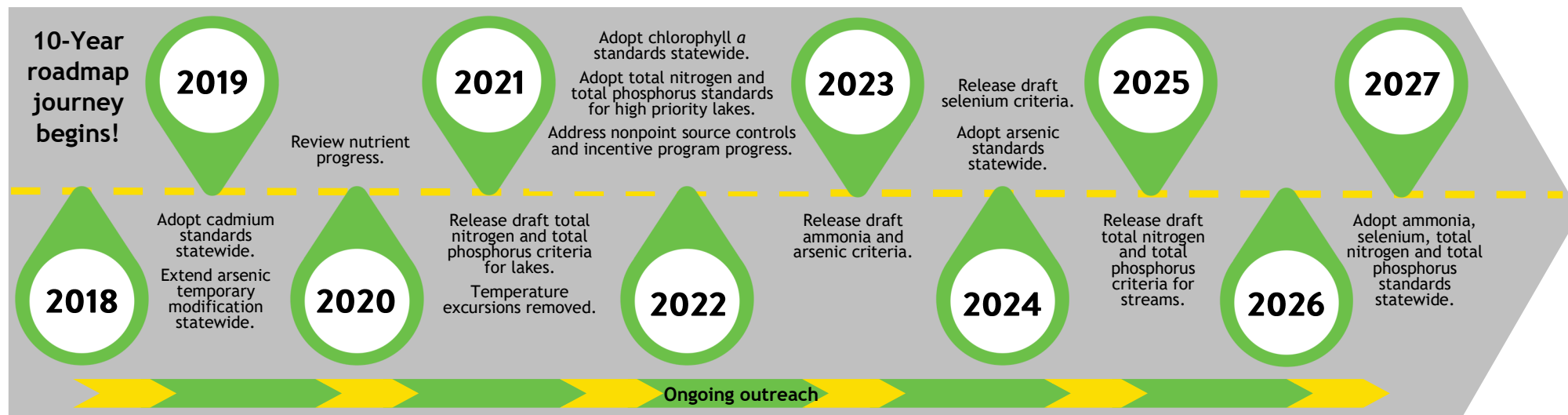
The Water Quality Control Division and stakeholders will undertake technical work and develop scientific evidence needed to support adoption of water quality criteria by the commission.

Criteria Implementation:

The water quality criteria adopted by the commission are implemented as water quality standards in the river basins statewide (Regulations 32-38). The standards are translated into permits that allow the discharge of acceptable levels of pollutants. Sometimes permit limits result in water treatment being needed to address permit requirements. Nonpoint sources, like agricultural runoff, can also release nutrients, so we will consider how to decrease nutrients in waterways from nonpoint sources as well.

Outreach:

There are several ways stakeholders can participate in shaping the efforts that will happen over 10 years from 2017 to 2027.





10-Year Water Quality Roadmap

Overview

Rulemaking hearings

2019: Regulations 31-38

- Cadmium standards adopted statewide.

2021: Regulations 31-38

- Delete temperature excursions.

2022: Regulations 31-38 & 85

- Chlorophyll *a* standards adopted statewide.
- Total nitrogen and total phosphorus standards adopted for lakes above dischargers, lakes with swim beaches, and lakes that are classified as direct use water supply.
- Address nonpoint source controls for nutrients.

2024: Regulations 31-38

- Arsenic standards adopted statewide.

2027: Regulations 31-38

- Ammonia and selenium standards adopted statewide.
- Total nitrogen and total phosphorus standards adopted for remaining waters statewide.

Criteria Development

The commission adopts water quality criteria during rulemaking hearings. Over 10 years from 2017 to 2027, the commission plans to adopt these criteria into multiple regulations at the same time. Statewide criteria are adopted in Regulation 31 and implemented into river basins in Regulations 32 to 38.

Evidence Development

We will work with stakeholders to evaluate federal criteria, examine appropriate data, and ultimately, draft appropriate criteria to protect Colorado's waters. We plan to release draft criteria as quickly as possible to allow the regulated community time to consider impacts of implementation on their facilities. The following are the major evidence development milestones through 2027:

- 2019 - Draft cadmium criteria.
- 2021 - Draft total nitrogen and total phosphorus criteria for lakes.
- 2023 - Draft ammonia and arsenic criteria.
- 2024 - Draft selenium criteria.
- 2025 - Draft total nitrogen and total phosphorus criteria for streams.

Criteria Implementation

Water quality treatment to address discharge permit conditions for nutrients, ammonia, temperature, arsenic, and selenium can be challenging from both a technological and financial perspective. Over 10 years, we will develop information on the technological and financial feasibility of meeting the new water quality criteria. Additionally, we plan to examine what information would be required to modify the statewide standards on a site-specific basis.

Work Group Efforts and Outreach

We are committed to an extensive stakeholder process throughout the 10-year water quality roadmap.

- Technical advisory committees will target members representing the EPA, Colorado Parks and Wildlife, non-profit organizations, academia, and industry while ensuring that all regions of the state are included.
- Annual updates on roadmap progress will be given to the commission and Colorado's Water Quality Forum.
