 - a. *Community Garden Meeting March 11th*- The Day of caring will be helping the Community Gardens clean up and get everything ready.
 - b. *Public Constitutional Town Meeting March 11th* -
 - c. *Planning & Zoning Meeting March 16th* – Met to discuss change in zoning from industrial to commercial. There will have to be an Ordinance change. They also voted on new officers. Mark Patterson-President; Ryan Huitt-VP; Terry Drake and Brent Shroyer both indicated they will stay on one more year.
 - d. *AGNC Board Meeting March 17th* – The big discussion at AGNC was 30x30.30% of land will be preserved and not managed. The County will be opposing.
10. **Rio Blanco County Commissioners Reports** – Ty Gates reported to the council that they have a letter of support to CPW for land exchange. Ty also indicated that they are searching for a new county attorney. The county is also working on broadband upgrades.

12. Supervisor Reports – See Attached

- a. *Don Reed* – The current operation have been good. The department is working on some spring projects, raw water system, and flushing program. Don also discussed the proposed Drought and Emergency Response Plan and use the plan as a guideline if actions are needed. The department is looking into alternate sources to store water to aid restrictive usage. Don informed the council that they have completed and submitted the application for the La Mesa waterline project. Don was requested to attend a meeting at the RBC Water Conservancy board to discuss the proposed water line project down river and recap on the status of the Wolf Creek Project. RBC Water Conservancy district would like the Town to be more vocal about the Town's needs and support of the new reservoir. The first hurdle will be the permitting then go from there. The RBC Water Conservancy district has cleared the Division of Water court and they were awarded a decree for 66,000-acre feet of water rights. Don also stated that they have received the go ahead from CDPHE after review of the Performance Design Review, no changes were needed. Will start working on putting the bid package together. Jocelyn and Emily will be the project supervisors for the Headworks project. Looking to start building by June 1st.
- b. *Ti Hamblin* – Ti was present to inform the council about an opportunity for a new K9. Ti indicated that he no longer can devote the time to be the K9 officer with his new responsibilities and duties. A private donor said that they would be willing to donate funds for a new K9. Ti stated that he found a dog and training resources for Daniel Connor, that would cost about \$15,000. Rich Garner stated that the K9 program is great for the community. Ti also expressed his concern over Senate Bill 62, which allows those that are arrested receive a summons and be released. Right now, Ti indicated that crime is on the increase and if this bill passes, most of the crimes in Rangely would be a summons and release. Keely Ellis stated that AGNC is opposing this bill.

There are going to be Grants out there to help reinvigorate the economy and will be looking at those as well. Lisa also stated that the county has been moved to a Level Blue. CNCC is conducting their Presidential interviews. There is going to be new fees to help CDOT get roads into better condition. It will happen in the next 3-5 years. There will be a new gas tax, diesel tax, fees on deliveries, fees on electric vehicles, uber and lift and other fees. Jeannie and McKenzie were approached by the Lodging Tax board, if they had any grant request that could help us doing more advertising. Jeannie did apply to Outdoor Colorado and was accepted and the paid them directly. Moving forward with projects for the summer.

ORDINANCE 694

AN ORDINANCE DESIGNATING THE LAND USE (ZONING) AND AMENDING THE TOWN OF RANGELY ZONING MAP AS IT PERTAINS TO 2828 SHALE DRIVE A CHANGE OF ZONING FROM INDUSTRIOUS TO COUNTRY ZONE

WHEREAS, on February 1, 2021, Oldcastle SW Group Inc., a Colorado corporation (hereinafter “Applicant”), submitted an application for Amendment to Rezone under procedures set forth in the Rangely Municipal Code. The proposed change is to rezone 2828 Shale Drive (a lot in the Clear Ridge Subdivision Poole & Pilcher Resub, Lot 4, Block 3, in Section 4, T1N, R101 W of the 6th P.M., Town of Rangely, Rio Blanco County, CO, Assessors’s Parcel No. 139504203004) from Industrious to Country Zone; and

WHEREAS, C.R.S. 13-12-115 (2) requires the Town to zone property that is annexed to the Town within ninety (90) days after the effective date of the annexation ordinance; and

WHEREAS, at a public hearing held on March 16th, 2021, before the Planning and Zoning Commission, after review of presented evidence, testimony, exhibits, review of the Town Master Plan, comments of public officials and referred agencies, comments from the public and recommendations from Town staff, the Town Planning Commission recommended to the Rangely Board of Trustees that the application for designation of zoning and amendment of the Town zoning map be approved subject to compliance with certain conditions; and

WHEREAS, at its public hearings with the 1st Reading to be held on April 13th, 2021 and 2nd Reading to be held on May 11th, 2021, after review of presented evidence, testimony, exhibits, review of the Town Master Plan, comments of public officials and referred agencies, comments from the public and recommendations from Town staff, the Board of Trustees RESOLVES AND FINDS as follows:

1. Proper publication and public notice were provided as required by law for hearings before the Planning Commission and Board of Trustees.
2. The proposed amendment is consistent with the purposes, goals, policies and Town zoning map and master plan. The subject property is currently annexed to the Town and zoned Industrious. The proposed amendment will rezone the subject property “Country” thereby creating consistency with the existing zoning map by creating this new designation.
3. The proposed amendment is compatible with existing and proposed uses surrounding the subject land. In addressing the unique location and characteristics of the property, the amendment is the appropriate zoning district for the land considering its consistency with the purpose and standards of the proposed zone district.

4. The proposed amendment is necessary because there will be a change in condition due to the fact that the property is being rezoned from Industrious to Country for Block 3, Lot 4 in Section 4, T1N, R101 W of the 6th P.M., Town of Rangely.
5. The proposed amendment, as conditioned will not result in significantly adverse impacts on the natural environment, including but not limited to water, air noise, storm-water management, wildlife habitat vegetation and wetlands.
6. The proposed amendment does address a demonstrated community need. The rezoning for the property will provide for the orderly and planned development of the property.
7. The proposed amendment will result in a logical and orderly development pattern. The proposed amendment will not result in spot zoning.
8. The resulting development, as conditioned, can logically be provided with necessary public facilities and services.
9. The proposed amendment, as conditioned, can logically be provided with necessary public facilities and services.
10. The proposed amendment, as conditioned, is changing to such a degree that it is in the public interest to encourage a new use or density in the area.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF RANGELY, COLORADO:

Section 1. The property described in Exhibit A attached is hereby classified under the zoning designation “Country” as set forth in Title 15, Article IV, Sections 106-120 of the Rangely Municipal Code.

Section 2. The zoning map of the Town of Rangely is hereby amended to show Lot 4 Block 3, Cear Ridge Subdivision Poole & Pilcher Resub subdivision, Town of Rangely. properly rezoned as “Country”.

Section 3. Effective Date: This ordinance shall be effective ten days after publication following final passage.

Section 4. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper for the health, safety and welfare of the Town of Rangely and the inhabitants thereof.

INTRODUCED, READ BY TITLE, APPROVED ON THE FIRST READING, AND ORDERED PUBLISHED IN FULL THIS DAY OF APRIL 13TH, 2021, BY THE TOWN COUNCIL OF THE TOWN OF RANGELY, COLORADO.

A public hearing and 2nd reading of Ordinance 694 shall be scheduled at the regular meeting of the Town Council of the Town of Rangely, Colorado, on the 11th day of May at 7:10 p.m. in the Rangely Town Hall in the Town of Rangely, Colorado.

Water/Wastewater – Submitted by Donald Reed

Project status/Current Issues:

Water Treatment Plant:

General note. The Department remains in full operations but is still adhering to Covid-19 policies and procedures.

- Operations has remained at a constant for the month. Were currently operating at about 300,000 gallons per day. Flows in the White River is at 380 cubic feet per second (CFS) which is high for the time of the year. Water quality is good. The Water Conservancy District has implemented new mandated operations for Kenny Reservoir which has had very little impact on our operations at this time. Our main concern is once spring runoff commences that is when we will see the full impact of their new operations. We anticipate run off will start around the end April. We completed a full series of lab test to use as a base line for comparison reasons They will be drawing off more through the bottom gate valves than over the spillway, this will pull in more silt as septic sludge, our treatment process and operations will have to accommodate the changes needed. The department will start monitoring with additional water sampling and analysis to see what changes are needed. The initial impact is undetermined at this time but will aid in scouring the riverbed during run off. Long term effects will be more favorable in extending the life of Kenny Reservoir and water quality may improve over time.
- Snowpack conditions in the Yampa-White Basin is currently at 92% which is below the median average for this time of the year. We need some additional precipitation to increase this percentage prior to spring run off to prevent drought restricted conditions.

- The Water Conservancy District will be holding a meeting on April 26, the propose of the meeting is to see if there is enough user support to move this project forward. The project is about installing a a new water main that would be tied into the Town main distribution line west of the town on County Rd 2 for approximately 12.5 miles this would work out to be separate entity from the Town system but would be under a Consecutive Agreement if terms were worked out.
- Completed the annual maintenance equipment program of all facilities. Started gearing up for spring operations. Also had all analytical equipment calibrated and serviced as required per state.
- Installed new backwash pump motor #2 and will send off #1 for repairs as a back.
- Waiting on response from DOLA on proposed grant for the Pipeline replace project for Le Mesa.
- Have completed 80% of the Utilities Master Plan.
- Working on the Operator agreement for Chevron, preliminary write up has been completed. The final review is completed and will forwarded to the Town attorney for legal review.
- Completed a full review of State new Ground Storage Comprehensive Program for 2021.
- Working on the changes for the approved Emergency Response Plane as outlined by Town Council. Lisa will proceed forward with drafting of Town Ordinance.
- Monthly compliance reports were sent to state with no compliance violations for this reporting period.

CONSTITUTIONAL SANCTUARY RESOLUTION OF THE TOWN OF RANGELY BOARD OF TRUSEES

WHEREAS, Amendment I of The Bill of Rights states, “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances [;]” and,

WHEREAS, the Constitution of Colorado Article II, Section 3 states, “All persons have certain natural, essential and inalienable rights, among which may be reckoned the right of enjoying and defending their lives and liberties; of acquiring, possessing and protecting property; and of seeking and obtaining their safety and happiness [;]” and,

WHEREAS, the Constitution of Colorado Article II, Section 4 states, “The free exercise and enjoyment of religious profession and worship, without discrimination, shall forever hereafter be guaranteed; and no person shall be denied any civil or political right, privilege or capacity, on account of his opinions concerning religion; but the liberty of conscience hereby secured shall not be construed to dispense with oaths or affirmations, excuse acts of licentiousness or justify practices inconsistent with the good order, peace or safety of the state. No person shall be required to attend or support any ministry or place of worship, religious sect or denomination against his consent. Nor shall any preference be given by law to any religious denomination or mode of worship [;]” and,

WHEREAS, the Constitution of Colorado Article II, Section 10 states, “No law shall be passed impairing the freedom of speech; every person shall be free to speak, write or publish whatever he will on any subject, being responsible for all abuse of that liberty; and in all suits and prosecutions for libel the truth thereof may be given in evidence, and the jury, under the direction of the court, shall determine the law and the fact[;]” and,

WHEREAS, Amendment IV of The Bill of Rights states, “The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated [;]” and,

WHEREAS, Amendment VIII of The Bill of Rights states, “Excessive bail shall not be required, nor excessive fines imposed [;]”and,

WHEREAS, the Governor of Colorado, through an unlegislated executive order, has placed undue strain on local businesses, while illogically and unequally restricting some more than others; and,

WHEREAS, the said Governor, through an improper executive order, has restricted free commerce and has instituted excessive fines and/or sanctions on businesses unable or unwilling to enforce unlegislated orders upon customers; and,

WHEREAS, the said Governor has improperly restricted citizens by imposing lockdowns, curfews limits, and the peoples' rights to assemble; and,

WHEREAS, the said Governor may enact further unlegislated and improper executive orders; and,

WHEREAS, any such other orders are clearly in violation of the Constitution of Colorado and the United States Bill of Rights; and

WHEREAS, the Town of Rangely Board of Trustees does not recognize the Governor's orders, in part due to Article II, Section 1 of the Constitution of Colorado which states, "All political power is vested in and derived from the people; all government, of right, originates from the people, is founded upon their will only, and is instituted solely for the good of the whole;" and,

WHEREAS, the Town of Rangely Board of Trustees wishes to express its deep commitment to the freedoms enumerated in the Bill of Rights and Colorado's Constitution, including the rights of all citizens of the Town of Rangely to peaceably assemble and to engage in commerce for the financial support of themselves and their families; and

WHEREAS, the Town of Rangely Board of Trustees wishes to express opposition to any order or law that would unconstitutionally restrict the rights of the citizens of the Town of Rangely; and

WHEREAS, We declare that the Constitution of the United States will be recognized in perpetuity as the highest legal authority in the State of Colorado - and that this Constitutional authority will prevail over any and all other governing authority, foreign law or culture or instruction or any statute or ordinance that conflicts with the Constitution of the United States in perpetuity. Any such unlawful statute, resolution, ordinance, instruction or declaration or foreign law or culture, that conflicts with the Constitution shall be ordained by law as instantly null and void - and will not be implemented or enforced. Nor will the people be subject to any fines or punishments for not implementing or enforcing such, in perpetuity.

WHEREAS, Unconstitutional declarations have been illegally imposed on the People to effect egregious loss of their Constitutional freedoms, we declare that any State or Federal requirements being sent forth shall be scrutinized by our chosen Constitutional attorney to define, for we the people, whether any such requirement be without Conflict of our US Constitution. If such requirement is found to be unconstitutional or in conflict with our US Constitution, then such requirement will be ordained null and void - and will not be implemented or enforced nor will any fines be enacted against the people in perpetuity.

WHEREAS, the Town of Rangely Board of Trustees wishes to express its intent to stand as a Sanctuary Town for the Bill of Rights and the federal and Colorado Constitutions, and to oppose, within the limits of the Constitutions of the United States and the State of Colorado, any efforts to unconstitutionally restrict such rights, and to use such legal means at its disposal to protect the rights of the citizens of the Town of Rangely: to freely exercise their religion; to peaceably assemble; to freely engage in commerce; to the free movement of persons; and to their rights of other individual liberties recognized as belonging to the People; and

WHEREAS, the means within the power of the Town of Rangely Board of Trustees includes the power to initiate legal action, the power to petition for redress of grievances, the power to appropriate funding for the law enforcement of the Town of Rangely, and the power to direct the employees of the Town of Rangely to not enforce any unconstitutional law or order.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF RANGELY, RIO BLANCO COUNTY, COLORADO;

1. The Town of Rangely Board of Trustees (Board) hereby declares the Town of Rangely, in Rio Blanco County, Colorado, as a “Constitutional Sanctuary Town” and expresses its intent to uphold the said Constitutions and other clearly established rights of the People of the Town of Rangely.
2. The Board hereby expresses its intent that no Town of Rangely funds will be used to restrict the Constitutional rights and other clearly established rights of the people of the Town of Rangely, and that no Town funds shall be expended to aid federal or state agencies in the unlawful restriction of said rights.
3. No Town of Rangely officials, employees, agents, funds, resources, agencies, contractors, buildings, detention centers, or offices may be used for the purpose of enforcing laws that unconstitutionally infringe on the Bill of Rights, Colorado’s Constitution, or other clearly established rights of the People.
4. The Board supports local law enforcement who support the clearly established rights of the People and directs its Town Manager to direct the Town Chief of Police to carefully evaluate requests from any state law enforcement officer, state health agent or federal agent where it is clear to the Chief that doing so would infringe on the rights of the People, as expressed in the Colorado and U.S. Constitutions.
5. The Board directs that Town of Rangely employees may not assist in or promote the enforcement of any unlawful or unconstitutional orders, including any issued by the Governor through executive orders, including any that clearly violate, in the informed judgment the Town Manager, our American rights to the free exercise of religion; our rights to peaceably assembly; our rights to the free engagement in commerce; our rights to free movement of persons; and any other individual liberties recognized as belonging to the People.

Resolution 2021 –03

A RESOLUTION REASSERTING THE RIGHTS OF THE TOWN OF RANGELY AND ITS RESIDENTS AND CONDEMNING ALL UNCONSTITUTIONAL LIMITATIONS IMPOSED UPON THEIR FREEDOMS BY THE GOVERNOR OF COLORADO

WHEREAS, Many of us believe that ALL businesses, places of worship, and governmental meetings are essential to the exercise of individuals’ fundamental rights, and it is discriminatory, and sometimes irrational, for the Governor to treat some but not all establishments with preference by labeling them as “essential;” and

WHEREAS, the 14th Amendment to the United States Constitution states, “No state shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any state deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws;” and

WHEREAS, individual citizens and groups have constitutionally protected rights of free speech, free assembly, and freedom to petition for redress of their grievances. *Edwards v. South Carolina*, 372 U.S. 229, 235 (1963); and

WHEREAS, the Colorado Constitution in the Colorado Bill of Rights, Article II, Section 24, *Right to assemble and petition*, declares “The people have the right peaceably to assemble for the common good, and to apply to those invested with the powers of government for redress of grievances, by petition or remonstrance;” and

WHEREAS, the Constitution of Colorado, Article II, Section 3 states, “All persons have natural, essential and inalienable rights, among which may be reckoned the right of enjoying and defending their lives and liberties; of acquiring, possessing and protecting property; and of seeking and obtaining their safety and happiness;” and

WHEREAS, the government is only lawfully permitted to regulate the time and manner of public gatherings in the interest of public safety, peace, comfort or convenience (*Cantwell v. State of Connecticut*, 310 U.S. 296, 306 (1940)) and “peaceable assembly for lawful discussion cannot be made a crime. The holding of meetings for peaceable political action cannot be proscribed.” *De Jonge v. State of Oregon*, 299 U.S. 353, 365 (1937); and

WHEREAS, governmental restrictions on liberty “may be sustained if the State demonstrates a sufficiently important interest and employs means closely drawn to avoid unnecessary abridgment of associational freedom.” *Buckley v. Valeo*, 424 U.S. 1, 25 (1976); and

WHEREAS on January 4, 2021, the Governor altered restrictions without regard to their purpose of health and safety and for his own political interests thus demonstrating that the limitations on speech did not meet the limited requirement of protecting the health and safety of the public; and

WHEREAS, the Governor's emergency orders, as enforced by State agencies, deny the rights of people to peaceably assemble at government meetings and in private places of business to engage in constitutionally protected activities; and

WHEREAS, the citizens of Rangely are aware of their own underlying health risk factors better than the Governor and the health department; and

WHEREAS, the citizens of Rangely have a RIGHT to work and provide for their families; and

WHEREAS, a state of emergency that operates in perpetuity becomes a state of tyranny.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF RANGELY, RIO BLANCO COUNTY, STATE OF COLORADO THAT:

The town of Rangely will not abide by any executive orders unlawfully limiting attendance of and free speech at public meetings within the town.

The Rangely Town Board does not support COVID restrictions that would shut down businesses in the Town of Rangely.

The Rangely Town Board calls upon the Governor to take all necessary steps to prevent harm to local businesses and minimize the harm of unconstitutional COVID related orders by reclassifying every business as an essential business.

The Rangely Town Board understands that, notwithstanding their purported unconstitutional nature, State authorities may attempt to pressure businesses to comply and may threaten their livelihoods. The Town of Rangely does not have the ability to preclude State enforcement actions. The Board therefore calls on each business and individual to determine for themselves the level to which they determine to comply, in their best interests, with the Governor's orders.

The Rangely Town Board calls upon each business to be responsible in evaluating their own establishment and their capacity to safely accept patrons.

The Rangely Town Board calls upon each business and patron to respect the determination of others as they determine the levels of protection instituted on their property.

The Rangely Town Board calls upon patrons to use their best judgment when entering any store or business and to feel free to walk away if they do not feel safe based on their underlying health conditions.

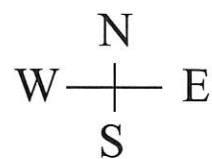

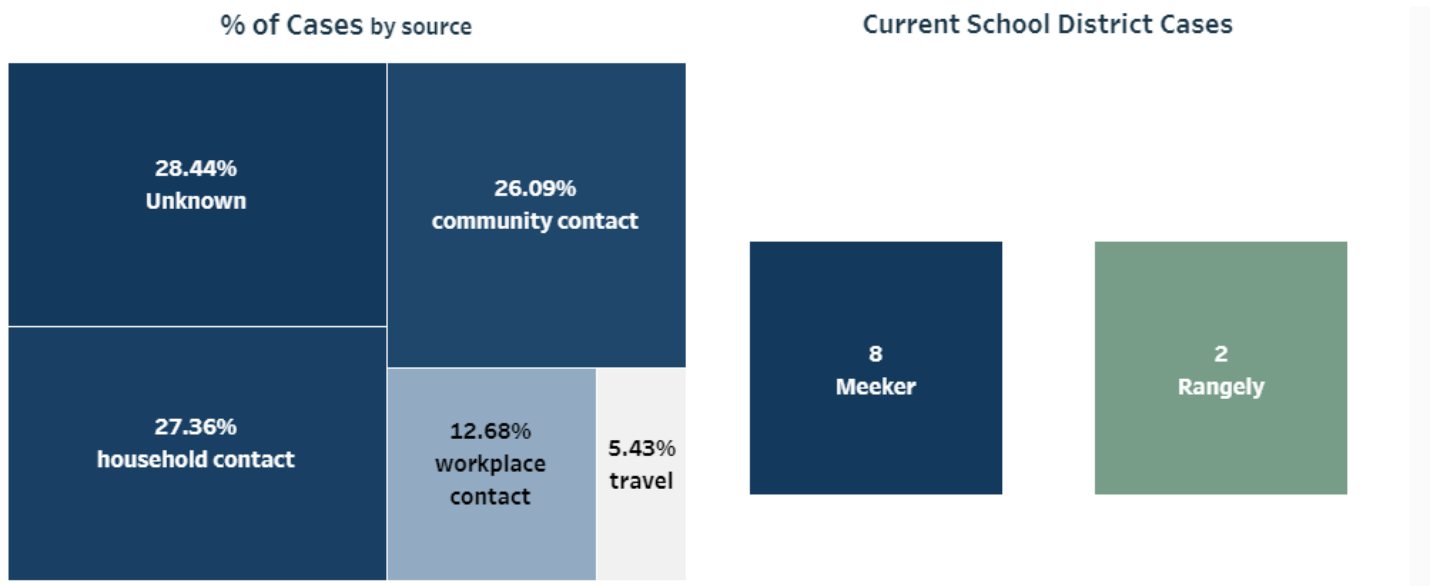
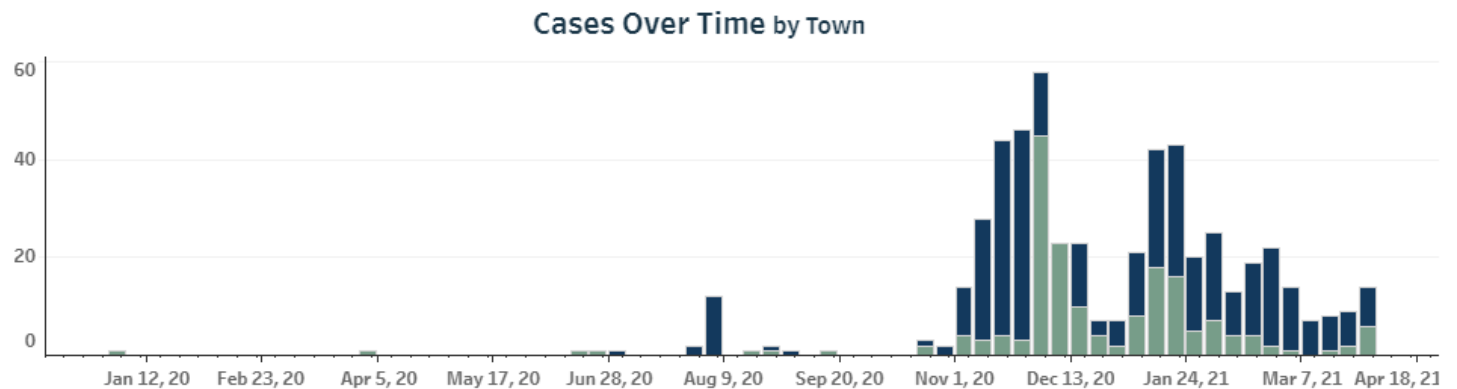

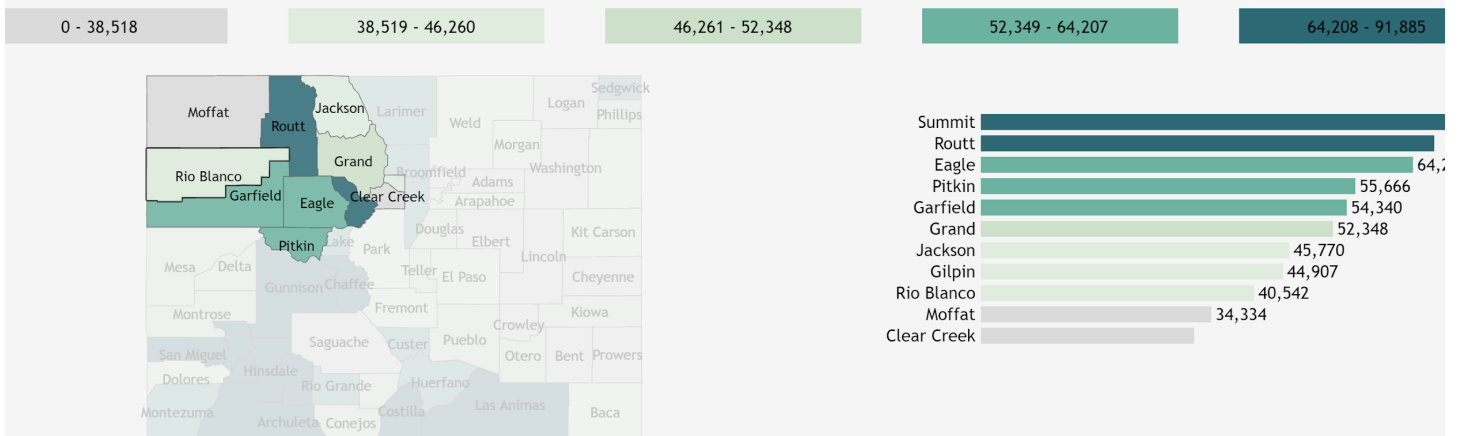

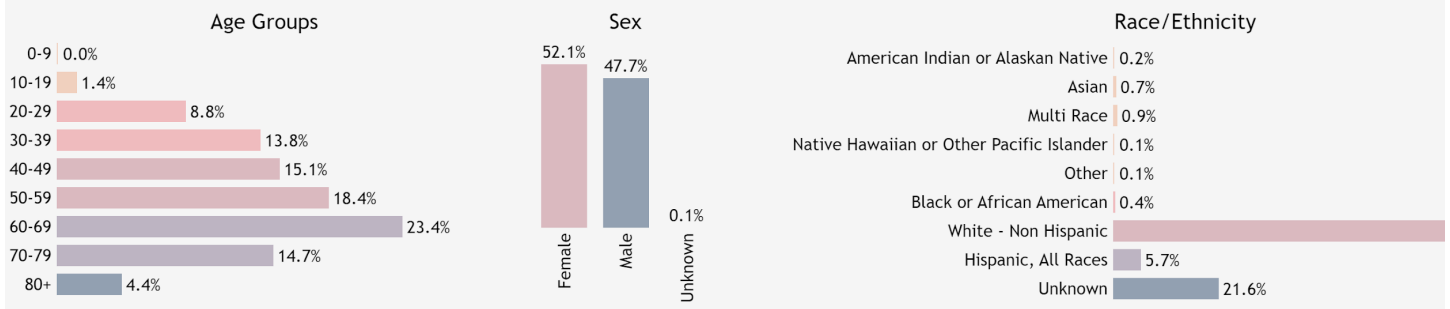

Colorado governor extends mask order, modifies it for level green counties

State order to last another 30 days; grocery stores, many other businesses not under requirement in green



Colorado Gov. Jared Polis in July 2020 announcing the statewide order requiring those over age 10 to wear masks indoors. An interpreter for the hearing impaired appears at upper right.

Setting up potential disputes for rural businesses, Gov. Jared Polis extended the statewide mask order but modified its requirements for counties in level green, the least-restrictive stage on Colorado's color-coded dial of pandemic restrictions.

In July of last year, Polis [signed Colorado's first statewide mask order](#) generally requiring masks to be worn in all public indoor spaces. The governor has extended the order every 30 days since then, according to a state fact sheet.

Effective April 3, the order's requirements changed for counties in level green, which includes many of Colorado's rural areas. As of April 2, Gilpin was the only Denver-area county operating in green.

The state's [color-coded COVID-19 dial](#) is the set of restrictions counties must follow based on the local spread of the virus. The system affects capacity at restaurants, other businesses, indoor and outdoor events, and other settings. Colorado [originally implemented the dial on Sept. 15](#).

Among the dial's six levels, green is the least restrictive. Purple, the most restrictive level, is a stay-at-home order.

Now, in counties in blue, yellow, orange, red and purple, masks must be worn in public indoor settings where 10 or more unvaccinated individuals or "individuals of unknown vaccination status" are present, the fact sheet on the modified order says.

Effectively, the section about unvaccinated Coloradans doesn't change much for most businesses.

“Businesses or facilities should err on the side of assuming that people entering their indoor site are unvaccinated. With 1 in 6 Coloradans fully vaccinated, most indoor public settings like grocery stores, retail stores and gyms will need to require mask-wearing,” the fact sheet says.

The larger change in the updated mask order is that the list of settings where masks are required in level green now only includes:

- Schools, including preschool through grade 12. That includes extracurricular activities.
- Child care centers and indoor children's camps.
- Public-facing state government facilities.
- Health care settings, including hospitals, ambulance service centers, urgent care centers and others.
- Personal services, such as hair and nail salons, esthetician services, and body art professionals.
- “Congregate care facilities,” including nursing facilities, assisted living residences, group homes and other care facilities.
- Prisons and jails.

In other words, many types of businesses — including grocery and retail stores, and others — are no longer included in the list of settings that require masks in level green. It remained to be seen how often businesses might decide to enforce their own mask requirements.

Nothing in the updated mask order prevents a county or municipality from adopting more “protective” — stricter — standards than those contained in the order, according to its text.

The order keeps exemptions that were in the prior orders, according to a news release from the governor's office.

People who are 10 years old and younger and those who cannot “medically tolerate” a face covering are exempt, according to the order's text.

The [updated mask order](#) comes on the heels of the [latest changes to Colorado's system of COVID-19 restrictions](#) — dubbed “dial 3.0” — which took effect on March 24. With the arrival of dial 3.0, counties scattered across the state moved to level green. Twenty-eight of the state's 64 counties were in that level as of March 26.

Only a few counties had qualified for level green — also known as the “protect our neighbors” stage — in the past.

As of April 2, the number of counties that are in level green was 31, representing a rough population of 238,000 Coloradans, according to the fact sheet.

State officials expect that dial 3.0 will remain in effect until mid-April, at which point the state plans to retire the dial and implement a new public health order that gives local public health agencies greater control over what restrictions to enforce.

Colorado's mask order, an executive order from the governor, is separate from the state's dial system of restrictions.

As for whether the mask order will be renewed again when it expires in May, the state's fact sheet said:

“The governor, public health experts and the governor's legal team review every executive order before expiration. We are closely monitoring disease transmission, hospitalizations and vaccination rates, and will consider these factors prior to the executive order's expiration.”

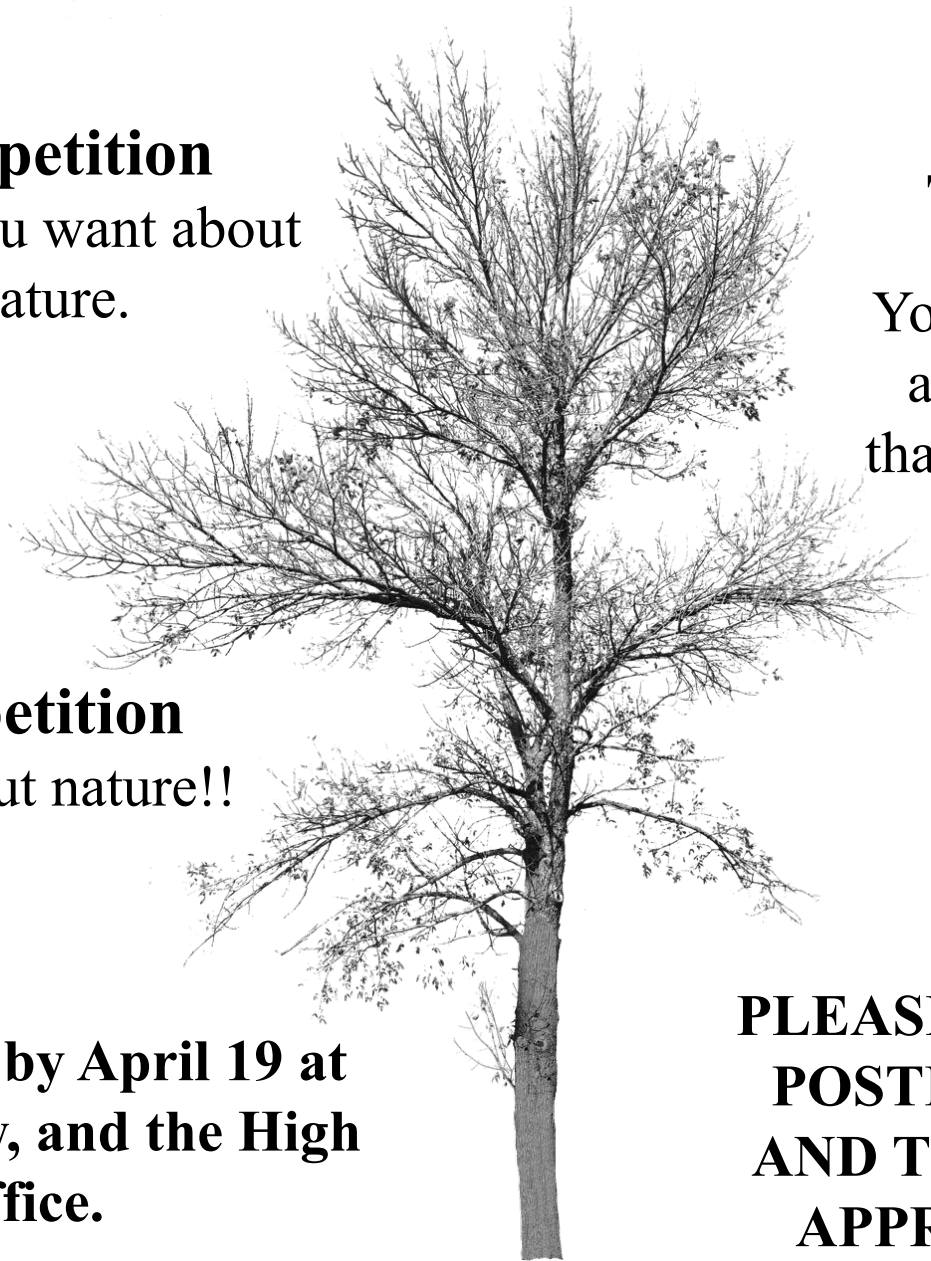

Tree Facts

What can a tree do for you? A lot. Check out all the ways—sometimes unexpected—that trees positively affect us, our communities, and our world.



Trees help clean our air.

1. Global forests removed about one-third of fossil fuel emissions annually from 1990 to 2007.
2. Trees remove pollution from the atmosphere, improving air quality and human health.
 - In Los Angeles, trees remove nearly 2,000 tons of air pollution each year.
 - In Chicago, trees remove more than 18,000 tons of air pollution each year.
 - In Greater Kansas City, trees remove 26,000 tons of air pollution each year.
3. Roadside trees reduce nearby indoor air pollution by more than 50%.



Trees contribute to our health.

4. A study of 10 cities found community forests save an average of one life each year. In New York City, trees save an average of eight lives every year.
5. Office workers with a view of trees report significantly less stress and more satisfaction.



Trees provide us with oxygen.

6. One large tree can provide a day's supply of oxygen for up to four people.
7. More than 20% of the world's oxygen is produced in the Amazon Rainforest



Trees help clean our drinking water.

8. Forested watersheds provide quality drinking water to more than 180 million Americans.
9. In 1997, New York City spent \$1.5 billion to preserve the forested watershed that supplies New York City's drinking water by purchasing thousands of upstate acres of forested watershed. A filtration plant large enough to clean New York City's water supply would have cost more than \$6 billion dollars.
 - o Today, New Yorkers enjoy some of the cleanest drinking water in the world, and New York City has won regional water taste competitions.



Trees provide much-needed cooling.

10. Trees lower surface and air temperatures by providing shade. Shaded surfaces may be 20–45°F cooler than the peak temperatures of unshaded materials.
 - o Trees cool the city by up to 10°F by shading our homes and streets and releasing water vapor into the air through their leaves.

11. Evaporation of water from trees has a cooling influence.



Trees help reduce the effects of climate change.

12. Trees absorb carbon dioxide (CO_2), removing and storing the carbon while releasing the oxygen back into the air.
- In one year, an acre of mature trees absorbs the amount of CO_2 produced by a car driven 26,000 miles.
13. During one year, a mature tree will absorb more than 48 pounds of carbon dioxide from the atmosphere and release oxygen in exchange.
- Nearly 20 pounds of carbon dioxide are produced from burning one gallon of non-ethanol gasoline.



Trees help us save energy.

14. Trees properly placed around buildings can reduce air conditioning needs by 30% and can save 20–50% in energy used for heating.
- The average Cincinnati community tree saves the average household \$56 annually in cooling costs by reducing electricity use. More than 85,000 Cincinnati community trees save residents \$4.8 million.
15. Carefully positioned trees can reduce a household's energy consumption for heating and cooling by up to 25%. Computer models devised by the U.S. Department of Energy predict that the proper placement of only three trees can save an average household between \$100 and \$250 in energy costs annually.

16. Trees provide vital wildlife habitat.

18. In Baltimore, a 10% increase in tree canopy corresponded to a 12% decrease in crime.

19. Among minor crimes, there is less graffiti, vandalism and littering in outdoor spaces with trees as a part of the natural landscape than in comparable plant-less spaces.

20. Chicago public housing residents with nearby trees and natural landscapes reported 25% fewer acts of domestic aggression and violence.



Trees are a good investment of our public dollars

21. Every dollar spent on planting and caring for a community tree yields benefits that are two to five times that investment—benefits that include cleaner air, lower energy costs, improved water quality and storm water control and increased property values.
 - In Indianapolis, each dollar invested in the city’s community trees yielded \$5.55 in benefits.
 - In New York City, it has been calculated that community trees provide \$5.60 in benefits for every dollar spent on tree planting and care.
 - In Cincinnati, the return on a \$1 investment in the city’s community trees is \$4.44.
22. The mature street trees in Beverly Hills, California, are worth \$450 million.
23. A cost-benefit analysis of the Berkeley, California, tree canopy indicated that each camphor tree had an annual net benefit to the city and its residents of nearly \$12,500, each shamel ash showed a \$9,600 annual net benefit, and each London planetree had an annual net benefit of more than \$8,700 per tree.



Trees increase our property values.

24. In Portland, Oregon, homes with street trees sold for \$7,130 more, on average, and 1.7 days more quickly.
 - Neighboring houses within 100 feet of street trees sold for \$1,688 more, on average.
 - The sale premium of having street trees was the same as adding 129 square feet of finished space.
25. In Fulton County (Atlanta), Georgia, mature trees positively influenced home sale prices. Homes sold for nearly \$105,000 more in neighborhoods with mature trees.

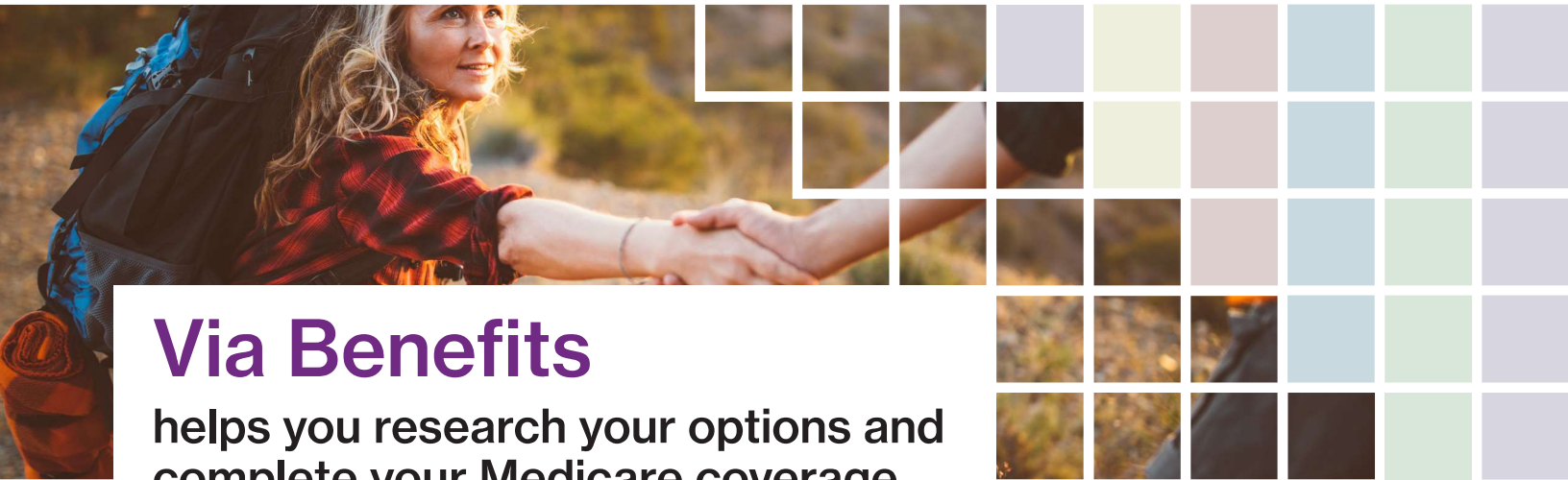

The GIS is part of the new [Sales and Use Tax System \(SUTS\)](#).

Retailers must take the following actions by July 1, 2021:

- Retailers that were sourcing all sales to their business location pursuant to section 39-26-104(3)(c), C.R.S., must begin applying the “destination sourcing” rules set forth in section 39-26-104(3)(a) and (b), C.R.S.
- Retailers that were utilizing address databases certified by the Department of Revenue pursuant to section 39-26-105.3, C.R.S., must ensure that the database provider is using the most recent information provided by SUTS in order to be held harmless under the terms of section 39-26-105.2(3), C.R.S.

Beginning July 1, 2021, all retailers will be required to apply the destination sourcing rules. The Department does not have the authority to grant exceptions to these rules.

All retailers are encouraged to file sales tax returns for the state, state-administered local jurisdictions, and participating home-rule cities using SUTS. SUTS is a one-stop portal that will allow taxpayers to do all manner of tasks related to collecting and remitting sales and use tax in an easy, automated, and seamless fashion. The system has the following capabilities:

- Accurate address location capability
- A uniform remittance form
- A single point of remittance
- A taxability and exemption matrix
- The ability to calculate tax rates on items with differing tax rates in the same jurisdiction
- A record of the history of any changes
